The submitting firm will be required to comply with all applicable laws, regulations, rules and ordinances of local, state and federal authorities having jurisdiction, including, but not limited to: all provisions of the Federal Government Equal Employment Opportunity clauses issued by the Secretary of Labor on May 21, 1968 and published in the Federal Register (41 CFR Part 60-1, 33 F.2 7804); all provisions of the Public Entity Crimes (Fla. Stat. §287.133, et seq, as amended) and the provisions in Fla. Stat. §287.134, et seq, as amended, regarding discrimination.

## **SECTION 1 – DEFINITIONS**

**ADDENDA** - Written and graphic documents issued prior to the receipt of bids to modify or interpret the bid documents.

**AGREEMENT** - The written instrument which is evidence of the agreement between City and Contractor covering the work.

**BID or PROPOSAL** - The offer or bid of a bidder or proposer submitted on the prescribed form setting forth the prices for the work to be performed.

**BID BOND** - A bond or other form of security offered by a bidder to the City soliciting the bid which guarantees that the bidder, if awarded the bid, will enter into a contract within a specified period of time and will furnish any required payment and performance bonds. If the bidder or proposer refuses to honor its bid, the bidder or proposer and bond surety or guarantor are liable on the bond for any additional costs the City incurs in hiring others to fulfill the contract, not to exceed the amount of the bid bond. A cashier's check or irrevocable line of credit on an acceptable bank, issued in the name of the City and in the required amount of the bid bond, may be substituted for a bid bond.

**BID DOCUMENTS** - The bid requirements, the Official Bid Form, instructions to bidders, the standard terms and conditions, plans and specifications, and the proposed contract documents. Include the "Public Notice of Request for bids," "General Information and Instructions for Bidders," "Standard Terms and Conditions," "Drug Free Workplace," "Agreement," "Specifications," and any Acknowledgement of Addenda issued prior to receipt of bids.

**BIDDER, PROPOSER, OR OFFEROR** – Bidder, proposer, or offer or shall have the same meaning; the individual or entity who submits a bid in response to an Invitation to Bid or Request for Proposal by the City.

**BIDDING REQUIREMENTS** - The Advertisement or Invitation to Bid or Request for Bids, Instructions to Bidders, bid security of acceptable form, if any, and the Bid Form with any supplements.

**CHANGE ORDER** - The signed contract serves to define the terms and conditions for the services, work, or project as described in the bid and contract documents. A Change Order shall be considered a written order to the Contractor signed by the City, after execution of the contract, authorizing a change in the work or an adjustment in the contract price or the contract time.

**CONTRACT** - The entire and integrated agreement between the Contractor and the City, defining its terms and conditions, which supersedes all prior negotiations, representations or agreements, either written or oral.

**CONTRACTOR** - Any person having a contract, agreement or purchase order with the City.

**CONTRACT DOCUMENTS** - Those items so designated in the agreement. Only printed or hard copies of the items listed in the agreement are contract documents.

**CITY OR OWNER** - The City of Sebring, a Florida municipal corporation - The entity for whom the work is to be performed. City Hall, 368 South Commerce Avenue, Sebring, Florida 33870, phone 863-471-5100.

**LOCAL BUSINESS** - Having a fixed office or distribution point located in and having a street address within the City of Sebring first, then Highlands County, Florida second, for a least six (6) months immediately prior to the issuance of the competitive bid, request for quotation, or invitation for bid by the City of Sebring; and holds a business license required by the City of Sebring.

**LUMP SUM BID PRICE** - The amount stated on the "Bid Form" for which the Proposer offers to provide a service as described in the bid documents.

**NOTICE OF AWARD** - The written notice by the City to the successful bidder or proposer, including instructions and conditions which are to be complied with in a designated time and stating that upon that timely compliance with all conditions listed therein, the City will execute the agreement and contract documents and provide the Contractor with a notice to proceed.

**NOTICE TO PROCEED OR PURCHASE ORDER** - A written notice given by the City stating the date on which the contract time will commence and when the Contractor shall start to perform the work under the contract documents.

**PAYMENT BOND** - A payment bond guarantees that the Contractor will pay suppliers, laborers, and subcontractors (subject to contract terms) for labor and materials. The bond shall remain in effect at least until one year after the date when final payment becomes due, except as provided otherwise by Laws or Regulations or by the contract documents.

**PERFORMANCE BOND** - A performance bond guarantees the City that the Contractor will complete the contract according to its terms including price and time. The bond shall remain in effect at least until one year after the date when final payment becomes due, except as provided otherwise by Laws or Regulations or by the contract documents.

**PROJECT** - The total construction of which the work to be performed under the contract documents may be the whole, or a part.

**SITE** - Lands or areas indicated in the contract documents as being furnished by City upon which the work or project is to be performed, including right-of-ways and easements for access thereto, and such other lands furnished by the City which are designated for the use of Contractor.

**SPECIFICATIONS** - The written requirements for materials, equipment, construction systems, standards, and workmanship for the work, and performance of related services.

**SUBCONTRACTOR** - An individual or entity having a direct contract with the Contractor or with any other Subcontractor for the performance of a part of the work at the site.

**SUBSTANTIAL COMPLETION** - The time at which the work (or a specified part thereof) has progressed to the point where the work (or a specified part thereof) is sufficiently complete, in accordance with the contract documents, so that the work (or a specified part thereof) can be utilized for the purposes for which it is intended.

**SUCCESSFUL BIDDER OR PROPOSER** - The bidder or proposer to whom the City provides written notice of award.

**UNIT PRICE BID** - The amount stated on the "Bid Forms" as a price per unit of measurement for services as described in the bid documents.

**WORK** - Construction and services required by the contract, whether completed or partially completed and includes all other labor, materials, equipment and services provided or to be provided by the Contractor to fulfill the Contractor's obligations.

## **SECTION 2 - GENERAL TERMS AND CONDITIONS (Rev 7/2019)**

All responses shall become the property of the City of Sebring. The City, at its discretion, reserves the right to waive minor informalities or irregularities in any response, to reject any and all responses, in whole or in part, with or without cause, and to accept that response, if any, which in its judgment will be in its best interest.

### **COMPLIANCE WITH APPLICABLE LAWS:**

*The submitting firm will be required to comply with all applicable laws, regulations, rules and ordinances of local, state and federal authorities having jurisdiction, including, but not limited to: all provisions of the Federal Government Equal Employment Opportunity clauses issued by the Secretary of Labor on May 21, 1968 and published in the Federal Register (41 CFR Part 60-1, 33 F.2 7804); all provisions of the Public Entity Crimes (Fla. Stat. §287.133, et. seq, as amended); shall comply with 18 U.S.C. § 874, 40 U.S.C. § 3145, and the requirements of 29 C.F.R. pt. 3 as may be applicable; shall comply with the Copeland "Anti-Kickback" Act (18 U.S.C. 874; 40 U.S.C. 3145) as supplemented in Department of Labor regulations (29 CFR Part 3); shall comply with section 6002 of the Solid Waste Disposal Act, Environmental Protection Agency (EPA) at 40 CFR part 247; and the provisions in Fla. Stat. §287.134, et seq, as amended, regarding discrimination.*

*Contractor acknowledges that City is a drug-free workplace. Contractor covenants that all employees of the Contractor working on City property shall be subject to the implementation of all possible provisions to maintain a drug-free environment and that Contractor will adhere to the provisions of Florida Statute 287.087.*

*The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive considerations for employment without regard to race, color, religion, sex, or national origin.*

*Contractor represents that it is not subject to a System for Award Management (SAM) exclusion and has not been debarred, suspended or otherwise excluded as a party declared eligible under statutory or regulatory authority to receive Federal grant funds.*

*The contractor is required to keep and maintain public records that ordinarily and necessarily would be required by the City in order to perform the service sought herein. The Contractor is required to provide the public with access to public records on the same terms and conditions that the City would provide the records and at a cost that does not exceed the cost provided in Ch. 119.07 et seq, Fla. Stat. or as otherwise provided by law. The contractor must ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law and must meet all requirements for retaining public records and transfer, at no cost, to the City all public records in possession of the contractor upon termination of the contract and destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. Successful bidder shall comply with all laws, ordinances, rules, orders, and regulations relating to the performance of the services and the protection of persons and property.

**ACCEPTANCE AND WARRANTY:** Neither the final certificate of payment nor any provision in this document, or partial or complete use of the project by the City shall constitute an acceptance of work not done in accordance with the contract document or relieve the Contractor of liability in respect to any expressed or implied warranties or responsibilities for faulty material or workmanship. Contractor shall remedy any defects and pay for any damages resulting there from which appear within a period of one year after final acceptance of the work unless otherwise stated in the specifications herein.

**ADDENDUMS:** If it becomes necessary to revise or amend any part of this document, an addendum will be issued and will be posted on [VendorRegistry.com](http://VendorRegistry.com). **It shall be the sole responsibility of the bidders to check the website to ensure that all available information has been received prior to submitting a bid.**

**ADDITIONAL WORK:** Contractor may recommend additional work needed in addition to regular maintenance. City purchasing policies will be followed for such additional work.

**ASSIGNMENT:** Awarded Contractor shall not assign this contract, in whole or in part, or any monies due hereunder, without the written consent of the City.

**BONDING:** Payment and performance bonds will be required of the awarded proposer for any contract that is greater than \$100,000 and will be in an amount equal to 100% of the price specified in the contract. The bonds shall be executed by a surety company authorized to do business in the State of Florida, or otherwise secured in a manner satisfactory to the City for the protection of all persons supplying labor and material to the Contractor or its subcontractors for the performance of the work provided in the contract. See attached bond forms.

**CHANGE ORDERS:** The signed contract serves to define the terms and conditions for the services, work or project as described in the bid and contract documents. A Change Order shall be considered a written order to the Contractor signed by the City, after execution of the contract, authorizing a change in the work or an adjustment in the contract price or the contract time.

**CITY EMPLOYEES AND FAMILY MEMBERS** are eligible to submit a bid for this contract, but in doing so they must file Form 3A “Interest in Competitive Bid for Public Business” with the Supervisor of Elections and submit a copy of the form with their submittal. Under Florida Statute 112.313 this includes “...public officers and employees, their spouses, and their children...”

**Any oral or other type of communication concerning this document shall not be binding.**

**COPYRIGHTS:**

1) If awarded a contract, the contractor agrees that the work requested herein is “work for hire” and shall irrevocably transfer, assign, set over, and convey to the City all right, title, and interest, including sole exclusive and complete copyright interest, in any and all copyrightable works created pursuant to the contract. The contractor further agrees to execute such documents as the City may request to effect such transfer or assignment.

2) Further, the Contractor agrees that the rights granted to the City by this section are irrevocable. Notwithstanding anything else in this invitation, the contractor’s remedy in the event of termination of or dispute over any agreement entered into as a result of this invitation shall not include any right to rescind, terminate or otherwise revoke or invalidate in any way the rights conferred in this section. Similarly, no termination of any agreement entered into as a result of this invitation shall have the effect of rescinding,

terminating, or otherwise invalidating the rights acquired pursuant to the provisions of this "Copyright" section.

3) The use of subcontractors or third parties in developing or creating input into any copyrightable materials produced as part of any agreement entered into as a result of this invitation is prohibited unless the City approves the use of subcontractors or third parties in writing in advance and such subcontractors or third parties agree to include the provision of this section as part of any contract they enter into with the contractor for work related to this contract.

4) If anything included in a deliverable limit the rights of the City to use the information for its own internal use, the deliverable shall be considered defective and not acceptable.

**DAMAGE TO PROPERTY:** Contractor agrees that all City or third party owned property that is damaged by the Contractor's personnel or equipment shall be repaired or replaced promptly, at Contractor's expense.

**DEFAULT:** In any action brought by either party for the enforcement of obligations of the other party, including appeals, the prevailing party shall be entitled to recover reasonable attorney fees, court and other costs, whether incurred before or at trial, on appeal, in bankruptcy, or in post judgment collections.

**DOCUMENT DEEMED AS A CONTRACT:** In the event that the Sebring City Council awards the project described herein to a Contractor(s), and/or a purchase order is processed then this document shall become a legally binding contract unless a separate document is drawn up by the City Attorney in which case the Attorney's contract is primary and this document is secondary.

**DUE CARE AND DILIGENCE** has been exercised in the preparation of this document and all information contained herein is believed to be substantially correct; however, the responsibility for determining the full extent of the service required rest solely with those making response. Neither the City nor its representative shall be responsible for any error or omission in the responses submitted, nor for the failure on the part of the respondents to determine the full extent of the exposures.

**EARLY TERMINATION:** City of Sebring reserves the right to cancel the entire contract should the Contractor violate any provisions of this contract, or if the services being provided by the Contractor do not meet the expectations of the City on a consistent and continuing basis. The City may cancel the contract upon thirty (30) days written notice thereof from City to Contractor.

**EQUIPMENT:** Contractor will provide, at Contractor's expense, all machinery, equipment, tools, superintendence, labor, insurance, and all other accessories necessary to provide the product(s) or service(s) in accordance with the description of the work described herein. Employees of Contractor shall wear company uniforms and shall work from vehicles bearing the Contractors name at all times.

**INDEPENDENT CONTRACTOR:** The parties expressly recognize that the relationship between the City and the Contractor is that of independent contractors, and



that neither Contractor nor any of its servants, agents, or employees shall ever be considered as an agent, servant, or employee of the City.

**INSPECTION & CORRECTION OF WORK:** All work done by the awarded Contractor will be monitored by an authorized designated City employee. Contractor shall notify the designated person of completion of each cycle within twenty-four hours of such completion. The designated contact person will then inspect the work and if they find it has not been done satisfactorily, said work shall be promptly corrected by the Contractor at the Contractor's expense.

**INSURANCE REQUIREMENTS:** Unless otherwise stated in the specifications, the following insurance requirements must be met before delivery of goods and services:

Contractor, upon its part, agrees to protect, indemnify, save harmless, and insure the City from any liability to any persons for injuries to the person, including homicide, or damage to property, resulting from the acts or omissions of the Contractor for performing its obligations under this contract. The parties expressly recognize that the relationship between the City and the Contractor is that of independent contractors, and that neither Contractor, nor any of its servants, agents, or employees shall ever be considered to be an agent, servant, or employee of the City. Contractor shall obtain and maintain, at Contractor's expense, the following insurance and shall not commence work hereunder until such insurance is obtained and approved by the City:

- a. **Comprehensive General Liability** (CGL) insurance shall be maintained by the vendor with a limit of not less than \$1,000,000 each occurrence. If such CGL contains a general aggregate limit, it shall apply separately to this project in the amount of \$2,000,000. CGL insurance shall include bodily injury and property damage liability for premises, products, and completed operations, and personal injury.
- b. **Automobile Liability** shall be maintained with a limit of not less than \$1,000,000 each accident for Bodily Injury and Property Damage. Such insurance shall cover liability arising out of any auto (including owned, hired, and non-owned autos). The policy shall be endorsed to provide contractual liability coverage.
- c. **Worker's Compensation** coverage is to apply to all employees for statutory limits in compliance with the applicable state and federal laws. The policy must include Employers' Liability with a limit of \$500,000 each accident, \$500,000 each employee, \$500,000 policy limit for disease.
- d. **Evidence of Insurance** shall be furnished by the vendor to the City of Sebring. Certificates of insurance are to be signed by a person authorized by the insurer to bind coverage on its behalf. The City of Sebring is to be specifically included as additional insured on all policies except workers' compensation. If the vendor is exempt from workers' compensation requirements they are to submit a DWC-252 Certificate of Exemption Form. In the event the insurance coverage expires prior to the completion of this contract, a renewal certificate shall be issued 30-days prior to the expiration date. The policy shall provide a 30-day notification clause in the event of cancellation or modification to the policy. All certificates of

insurance must be on file with and approved by the City of Sebring before the commencement of work activities.

**LICENSING:** Bidders shall be fully licensed in the state of Florida and shall comply with all applicable laws, regulations, rules, and ordinances of local, state, and federal authorities having jurisdiction. Failure or inability on the part of the respondent to have complete knowledge and intent to comply with such laws, rules and regulations shall not relieve any respondent from its obligation to honor its response and to perform completely in accordance with its response. Proof of all relevant licenses is required as part of your bid submittal.

**LIQUIDATED DAMAGES:** If Contractor fails to achieve substantial completion of the project on or before the date of substantial completion as set forth in the contract, Contractor shall pay to the City of Sebring liquidated damages in the amount of \$500.00 per calendar day for each calendar day the date of substantial completion is delayed. If Contractor fails to achieve final completion of the project on or before the date of final completion as set forth in the contract, or as extended by a change order, Contractor shall pay to the City of Sebring liquidated damages in the amount of \$100.00 per calendar day for each calendar day the date of final completion is delayed.

**LOCAL PREFERENCE:**

1) Preference in Competitive Bidding, Quotes, and Request for Proposals: When purchasing or contracting for procurement services of tangible personal property, materials, contractual services, construction, and/or commodities, the Sebring City Council shall give preference to local businesses in making such purchases or awarding such contracts. Purchase price shall include the base bid and all alternates or options to the base bid that are being awarded. Preference shall be based on the following scale:

<u>Bid/Contract Amt.</u>		<u>Highlands County</u>	<u>City of Sebring</u>
\$0 - \$249,999.99	=	5%	7%
\$250,000 - \$999,999.99	=	4%	4%
\$1,000,000-1,999,999.99	=	3%	3%
\$2,000,000 and over	=	2%	2%

Verification shall be made through Property Appraiser's records.

2) Local Business Definition: "Local business" shall mean a business that:

- a) Has a fixed office or distribution point located in and having a street address within the City of Sebring first, then Highlands County, Florida second, for at least six (6) months immediately prior to the issuance of the competitive bid, request for quotation, or request for proposal by the City of Sebring; and
- b) Holds a business license required by the City of Sebring.

3) Exceptions to Local Preference:

- a) The procurement preference set forth in this policy shall not apply to the following purchases or contracts:

1. Goods or services provided under a cooperative purchasing, inter-local agreement, or “piggybacked” contract.
  2. Contracts for professional services which is subject to the (CCNA) Consultant’s Competitive Negotiation Act or subject to any competitive consultants selection policy or procedure adopted by or utilized by Sebring City Council.
  3. Purchases which are funded, in whole or in part, by a government entity and the laws, regulations, or policies governing such funding prohibit application of that preference.
  4. Purchases made or contracts let under emergency or noncompetitive situations or for litigation related services.
  5. When the bid specifications contain a location/vicinity requirement.
- b) The local preference established in the City’s policy does not prohibit the Sebring City Council from giving any other preference permitted by law in addition to local preference authorized in this policy.

**MULTIPLE RESPONSES:** If submitting a response for more than one bid, each bid must be in a separate envelope and correctly marked.

**NOTICES:** All notices provided under or pursuant to this contract shall be in writing, either by hand delivery or first class certified mail – return receipt requested.

**PAYMENTS:** All payments must be approved by Sebring City Council, which meets the first and third Tuesday of each month. To be considered for payment at any meeting, the invoice must be signed by the department head(s) and received by Accounts Payable, 368 South Commerce Avenue, Sebring, Florida 33870 one week prior to a City Council meeting. Separate invoices must be rendered for each purchase order.

**PERFORMANCE & WORKMANSHIP:** Contractor shall, in good workmanlike manner, perform all services pursuant to the specifications. Should the Contractor fail to provide prudent and competent professional service, the City may notify the Contractor in writing stating the City’s intention to terminate the contract and stating the reasons therefore. Unless Contractor remedies such default or has made satisfactory arrangements with the City for such remedy within five (5) business days after service of said notice upon Contractor, this contract may be terminated by the City. In the event of such termination, the City may take over and complete the work at the expense of the Contractor. The Contractor shall be liable to the City for any excess costs the City incurs.

**PRE-BID MEETING:** A non-mandatory pre-bid meeting will be held on July 26<sup>th</sup>, 2019 at 10:00 a.m. THIS PRE-BID MEETING WILL BE HELD SIMULTANEOUSLY WITH THE PRE-BID MEETING FOR ITB 19-005. All interested parties will meet at City Hall Council Chambers, 368 S. Commerce Ave., Sebring, FL 33870 to sign in and receive instructions. All parties will then proceed to the sites. No questions will be answered at this meeting unless the written question is provided to the Purchasing Agent prior to or during the meeting. Written questions will be answered at the meeting and then posted online at VendorRegistry.com as an addendum.

**PREPARATION COSTS:** The City will not reimburse respondent(s) for any costs associated with the preparation and submittal of any responses.

**PRICE:** City shall pay the awarded Contractor the sum stated on the “Official Bid Form” page of this packet in exchange for the products or services rendered as described herein. The bid price shall be fixed and firm for the period of this contract. Any change in price may result in the cancellation of the purchase order and/or agreement.

## **SECTION 3–PURPOSE OF PROJECT**

The purpose of this bid is to seek a Contractor for the construction of a portion of the Lakeview Mobile Park wastewater collection system to the City of Sebring sewage collection system as shown on the bid plans. The successful bidder will also be responsible for the demolition of the existing wastewater treatment plant and ponds as described on the plans and in the specifications.

## **SECTION 4 – SPECIFICATIONS**

### GENERAL SPECIFICATIONS

#### GENERAL NOTES

- 2) Most, if not all, of the technical specifications are listed on the plans. The local codes for the specified work are adopted herein.
- 3) The contractor shall supply all labor, materials and equipment for the completion of the work.
- 4) The contractor shall be responsible for maintaining a safe work area and supply all necessary signs, equipment and personnel to accomplish the task. Traffic shall be restricted to local traffic only. The work site and traffic control devices used shall at all times be in compliance with the Florida Department of Transportation Roadway and Traffic Design Standards Manual (current edition) and the USDOT, FHWA Manual on Uniform Traffic Control Devices (current edition).
- 5) Removed asphalt and/or concrete sidewalk, WWTP tanks, etc. and curb shall be hauled to a landfill, recycler or otherwise legally disposed of by the contractor. The cost of the hauling and disposal shall be included in the bid price.
- 6) The work shall be fully guaranteed by the contractor for materials and workmanship for a period of at least three (3) years from the date of final payment for the project.
- 7) Any damage caused by the contractor to items which are adjacent to the construction area shall be repaired or replaced by the contractor.
- 8) Any damage done to the grassed right of way areas adjacent to the pavement, such as by parking or driving of trucks or equipment shall be repaired and sodded by the contractor.
- 9) All cleanup work is the responsibility of the contractor, all debris shall be disposed of properly and lawfully.

- 10) Quantities shown are our estimates, if you disagree with those quantities you should provide us with your own values when bidding the job and clearly point them out in the bid submittal package, so that we may evaluate the bids fairly.
- 11) The Contractor will verify all quantities and add any missing materials to his bid for a 100% complete project. The Contractor is responsible for the as-built survey, all electrical work and coordination with Duke Energy.
- 12) The Underground Contractor will verify all quantities and add any missing materials to his bid for a 100% complete project.
- 13) The Demolition Permit is the responsibility of the Contractor. The City of Sebring will furnish the contractor with the required asbestos survey prior to the application for demo permit and the demolition of the WWTP.
- 14) All fittings to be mechanical Joint type with EBAA Mega Lug. All HDPE connections will require stainless steel stiffeners.
- 15) All HDPE fusing will require a mandatory current fusing certification from the contractor issued to the engineer of record prior to any construction.
- 16) All staking will be under the direct supervision of a Licensed Professional Land Surveyor.  
Gravity sewer lines will need to be staked and verified by The City of Sebring prior to installation.
- 17) The Licensed Professional Land Surveyor will issue 5 signed and sealed As-Built Survey's along with an Auto-Cad format As-Built drawing on CD showing all utility improvements to the Engineer of Record after completion of the project.
- 18) The engineering cost estimate for this project is \$180,000.00.

## TECHNICAL SPECIFICATIONS

### SCOPE OF WORK

The scope of work is generally described as the rehab of the lift station with new lining, new sewage pumps, valve box, panel box, junction box, meter can and 3" force main from the lift station to a gravity collection system within the Sam's (old Scotty's) parking area (see plan). Once the rehabbed lift station is fully functional and have been cleared for use by FDEP, the existing wastewater treatment facility shall be, emptied, cleaned, removed and then legally and properly disposed of offsite. The existing percolation ponds shall be filled in with the leveling from the existing berms and any additional clean sand fill needed to the grades specified on the plans.

- 1) Install approximately 90' of 3" Ring-Tite PVC, Class 200 force main within the 15' utility easement along the westerly side of Seaview Street beginning from existing lift station northerly toward Bayview Street using open cut method. Please notice that there may be several existing utilities along the force main path.

- 2) Install approximately 1080' of 3" SDR-11 directional bore westerly along the southerly right-of-way of Bayview Street to the approximate lot lines between addresses 2624 and 2632. Thence northerly 170' of SDR-11 directional bore and 10' of SDR-11 open cut to tie into the existing gravity sewer collection system within utility easement along the easterly property line of Sam's Club property (S-23-34-28-a00-0132-0000, 2720 US 27, Sebring, FL 33870).
- 3) Install new valve box assembly which includes a bypass connection.
- 4) Pressure test the newly installed force main line and valve box assembly. Once the force main line and valve box assembly has been tested and cleared for use by FDEP, the project engineer and the City of Sebring staff may authorize bypass pumping to begin.
- 5) Plug the last segment of gravity sewer line and connect a bypass pump at the final manhole before the lift station, thereby utilizing the last manhole as a temporary lift station. Bypass the lift station and direct the flow to the newly installed valve box assembly and force main line to city collection system.
- 6) After the bypass is running properly, remove the existing lift station equipment and dispose of legally and properly.
- 7) Rehabilitate the lift station -- clean and install the liner, the new equipment, pumps, controls, valve box, etc. To rehabilitate the lift station.
- 8) Once the new lift station is fully operational, the wastewater treatment plant shall be emptied, cleaned then dismantled and legally disposed of as described in the wastewater demolition specifications contained herein these bid specifications. All concrete materials, tanks, piping, will be the responsibility of the contractor to remove and dispose of legally and properly
- 9) The new fencing around the lift station shall be placed once the work on the lift station is completed.
- 10) The excavated voids or holes in the plant site and percolation ponds for the plant will be filled in with material from the berms and other imported clean sand fill material as needed to match the grades shown of the plan and the surrounding area. All of the fill shall be placed in compacted one foot lifts and then sodded as described in the wastewater plant demolition specifications.

#### WASTEWATER PLANT DEMOLITION

Following successful completion of the lift station and force main connection to the City of Sebring and the authorization by the Florida Department of Environmental Protection to place the connection in service, all tanks and components of the existing wastewater facility will be removed from the site and the tank sites and ponds backfilled. The successful bidder shall be responsible for all labor, equipment, materials and disposal fees required for this process.



1) The existing tanks will be emptied of the contents, pressure washed to be clean of loose materials and then hauled from the site and disposed of in a lawful and legal manor. The existing mixed liquor being treated in the tanks shall be pumped into the lift station at a controlled rate under the supervision of the engineer and/or City of Sebring wastewater staff. The onsite lift station and any downstream lift stations cannot be overwhelmed with the material, so it will take some time. If the contractor prefers to load the material on a tanker truck and hauled to the plant or other point in the collection system, that process is acceptable as long as the process is approved by City staff. Each tank shall be washed clean of solids at the end of the emptying process, then rinse washed with a chlorine bleach solution to disinfect prior to hauling. The successful bidder will then remove the tanks from the site for recycling, landfill disposal or other legal and lawful destination.

2) The holes left by the tank removal and the existing percolation ponds shall be backfilled with clean sand fill. The fill shall be placed in twelve inch or less lifts and equipment rolled or compacted to eliminate pockets, approximate native ground and prevent excessive settling. Any berms around the percolation ponds may be used as part of the fill dirt for the ponds and plant and shall be leveled to match the surrounding area. The fill in the plant area shall be brought up to match the grades shown on the plans and the surrounding ground. The fill in the percolation ponds shall be brought up to the top of bank elevation as noted on the plans. The fill area shall be smooth and level after the final dressing. The area shall be sodded with Bahia sod. The contractor shall be responsible for the watering and maintenance of the sod until the project is officially completed. After completion of the project, the owner of the land will take over the watering and maintenance of the sod.

3) Unless claimed by the owner, the contractor shall be responsible for the legal and proper disposal of all motors, blowers, pumps, piping, concrete, etc., which made up the wastewater plant.
