The City of Springfield will be accepting bids for the replacement of the roof on the high service building located at the Springfield Water Treatment Plant, 6213 Smith Road, Cedar Hill, TN. Sealed bids must be received in the Office of the City Recorder at City Hall, 405 N. Main Street, Springfield, TN, 37172, no later than 10:00 a.m. on Friday, July 7, 2017, at which time bids will be opened and read aloud. Any bids received after 10:00 a.m. on Friday, July 7, 2017, will be rejected. Bid submittals shall make reference to Bid Notice # 1033 on the outside of the sealed envelope and that the bid pertains to re-roofing the high service pump building at the City of Springfield Water Treatment Plant.

The size of the roof is approximately 30' X 45' (1,350 sq/ft). The successful bidder will:

Supply all necessary materials and equipment to complete the job including the removal of any debris associated with the job.

Remove existing materials down to the substrate.

Furnish and install a polyiso rigid roof insulation system with a minimum of 1". Tapered polyiso crickets shall be installed where required for proper drainage to drains.

Furnish and install fully adhered 60 mil white tpo with all appropriate flashings and terminations in accordance with the manufacturer's specifications for a fully adhered installation.

Furnish and install 24-gauge prefinished metal copings with the appropriate cleats and fasteners.

Provide a written, industry-standard warranty regarding leakage, life of the roofing system, etc.

It is strongly recommended that an on-site inspection be made prior to submitting a bid due to the complexity of the roof having drains, vents, exhaust fans, etc.

These specifications shall be the minimum necessary to provide the desire roofing system and are not intended to be restrictive.

# IRAN DIVESTMENT ACT NOTICE

While in conclusion on the list would make a person ineligible to contract with the state of Tennessee, if a person ceases its engagement in investment activities in Iran, it may be removed from the list.
