Bid #23-087 Grinding of Yard Waste, Land Clearing Debris & Clean Wood

INTRODUCTION

The Georgetown County, SC, Public Services Department, Division of Environmental Services is soliciting sealed, public bids for Grinding of Yard Waste, Land Clearing Debris and Clean Wood. All process grindings remain onsite for beneficial use.

SCOPE OF SERVICES

The Georgetown County Department of Public Services, Environmental Services Division, requires grinding services for yard waste, land clearing debris and clean wood. Yard Waste is defined as dry/green vegetation/trees. Land Clearing Debris is defined as partial and/or whole trees and related vegetation to include roots, stumps etc. Clean wood may include clean pallets.

- a) Approximately 8,000 9,500 tons of grindable material per year is generated by the County with an estimated four (4) mobilizations annually. Quantities are estimated and may vary due to severe weather conditions or other causes of damage to trees and shrubbery in the county. The County of Georgetown does not guarantee any minimum amounts under this contract.
- b) Material must be tub ground. Grinding must result in a marketable biomass fuel using grinder screens 6" or smaller.
- c) Pricing will be based on yard waste, land clearing debris and clean wood, by the ton, and is based on the "scaled in" weight collected, not the finished ton after grinding. The GCSWL truck scales will be used for this purpose. Weight adjustments will be made for material that cannot be ground or chipped by the Contractor.
- d) Ground material shall be placed in windrows in location designated by staff. The current windrow area is approximately 500 feet from the stockpile of unground materials.
- e) The majority of the debris material is branches and small yard waste debris. However, there are a minimal number of tree stumps included. Less than 25% of the volume is large material.

- f) The landfill operating hours are M-F 7:30AM to 4:30PM. Requests for other hours to grind may be considered upon request and based on mutual agreement.
- g) Yard waste/clean wood grinding equipment shall be self-powered. The County will not provide fuel, electrical power or other means to sustain the operation of the Contractor's equipment. Yard waste/clean wood grinding equipment shall be capable of processing stumps, dirt, logs, and tree branches, brush, landscaping cuttings and trimmings and lumber scraps to the required product size. The discharge height of the processing equipment shall be capable of producing an endproduct stockpile in windrows not to exceed twenty-five feet (25') wide and twelve feet high (12'). All powered equipment shall be equipped with spark arresting mufflers compliant with OSHA standards and operated and mounted so that noise levels do not exceed County or applicable standards for the type of operations.
- k) Contractor shall have the sufficient amount of equipment required to move waste as needed to feed the grinder and place in windrows. County will not assist moving waste material during grinding operations.
- Neither the County nor County staff will be responsible for any damage that may occur to the Contractors' property while it is on County of Georgetown property or as it is being moved to or removed from the County's property. The material to be ground is classified as clean yard waste, clean wood; however, land clearing debris may contain dirt. Georgetown County will not assume liability for damages caused by foreign material, contaminants or dirt.
- m) <u>Safety:</u> The Contractor will be responsible for the safety of their staff, County staff and public during grinding operations. A current certificate of insurance listing Georgetown County as an additional insured must remain on file with the County Purchasing Department at all times during the life of the Contract. See the Instructions for Providers section for County insurance requirements. The County will collect this only from the awarded Contractor at time of Contract signatures.
- n) <u>Alternate #1-Emergency Deployment:</u> In the event of an emergency, this contract is part of the County's Emergency Response and Debris Management Programs. The County may establish secondary grinding locations. If those grinding locations do not have a scale for recording of weights, by mutual agreement of quantities, the Contractor may provide grinding by cubic yardage.
- <u>Alternate #2-Soil Screening:</u> Contractor may be contracted to screen ground/ungrounded land clearing debris to separate soil and debris; Single pass, 6" screen acceptable for screening. If your company does not perform Soil Screening, please state that on the Exceptions Page in the Mandatory Bid Forms.


Site Inspection

The grinding service site location is on County property, within the operating solid waste landfill. Each offeror shall be responsible for visiting the site by making a prior appointment. Please contact Nancy Silver at <u>nsilver@gtcounty.org</u> to schedule a site visit. The GPS address for the landfill office is 201 Landfill Road, (off Browns Ferry Road a/k/a SC-51), Georgetown, SC 29440.

1) The bidder is expected to have become familiar with and take into consideration, site

conditions which may affect the work and to check all dimensions at the site.

- 2) Each bidder shall acquaint themselves thoroughly as to the character and nature of the work to be done. Each bidder furthermore shall make a careful examination of the site of the work and inform themselves fully as to the difficulties to be encountered in performance of the work, the facilities for delivering, storing and placing materials and equipment and other conditions relating to construction and labor.
- 3) The bidder shall examine the premises and the site and compare them with any applicable drawings and specifications. He/she shall familiarize themselves with the existing conditions such as obstructive area levels and any problems related to erecting the required systems.
- 4) No plea of ignorance of conditions that exist or may hereafter exist on the site of the work, or difficulties that may be encountered in the execution of the work, as a result of failure to make necessary investigations and examinations, will be accepted as an excuse for any failure or omission on the part of the Contractor to fulfill in every detail all the requirements of the contract documents and to complete the work for the consideration set forth therein, or as a basis for any claim whatsoever.
- 5) Insofar as possible, the Contractor, in carrying out his/her work, must employ such methods or means as will not cause interruption of or interference with the work of any other Contractor, or County personnel at the site.



Provisions for Cost of Fuel Price Adjustment

Fuel Cost Factor

- To provide for the potential effect of fuel prices adjustments, each contractor must indicate a decimal or percentage factor for calculating the portion of their expense which is based on the fuel cost portion of the price per ton rate for the service you are bidding. This fuel cost factor will remain constant throughout the contract term. (IE: if 15% of your total cost to provide a service is directly related to the cost of fuel, you would indicate "15%".)
- 2) To accommodate changes in fuel costs, prices may be adjusted no more than quarterly if requested by contractor based on the most current North Augusta, SC Average Rack Price that is available on the closest day to the contract anniversary date, as recorded in the State of South Carolina adjusted average cost available and published by South Carolina Business Opportunities (SCBO). The contractor is expected to manage costs associated with labor, overhead and general sales and administration for the life of the original agreement. No price change related to cost issues other than fuel cost will be considered as a basis for price adjustment.
- 3) A fixed margin to be used in price adjustment calculations shall be calculated by subtracting the fuel cost (determined from the fuel cost factor) from the original bid unit price:

Fuel Cost = Bid Unit Price x Fuel Cost Factor Fixed Margin = Bid Unit Price - Fuel Cost

For price adjustments, this fixed margin shall be utilized to calculate subsequent fuel costs relative to the contract unit price in effect at the time, regardless of the contractor's actual fuel cost:

Fuel Cost = Contract Unit Price - Fixed Margin

4) The benchmark fuel price index for the purpose of calculating price adjustments for the agreements resulting from this bid shall be the reported State of South Carolina adjusted average cost available on South Carolina Business Opportunities (SCBO). The base value to be used for calculating the initial price adjustment shall be the index published on the first week of the contract award. Adjustments shall be calculated according to the percentage change, up or down, as reflected in this index. Only the fuel cost component of the contract unit price shall be adjusted. The adjusted fuel cost shall be calculated by one of the following formulas:

Adjusted up in accordance with the percent increase in the index value: Adjusted Fuel Cost = Fuel Cost + (Index Value % Increase x Fuel Cost) OR Adjusted down in accordance with the percent decrease in the index value: Adjusted Fuel Cost = Fuel Cost - (Index Value % Decrease x Fuel Cost)

The new unit price is the sum of the fixed margin and the adjusted fuel cost:

New Unit Price = Fixed Margin + Adjusted Fuel Cost

5) All calculated price adjustments shall be effective on the first calendar day of the "price adjustment"

month.

- 6) All price adjustment calculations of less than 1 % shall not be implemented. Subsequent price changes shall be calculated by comparing the current index value to the index value last used to calculate an allowable price change, which may result in cumulative increases or decreases of more than 1 %.
- 7) The calculation method described herein shall not change for the life of the agreement.

Evaluation & Award

The County intends to award an indefinite delivery services contract to the lowest responsive and responsible bidder. In determining responsibility, the following items shall be considered: references, compliance with specifications and requirements, and equipment.

If it is necessary for the selected firm to retain sub-consultants to perform specific services, identification of those firms and any fees for those services must be submitted as part of your bid. Any changes in sub-consultants for necessary services shall require prior approval by Georgetown County.

The base term of the contract will be for one (1) year from the date the effective date of the contract with automatic renewal for four (4) additional one (1) year periods, contingent upon satisfactory appraisal of the previous one (1) year period, and pending availability of appropriated funds, not to exceed a maximum of five (5) years total.

- 3. <u>Inclement Weather/Closure of County Courthouse</u> Bid openings at the time of this issuance are being conducted virtually or hybrid and may occur from an alternate secure and/or remote location as needed. A virtual meeting link will be posted under the bid number before the bid opening time so that members of the public may attend the meeting virtually.
- 4. This solicitation does not commit Georgetown County to award a contract, to pay any cost incurred in the preparation of the bid, or to procure or contract for goods or services. It is the responsibility of each bidder to see that the Georgetown County Purchasing Office receives bids on, or before, the date and time specified for the bid opening. No bid will be accepted thereafter. The County assumes no responsibility for delivery of bids that are mailed. Georgetown County reserves the right to reject any or all bids and to waive any informalities and technicalities in the bid process.

5. NON EXCLUSIVITY

Nothing herein is intended nor shall be construed as creating any exclusive arrangement with Contractor. Any resulting contract shall not restrict the County from acquiring similar, equal or like goods and/or services from other entities or sources, when Staff determines internally that this resulting action is in the best interest of Georgetown County.

- 6. <u>No Bidder may submit more than one bid</u>. Multiple bids for different manufacturers but represented by the same firm will not be accepted. Bids offered directly from manufacturers shall indicate if a local dealer/representative will be involved.
- 7. <u>Definitions:</u>
 - a) The terms "Proposer", "Offeror", "Vendor" or "Bidder" refer to those parties who are submitting sealed responses for the work set forth in this document to the OWNER, as distinct from a subbidder who provides a bid to the Bidder. The term "Contractor" refers to the successful Bidder.
 - b)The term "<u>Grinding of Yard Waste, Land Clearing Debris & Clean Wood</u>" or "Service" refers to the **complete set of services** as specified in this document, in every aspect.
 - c)The terms "Owner" and "County" refer to the County of Georgetown, South Carolina.
 - d)Where the words "shall" or "must" are used, it signifies an absolute minimum function or capacity that, if not satisfied, may result in disqualification.
 - e)Where the words "should", "may", or "is desirable" are used, it signifies desirable, but not mandatory functions or capacities. Bidders who are able to provide these functions or capacities may be evaluated more favorably that those who cannot.

8. Correction or Withdrawal of Bids; Cancellation of Awards

An offeror must submit in writing a request to either correct or withdraw a bid to the Procurement Officer. Each written request must document the fact that the offeror's mistake is clearly an error that will cause him substantial loss.

- a) Correction of awards : An offeror shall not be permitted to correct a bid mistake after bid opening that would cause such offeror to have the low bid unless the mistake in the judgment of the Procurement Officer is clearly evident from examining the bid document; for example, extension of unit prices or errors in addition.
- b) Cancellation of awards prior to performance: When it is determined after an award has been issued but before performance has begun that Georgetown County's requirements for the goods or services have changed or have not been met, the award or contract may be canceled and either re-awarded or a new solicitation issued.

9. Faxed or E-mailed bids will not be accepted by Georgetown County. Electronic bid submissions must be submitted through the Georgetown County Purchasing Vendor Registry page to ensure they remain sealed until the scheduled bid opening date and time.

10. If you need any reasonable accommodation for any type of disability in order to participate in this procurement, please contact the purchasing office as soon as possible.

- 11. Title VI of the Civil Rights Act of 1964: Georgetown County hereby gives public notice that it is the policy of the agency to assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice, and related statutes and regulations in all programs and activities. Title VI requires that no person in the United States of America shall, on the grounds of race, color, or national origin, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which Georgetown County receives federal financial assistance. Any person who believes they have been aggrieved by an unlawful discriminatory practice under Title VI has a right to file a formal complaint with Georgetown County. Any such complaint must be in writing and filed with Georgetown County's Title VI Coordinator within one hundred and eighty (180) days following the date of the alleged discriminatory occurrence. - 12. Any deviations from the specifications or modification of this bid and any extra or incidental work or reductions in work shall be set forth in writing and signed by both parties prior to making such change. Any increase or decrease in the bid price resulting from such change shall be included in writing.
- 13. <u>Exceptions</u>: The bidder shall list on a separate sheet of paper any variations from, or exceptions to, the conditions and specifications of this bid. This sheet shall be labeled "Exception(s) to Bid Conditions and Specifications," and shall be attached to the bid. When Proposers find instances where they must take exception with certain requirements or specifications of the bid, all exceptions shall be clearly identified. Written explanations shall include the scope of the exceptions, the ramifications of the exceptions for the County of Georgetown, and a description of the advantage to be gained or disadvantages to be incurred by the County as a result of these exceptions. If none, write "NONE".
- 14. Georgetown County reserves the right to reject any or all bids, and to waive as an informality any irregularities contained in any bid as may be deemed in the best interest of the County. Georgetown County further reserves the right to reject any bid submitted, at its sole option, that the vendor may not be able to meet the service requirements of the bid.
- 15. <u>Publicity releases</u>: contractor agrees not to refer to award of any resulting contract in commercial advertising in such a manner as to state or imply that the products or services provided are endorsed or preferred by the user.
- 16. <u>Material Safety Data Sheets</u>: The County of Georgetown will not receive any materials, products, or chemicals which may be hazardous to an employee's health unless accompanied by a Material Data Sheet when received.
- 17. <u>Ownership of Copyright</u>: All right, title and interest in all copyrightable materials which vendor shall create in the performance of its obligations hereunder shall be the property of the procurer. Vendor agrees to assign and hereby does assign any and all interest it has in and to such material to procurer. Vendor agrees, upon the request of procurer to execute all papers and perform all other such acts necessary to assist procurer to obtain and register copyrights on such materials. Where applicable, works of authorship created by the vendor in the performance of its obligations hereunder, shall be considered "works for hire" as defined in the U.S. Copyright Act.

- 18. <u>Ownership of Documents</u>: Any reports, studies, photographs, negatives or other documents prepared by vendor in the performance of its obligations shall be the exclusive property of the procurer and all such material shall be remitted to the procurer by the vendor upon completion, termination or cancellation of this order. Vendor shall not use, willingly allow or cause to have such material used for any purpose other than performance of its obligations under this order without the prior written consent of the procurer.
- 19. <u>Affirmative Action</u>: The contractor will take affirmative action in complying with all Federal and State requirements concerning fair employment and employment of the handicapped, and concerning the treatment of all employees, without regard or discrimination by reason of age, race, color, religion, sex, national origin or physical handicap. The following are incorporated herein by reference: 41 C.F.R. 60-1.4, 60-250.4 and 60-741.4.
- 20. Inclusion and participation of disadvantaged, small, and local business entities is strongly encouraged, but minimum participation standards are not in effect for this project.
- 21. Federally Funded Construction Contracts Over \$2,000:
 - a) Davis-Bacon Requirements. These contracts need to include a provision for compliance with the Davis-Bacon Act (40 USC 276a to a—7) and the Department of Labor implementing regulations (29 CFR Part 5). Under this Act, Contractors are required to include the contract provisions in Section 5.5 (a) of 29 CFR Part 5, and to pay wages to laborers and mechanics at a rate not less than the minimum wages specified in the wage determination made by the Secretary of Labor. In addition, Contractors shall be required to pay wages not less than the minimum wages specified in the wage determination made by the Secretary of Labor. In addition, Contractors shall be required to pay wages not less often than once a week.  - b) Contract Work Hours and Safety Standard Act Requirements. The contracts must include a provision for compliance with Sections 103 and 107 of the Contract Work Hours and Safety Standards Act (40 USC 327-330) as supplemented by the Department of Labor regulations (29 CFR Part 5). Under Section 103 of the Act, each Contractor shall be required to compute the wages of every mechanic and laborer on the basis of a standard workweek of 40 hours. Work in excess of the standard workweek is permissible provided that the worker is compensated at a rate not less than one times the basic rate of pay for all hours worked in excess of 40 hours in the workweek. Section 107 of the Act is applicable to construction work and provides that no laborer of mechanic shall be required to work in surroundings or under working conditions which are working conditions.
 - the workweek. Section 107 of the Act is applicable to construction work and provides that no laborer of mechanic shall be required to work in surroundings or under working conditions which are unsanitary, hazardous, or dangerous to health and safety as determined under construction, safety and health standards promulgated by the Secretary of Labor. These requirements do not apply to the purchases of supplies, materials, or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence.
 - c) Copeland "Anti-Kickback" Act Requirements. All construction contracts over \$2,000.00 must include a provision for compliance with the Copeland "Anti-Kickback" Act (18 U.S.C. 874) as supplemented in Department of Labor regulations (29 CFR Part 3). This act provides that each Contractor shall be prohibited from inducing, by any means, persons employed in the construction, completion, or repaid of public work to give up any part of their compensation.

22. Bidders must clearly mark as "confidential" each part of their bid which they consider to be proprietary information that could be exempt from disclosure under section 30-4-40, Code of Laws of South Carolina 1976, as amended (Freedom of Information Act). If any part is designated as confidential, there must be attached to that part an explanation of how this information fits within one or more categories listed in section 30-4-40. The County reserves the right to determine whether this information should be exempt from disclosure and no legal action may be brought against the County or its agents for its determination in this regard.

23. CERTIFICATION REGARDING DRUG-FREE WORKPLACE:

The contractor certifies that the vendor(s) will provide a "drug-free workplace" as that term is defined in Section 44-107-30 of the Code of Laws of South Carolina, 1976, as amended, by the complying with the requirements set forth in title 44, Chapter 107.

24. Certification of Non-Segregated Facilities

The federally-assisted construction contractor certifies that he does not maintain or provide, for his employees, any segregated facilities at any of his establishments and that he does not permit his employees to perform their services at any location, under his control, where segregated facilities are maintained. 27. This Invitation for Bid covers the estimated requirements to provide <u>Grinding of Yard Waste, Land</u> <u>Clearing Debris & Clean Wood</u> for the <u>Georgetown County Public Services</u>, <u>Environmental Services</u> <u>Division</u>. The purpose is to establish firm pricing and delivery. The right is reserved to extend the use of this contract to any County Department.

28. TERMS OF AGREEMENT / RENEWAL

The County reserves the right to negotiate with the successful bidder, after contract award, for an additional discount should available funds permit the purchase of additional units within the fiscal year.

29.PRICE ESCALATION/DE-ESCALATION:

Prices are to remain firm for the first contract period. In subsequent terms, the contractor may request, in writing at least sixty (60) days in advance of the contract ending date, an increase/decrease. Should the County elect to exercise the option to renew the contract for additional year(s), the contract prices for the additional years shall not exceed the percentage increase/decrease of the "Services" category of the CPI-W SECTION OF THE COMSUMER PRICE INDEX of the United States Bureau of Labor Statistics for the latest twelve month for which statistics are available. Should the price change be granted and the County elects to renew the contract, the purchase order will reflect the changes.

31. Workman's Compensation Coverage

32. Hold Harmless Clause

The Contractor shall, during the term of the contract including any warranty period, indemnify, defend, and hold harmless the County, its officials, employees, agents, and representatives thereof from all suits, actions, or claims of any kind, including attorney's fees, brought on account of any personal injuries, damages, or violations of rights, sustained by any person or property in consequence of any neglect in safeguarding contract work or on account of any act or omission by the contractor or his employees, or from any claims or amounts arising from violation of any law, bylaw, ordinance, regulation or decree. The vendor agrees that this clause shall include claims involving infringement of patent or copyright.

33. Condition of Items

All items shall be new, in first class condition, including containers suitable for shipment and storage, unless otherwise indicated herein. Verbal agreements to the contrary will not be recognized.

34. Workmanship and Inspection

All work under this contract shall be performed in a skillful and workmanlike manner. The County may, in writing, require the Contractor to remove any employee from work that the County deems incompetent or careless.

Further, the County may, from time to time, make inspections of the work performed under this contract. Any inspection by the County does not relieve the Contractor from any responsibility regarding defects or other failures to meet the contract requirements.

35. Invoicing and Payment

The Contractor shall submit invoices on a frequency to be determined, as agreed upon by the County, for each payment requested. Such invoice shall also include a detailed breakdown of all charges. All such invoices will be paid within thirty (30) days unless any items thereon are questioned, in which event payment will be withheld pending verification of the amount claimed and the validity of the

claim. The firm shall provide complete cooperation during any such investigation. All invoices shall be forwarded to the following address:

36. Assignment of Contract

This contract may not be assigned in whole or part without the written consent of the Purchasing Officer.

37. Termination

Subject to the provisions below, the contract may be terminated by the County upon sixty (60) days advance written notice to the other party; but if any work or service hereunder is in progress, but not completed as of the date of termination, then this contract may be extended upon written approval of the County until said work or services are completed and accepted.

a. <u>Termination for Convenience</u>

In the event that this contract is terminated or canceled upon request and for the convenience of the County, without the required sixty (60) days advance written notice, then the County shall negotiate reasonable termination costs, if applicable.

b. <u>Termination for Cause</u>

Termination by the County for cause, default or negligence on the part of the contractor shall be excluded from the foregoing provision; termination costs, if any, shall not apply. The sixty (60) days advance notice requirement is waived in the event of Termination for Cause.

c. <u>Non-Appropriation:</u>

It is understood and agreed by the parties that in the event funds are not appropriated in the current fiscal year or any subsequent fiscal years, this contract will become null and void and the County will only be required to pay for services completed to the satisfaction of the County.

38. Default

In case of default by the contractor, for any reason whatsoever, the County may procure the goods or services from another source and hold the contractor responsible for any resulting excess cost and may seek other remedies under law.

39. Severability

In the event that any provision shall be adjudged or decreed to be invalid, such ruling shall not invalidate the entire Agreement but shall pertain only to the provision in question and the remaining provisions shall continue to be valid, binding and in full force and effect.

40. <u>Applicable Laws</u>

This Agreement shall be governed by and construed in accordance with the laws of the State of South Carolina, U.S.A.

41. Claims and Disputes:

All claims, disputes and other matters in question between parties arising out of, or relating to, this Agreement, or the breach thereof, shall be decided in the Circuit Court of the Fifteenth Judicial circuit in Georgetown County, South Carolina. By executing this Agreement, all parties specifically consent to venue and jurisdiction in Georgetown County, South Carolina and waive any right to contest jurisdiction and venue in said Court.

42. Rights of County

The County reserves the right to reject all or any part of any bid, waive informalities and award the contract to the lowest responsive and responsible bidder to best serve the interest of the County.

43. Award of Bid

In determining the lowest responsive and responsible bidder, in addition to price, there shall be considered the following:

- (a) The ability, capacity and skill of the bidder to perform the contract.
- (b) Whether the bidder can perform the contract within the time specified, without delay of interference.
- (c) The character, integrity, reputation, judgment, experience and efficiency of the bidder.

47. Firm Pricing for County Acceptance

49. Unit Prices and Extension

50. Use of Brand Names (If Appropriate)

Should the lowest responsible and responsive Georgetown County bidder not exercise its right to match the bid as granted herein, the next lowest qualified Georgetown County bidder shall have that right and so on. The right to exercise the right to match the bid shall be exercised within 24 hours of notification of the right to match the non-Georgetown County bidder's bid.
- 4. In order to qualify for the local preference authorized by this Section, the vendor seeking same shall be required to submit with its bid a statement containing relevant information which demonstrates compliance with the provisions of this Section. This statement shall be on a form provided by the County purchasing department and shall be signed under penalty of perjury. Failure to provide such affidavit at the time the bidder submits its bid shall constitute a waiver of any claim for preference.
- 5. For all contracts for architecture, professional engineering, or other professional services governed by Section 2-56, Architect-Engineer and Land Surveying Services Public Announcement and Selection Process, the county shall include the local business status of a firm among the factors considered when selecting which firms are "most highly qualified."

In determining which firm is the "most qualified" for purposes of negotiating a satisfactory contract, preference shall be given to a local business where all other relevant factors are equal.

 - (d) Purchases or contracts made pursuant to a noncompetitive award process, unless otherwise provided by this section; or
 - (e) Any bid announcement which specifically provides that the general local preference policies set forth in this section are suspended due to the unique nature of the goods or services sought, the existence of an emergency as found by either the county council or county administrator, or where such suspension is, in the opinion of the county attorney, required by law.
