RESERVATIONS

The City, through its duly authorized officials, reserves the right to reject any, part of, or all proposals and to waive any formality pertaining to any proposal, without the imposition of any form of liability. The Owner also reserves the right to award this proposal to the most qualified proposer or to the proposer that offers the best value to the City taking into consideration the evaluation criteria contained herein. The companies whose proposals are not accepted will be notified after a binding agreement between the successful Candidate(s) and the Owner is executed, or upon the Owner's rejection of all proposals.

SUBSTITUTIONS

Where materials or equipment are specified by a trade or brand name, it is not the intention of the City to discriminate against an equal product of another manufacturer, but to set a definite standard of quality or performance and to establish an equal basis for the evaluation of bids. In preparing this bid, each bidder is expected to include in his base bid the cost of the items so specified. No alternate bids or bid items will be considered for this proposal.

SCOPE OF SERVICES

The City of Conroe is interested in providing first class food and beverage mobile concession service as specified herein. Before submitting a proposal, each bidder will be held responsible for having examined the premises and satisfied themselves as to the existing conditions or location under which they will be obligated to operate, or that will in any way affect the services under the contract.

PROPERTY DESCRIPTION

Dr. Martin Luther King, Jr. Park- Located at 1001 Dr. Martin Luther King, Jr. Place South, Conroe, TX 77301 features a large playground, pavilion and picnic areas, futsal courts, basketball courts, walking trail, multi-purpose field, sand volleyball court, and a splash pad.

McDade Park- Located at 10310 FM 2854, Conroe, TX 77304 features a playground, pavilions and picnic areas, multi-purpose and soccer fields, basketball court, walking trail, fitness course, sand volleyball court, horseshoe pit, fishing access, and an 18-hole disc golf course.

Candy Cane Park- Located at 1204 Candy Cane Lane, Conroe, TX 77301 features playgrounds, pavilions and picnic areas, basketball court, walking/jogging trail, tennis/ pickleball courts, sand volleyball court, and a fitness course. The Conroe Aquatic Center and the C.K. Ray Recreation Center are also features of the park, however, concessions at these facilities are not included in the this RFP.

Kasmiersky Park- Located at 889 Old Magnolia Rd., Conroe, TX 77304 features an ADA inclusive playground, pavilions and picnic areas, multi-use field, basketball court, a half-mile walking trail, a skate park, and an off-leash dog park.

SPECIAL PROVISIONS

<u>Period of Operation</u>: Upon acceptance and approval this bid effects a written agreement between CITY and VENDOR for the rights to operate a mobile concession stand at FACILITIES in accordance with the provisions contained herein. Contract will commence on May 1, 2019 and continue for 12 months, renewable annually thereafter every year. CITY will evaluate the proposals and select the one (or more) most beneficial to the CITY.

Report of Sales: All payments are to be submitted to CITY, Conroe Parks and Recreation Department Attn: Lauren Arnold located at 1504 Parkwood West, Conroe, Texas 77301 (physical address) or mail to P.O. Box 3066, Conroe, Texas 77305 by the 15th of each month for the previous month's operation. Each payment (check payable to the City of Conroe) shall be accompanied by a complete report of the month's business transactions on standard monthly report forms, including the total of all daily sales of all commodities.

<u>Payment Default</u>: In case VENDOR fails to pay the monies due to CITY, pursuant to the terms of this agreement, CITY has the option to terminate the contractor and seek whatever legal relief may be appropriate to recover the balance due and may relet the privileges herein conveyed.

<u>Supervision</u>: VENDOR shall directly supervise this concession operation at all times. CITY shall have the right to inspect the vehicle or premise and to supervise the manner of exercising privilege hereby granted, and the conduct of VENDOR and those under him.

<u>Alterations</u>: Alterations to any part of the building or grounds on the premises will not be permitted without the prior approval of the Parks and Recreation Department. Any such alterations permitted will be at the expense of VENDOR and must comply with all City of Conroe building codes.

<u>Sublet of Concessions</u>: VENDOR shall not sell, sublet or assign this contract or any portion thereof to any other person or assignee or lessee.

<u>Violation of Contract, Law and/or Ordinances</u>: In the event VENDOR, its agents, representatives, employees, or volunteers are found willfully violating any law, ordinance, or provision of this contract, or becomes objectionable and offensive to the good order and use of the said PARK FACILITY, The said VENDOR shall be required to remove any such person from said FACILITY at once. CITY may, in addition thereto, terminate and cancel this agreement at its option and have all VENDOR property removed from the area.

Police Protection: CITY does not guarantee police protection and will not be liable for any loss or damage sustained by VENDOR. VENDOR shall hold and save CITY harmless from any and all claims from damages of whatever nature and kind, suffered or asserted to have been suffered, by the person or property of any person whomever, growing out of or resulting from or in any way connected with exercise of the privilege herein granted.

<u>Termination Clause:</u> It is further understood and agreed that VENDOR will vacate the premises immediately upon receipt of written notice to him by CITY. In the event this contract is for any reason canceled, or at the termination of this contract and in case VENDOR fails to vacate the said premises upon aforesaid cancellation or at the termination of this contract, CITY shall not be responsible for any damage that might occur to VENDOR's property by virtue of CITY forcibly removing the property of VENDOR.

<u>Hours or Operation:</u> The Parks and Recreation Department reserves the right to regulate the days and hours the concessions will operate. Special events are occasionally held at PARK FACILITY. Detailed schedules will be forwarded to VENDOR as soon as CITY has the information. VENDOR will open and operate at an agreed upon time by City and Vendor. The public is allowed to bring food and beverages into FACILITY. FACILITY will generally be open to the public as follows:

Sunday through Saturday from dawn to dusk (lighted multi-purpose field until 11:00 p.m.).

COMMUNICATION

The City of Conroe shall not be responsible for any verbal communication between any representative of the City and any potential firm. All modifications to this solicitation must be made in writing. A proposer's failure to examine relevant documents or specifications will not relieve offer or from any obligation with regard to their response to this invitation.

CONDITIONS OF CONDUCT

At all times any agent, officer, or employee of Proposer shall be present upon property owned by the City of Conroe, the terms and conditions of the Drug and Alcohol Policy currently adopted by the City of Conroe, shall be deemed applicable to such persons. Violations of terms and conditions while present on the premises owned by the City of Conroe shall be grounds for termination of any contract between the City and Proposer. A copy of this policy is available for public inspection in the office of the City Secretary and copies may be obtained at a nominal charge.

ETHICAL STANDARD

No City official or employee shall have interest in any contract resulting from this bid. Individuals with a possible conflict will enact a public disclosure record by completing a "Statement of Financial Interest" form.

REIMBURSEMENTS

There is no expressed or implied obligation for the City of Conroe to reimburse responding firms for any expenses incurred in preparing proposals in response to this request and the City will not reimburse responding firms for these expenses, nor will the City pay any subsequent costs associated with the provision of any additional information or presentation, or to procure a contract for these services.

DISCLOSURE

There will be no disclosure of the contents to competing firms until the contract is awarded. All proposals will be kept confidential during the negotiation process. Once the contract has been awarded, all proposals will be open for public inspection, except for trade secrets and confidential information, which the firm identifies as proprietary.

DEFAULT

The City reserves the right to terminate the contract immediately for failure to meet delivery or completion schedules, or otherwise perform in accordance with the requirements of this proposal.

SELECTION PROCESS

The City reserves the right to award parts of bids, reject any or all bids and to waive technical irregularities in bidding. Contract award will be made on the basis of the lowest qualified responsible bidder or the bidder who provides the goods and services at the best value for the City, considering the evaluation selection criteria below.

Best Value Selection Criteria:

a) Equipment condition, qualifications and overall experience.
b) Food variety, selection offered and process of items to be sold.
c) References of current customers.
30 points
35 points

If negotiations with the most qualified Proposer are unsuccessful for any reason, the City will terminate negotiations formally and in writing with such firm and proceed in order to negotiate with the next most qualified firm until an agreement is reached.

Proposals will be assessed against evaluation criteria and a decision made by the Evaluation Committee. Notification of proposal acceptance will be written formal confirmation.

INDEMNIFICATION

The Proposer shall, defend, indemnify, and hold harmless the City of Conroe, their officers, and agents from and against any and all claims, demands, causes of action, orders, decrees, or judgments for injury, death, damage to person or property, loss, damage, or liability of any kind (including without limitation liability under any federal, state, or local environmental law, Compensation and Liability Act; fees and costs (including all costs or settlements and reasonable attorney's fees incurred in defending any claim, demand, or cause of action) occasioned by, growing out of, or arising from (a) the performance of any product or service to be supplied by the Proposer, or (b) by any act, error or omission on the part of the Proposer, its agents, employees, or subcontractors, and or (c) any failure to fully comply with all applicable laws and regulations by the Proposer, its agents, employees, or subcontractors.

INSURANCE REQUIREMENTS

The Proposer shall procure and maintain, at its expense, during the term of this proposal, at least the following insurance, covering work performed.

INDEPENDENT CONTRACTOR RELATIONSHIP

The Proposer is and shall perform these services as an independent contractor, and as such, shall have and maintain complete control over all of its employees, agents, and operations. Neither the Proposer nor anyone employed by it shall be, represent, act, purport to act or be deemed to be the agent, representative, employee or servant of the City of Conroe.

The Proposer selected by this Request for Proposal will be working as an independent contractor and will be required to take out and keep in force all permits, licenses, certifications, other approvals, and or insurance that may be required by the City of Conroe, any local or regional governmental agency, the State of Texas, or the federal government. Failure to comply with any of these items would be grounds for immediate cancellation of the contract.

CONDITIONS OF WORK

Proposers are expected to be fully informed of buildings, locations and working conditions under which the service will be performed, and to have thoroughly reviewed this RFP and specifications. Failure to do so will not relieve the successful proposer of any obligations to furnish the services as specified herein.
