City of Knoxville Request for Proposals Video Detection System

I. Statement of Intent

The City of Knoxville is seeking proposals from responsible, qualified firms to provide a low maintenance Video Detection System (VDS). This VDS shall monitor vehicles on a roadway via processing of video images and provide detector outputs to a traffic controller or similar device.

The City intends to award a contract for the term of one (1) year with two (2) optional one-year renewals. The City anticipates a contract being awarded as soon as practicable following the evaluation of proposals.

II. RFP Time Line

This timetable is for the information of submitting entities. These dates are subject to change. However, in no event shall the deadline for submission of the proposals be changed except by written modification from the City of Knoxville Purchasing Division.

III. Background

The City of Knoxville's Traffic Engineering division maintains over 390 signalized intersections. Approximately 50 intersections use real time video for detecting vehicles. This video system would replace current systems that are obsolete and/or damaged. The City is in search of a video solution that detects vehicles and capable of real time traffic signal performance measures. This data shall be based on the Purdue/ Federal Highway Administration (FHWA) high resolution data formats. Because the City is committed to environmentally sound practices, the City desires a solution that could reuse and/or recycle existing City-owned wiring and cabinet card racks. The use of existing wiring would save City resources, as well as, installation time. Although, the core goal of this RFP would be reliable replacement vehicle presence detection, the City is interested in advanced features. This very set of features are becoming standard with advanced video detection systems.

IV. General Conditions

- 4.1 The following data is intended to form the basis for submission of proposals to provide a Video Detection System for the City of Knoxville.
- 4.2 This material contains general conditions for the procurement process, the scope of

service requested, contract requirements, instructions for submissions of proposals, and submission forms that must be included in the proposal. The RFP should be read in its entirety before preparing the proposal.

- 4.3 All materials submitted pursuant to this RFP shall become the property of the City of Knoxville.
- 4.4 To the extent permitted by law, all documents pertaining to this Request for Proposals shall be kept confidential until the proposal evaluation is complete and a recommendation submitted to City Council for review. No information about any submission of proposals shall be released until the process is complete, except to the members of the Evaluation Committee and other appropriate City staff. All information provided shall be considered by the Evaluation Committee in making a recommendation to enter into an agreement with the selected consultant.
- 4.5 Any inquiries, suggestions or requests concerning interpretation, clarification or additional information pertaining to the RFP shall be made **in writing and be in the hands of the Procurement Specialist, Julie Smith Maxwell, by the close of the business day on June 8, 2018.** Questions can be submitted by letter, fax (865-215-2277), or email to jmaxwell@knoxvilletn.gov. The City of Knoxville is not responsible for oral interpretations given by any City employee, representative, or others. The issuance of written addenda is the only official method whereby interpretation, clarification, or additional information can be given. If any addenda are issued to this Request for Proposals, the Purchasing Division will post them to the City's website at www.knoxvilletn.gov/proposals. Submitting organizations are strongly encouraged to view this website often to see if addenda are posted. Failure of any proposer to receive such addendum or interpretation shall not relieve such Proposer from any obligation under his proposal as submitted. All addenda so issued shall become part of the Contract Documents.
- 4.6 The City of Knoxville reserves the right to (a) accept or reject any and/or all submissions of proposals; (b) to waive irregularities, informalities, and technicalities; and (c) to accept any alternative submission of proposals presented which, in its opinion, would best serve the interests of the City. The City shall be the sole judge of the proposals, and the resulting negotiated agreement that is in its best interest, and its decision shall be final. The City also reserves the right to make such investigation as it deems necessary to determine the ability of any submitting entity to perform the work or service requested. Information the City deems necessary to make this determination shall be provided by the submitting entity. Such information may include, but is not limited to, current financial statements by an independent CPA, verification of availability of equipment and personnel, and past performance records.
- 4.7 Included in the Contract Documents is an affidavit that the undersigned has not entered into any collusion with any person with respect to this proposal. The qualifier is required to submit this affidavit with the submission. Also included is the Diversity Business Program contracting packet. Submissions must indicate on the enclosed form whether or not the proposer/qualifier intends to use subcontractors and/or suppliers from one of the defined groups. Proposers/Qualifiers are advised that the City tracks use of such use, but it does not influence or affect evaluation or award.

- 4.8 Subsequent to the Evaluation Committee's review and the Mayor's recommendation of a firm(s), Knoxville City Council approval may be required before the final contract may be executed.
- 4.9 All expenses for making a submission of proposal shall be borne by the submitting entity.
- 4.10 Any submission of proposals may be withdrawn up until the date and time for opening of the submissions. Any submission not so withdrawn shall, upon opening, constitute an irrevocable offer for a period of 120 days to the City of Knoxville for the services set forth in the Request for Proposals until one or more of the submissions have been duly accepted by the City.
- 4.11 Prior to submitting their proposals, proposers are to be registered with the Purchasing Division by setting up a Vendor Self-Service Account. Instructions for registering on-line are available at www.knoxvilletn.gov/purchasing. **Proposals from un-registered proposers may be rejected.**
- 4.12 **NO CONTACT POLICY:** After the posting of this solicitation to the Purchasing Division's website, any contact initiated by any proposer with any City of Knoxville representative concerning this proposal is strictly prohibited, unless such contact is made with the Purchasing Division representative listed herein or with said representative's authorization. Any unauthorized contact may cause the disqualification of the proposer from this procurement transaction. Proposals must include a notarized No Contact/No Advocacy Affidavit (to be found in the "Submission Forms" section of this document).
- 4.13 **INCLEMENT WEATHER:** During periods of inclement weather, the Purchasing Division will enact the following procedures with regard to solicitations and weather delays:
 - If City offices are closed due to inclement weather on the date that proposals/proposals/qualifications/letters of interest are due into the Purchasing Office, all solicitations due that same day will be moved to the next operational business day.
 - The City of Knoxville shall not be liable for any commercial carrier's decision regarding deliveries during inclement weather.
- 4.14 The successful proposer's pricing must be clear and complete. Any erasures, strikeovers, and/or changes to prices written in numerals should be initialed by the proposer. Failure to initial may be cause to reject the proposal as irregular and disqualified from consideration. All items required in the specifications must be included in the total proposal price. Any option prices must be clearly labeled as such so as not to be confused with the grand total.

V. Scope of Service

1. GENERAL

This special specification sets forth the minimum requirements for a camera for use with a Video Detection System (VDS) that monitors vehicles on a roadway via processing of video images and provides detector outputs to a traffic controller or similar device.

Definitions

Camera Assembly: The complete camera or optical device assembly used to collect the visual image. The camera assembly consists of a charged coupled device (CCD) camera, environmental enclosure, sun shield, and all necessary mounting hardware.

Live Video: Video output shall be 30 frames per second.

Lux: The unit of light intensity used to determine the minimum and maximum values of light in which a camera may operate.

2. FUNCTIONAL REQUIREMENTS

Provide CCTV Cameras in accordance with NTSC and EIA-170A. Conform the system limiting resolution to FCC regulations for broadcast signals. Provide clear, low-bloom and low-lag video pictures under all conditions from bright sunlight to nighttime scene illumination.

3. CAMERA ASSEMBLY

As a minimum, each camera shall be of solid state design and provide the following capabilities:

Provide a color camera. During night-mode, it may switch over to black and white for better contrast.

Images shall be produced with:

A Charge Coupled Device (CCD) sensing element with a horizontal resolution of 480 lines for black and white or 550 lines for color with a vertical resolution of 350 lines for black and white or color. Images shall be output as a video signal conforming to RS170 and NTSC or a Complementary Metal Oxide Semiconductor (CMOS) sensing element. This element shall output both digital 1080p and/or analog NTSC Broadband 1Vp-p video.

Useable video and resolvable features in the video image shall be produced when those features have luminance levels as low as 0.2 lux for black and white or as low as 1.0 lux for color for night use.

Useable video and resolvable features in the video image shall be produced when those features have luminance levels as high as 10,000 lux during the day. The camera must not sustain any permanent damage when pointed directly at strong light sources, including the sun, for brief periods of time.

The camera shall include an electronic shutter or auto-iris control based upon average scene luminance and shall be equipped with an electronic shutter or auto-iris.

The camera shall not incorporate any mechanically adjustable zoom or focus elements which can move out of adjustment over time due to vibration. Digital zoom is acceptable.

The camera and lens assembly shall be housed in an environmental enclosure that provides the following capabilities:

The enclosure shall be waterproof and dust tight to the latest NEMA 4 specifications.

The PCB's shall be conformally coated.

The camera and lens shall be capable of operating in all weather conditions and able to withstand wind load of 140 mph without permanent damage to mechanical and electrical equipment or loss of alignment. The camera shall be made of material and placed in a location that minimizes lightning strikes to it.

The camera's front lens cover shall be easily replaceable without the use of special tools or the loss of warranty.

The unit shall provide strain relief for all cables (AC, DC, Coax, and camera cables).

The camera will be designed so as to allow up to two cameras to be mounted on a single U Bracket. The camera shall also be capable of being mounted directly to a mast arm or luminaire pole by only using strapping material.

The enclosure shall allow the camera to operate satisfactorily over an ambient temperature range from -40F to 165F while exposed to precipitation as well as direct sunlight.

Input power to the environmental enclosure shall be nominally 115 VAC 60 Hz or 12 VDC to 28 VDC. The maximum power consumption under all conditions shall be 1.4W or less.

The camera enclosure shall also include a sun shield to minimize glare. The front edge of the sunshield shall protrude beyond the front edge of the environmental enclosure and shall include a provision to divert water flow to the sides of the sun shield.

All materials used in the enclosures and cables shall include ultra violet inhibitors.

When operating in the environmental enclosure with power and video signal cables connected, the image sensor shall meet FCC class B requirements for electromagnetic interference emissions.

The lens shall require very little cleaning. The camera lens shall not require cleaning more than once a year.

The camera shall not require a heater to keep the lens free from fog, ice and snow accumulations.

The camera shall provide digital optical masking capabilities to block bright lights (car hi beam vehicle headlights at night or during sunset/sunrise hi glare conditions).

The camera shall have Wide Dynamic Range (WDR) capabilities to further enhance performance under difficult lighting conditions.

The camera shall provide both analog and digital outputs.

The output from the camera enclosure shall be in accordance with NTSC and EIA-170A.

Connections for both video and power shall be made to the image sensor using a standard quick disconnect connectors. The coaxial cable termination shall be a standard BNC while the power and ground connectors shall be able to accommodate 14 - 22 gauge solid or stranded cable. The connectors themselves (coaxial and power) shall be fully enclosed inside a weatherproof traffic signal housing (NEMA-4 enclosure) with strain reliefs to protect against premature failure due to wind, vibration, hail, snow, ice, water or other weather related elements.

All connections shall enter the NEMA-4 enclosure from the bottom of the enclosures to reduce the chance of water leakage into the enclosures.

There will be an option to connect the coax cable to the camera without the use of a BNC connector.

The connection between the image sensor and the VDS processor unit is a coaxial cable. The coaxial cable used shall be a low loss, 75 ohm, precision video cable suited for outdoor installation, such as Belden 8281.

The camera shall meet TS2 cabinet specifications for both environmental and electrical performance

The power supply shall be rated at least five (5) times greater than the power requirement of the camera.

Surge protection shall utilize a triple stage hybrid including a gas tube to withstand up to 20kA of surge. Sneak and fault currents shall be addressed by resettable fuses.

The total weight of the camera in the environmental enclosure shall be two (2) pounds or less.

4. VDS REQUIREMENTS

As a minimum, each VDS card shall be of solid state design and provide the following capabilities:

Four (4) outputs per card with capabilities of sixteen (16) outputs per card via a SDLC

option.

SDLC shall be available in either a slide in card or stand alone module.

The SDLC module shall be able to support up to six (6) cameras and 96 outputs.

The slide in SDLC card shall provide quad video output of both raw video and video detection overlay.

The slide in SDLC card shall be able to support up to eight (8) cameras and 128 outputs.

An expansion card shall also be available to provide an additional four (4) outputs per card.

The expansion card can be daisy chained to provide up to 16 outputs.

NEMA TS1/TS2, ATC and 170/2070 cabinet compatible.

The system must be capable of recording traffic data in low light conditions.

Advanced detection capabilities up to 1,000 feet while simultaneously performing stop bar detection and left hand turn counts plus total vehicle counts from a single camera.

Presence, speed, and volume capabilities.

Reports shall be created from selection criteria of time frames, speeds, volumes, turning movements, and counts. Reports must be in Microsoft Excel® or Adobe Acrobat PDF® formats.

Set up via USB mouse and monitor or laptop PC (at the intersection or remotely at a TMC/TOC).

Field upgradeable software via a USB thumb drive.

Ability to store two (2) weeks of vehicle counts and queue data in 15 minute increments, then download up to four (4) approaches from a single Ethernet IP address from the TMC/TOC or laptop PC.

Capable of queue data to 600 ft.

Analog NTSC, Ethernet and digital outputs.

With the Ethernet option, the card shall be capable of being monitored, adjusted and set up remotely at a TMC/TOC.

Single or dual channel video input cards.

Up to thirty (30) detection zones per card.

Meets TS2 Electrical/Environmental cabinet specs.

5. ADDITIONAL FUNCTIONALITY

A surge suppression panel will provide Edco CX06-M surge protectors or equivalent.

Each camera power feed shall have a switch to control the individual power to each camera independent of the other cameras at the intersection.

Surge suppression and a circuit breaker shall also be incorporated into the power termination panel.

Additional sensors/features shall be capable of being added to the camera sensor platform for further functionality.

A Power Line Modem (PLM) to eliminate the need for the pulling of the power or coaxial cable for communications back to the cabinet. The system shall require the use of the neutral wire and a spare unshielded wire. The output of the PLM shall be either NTSC analog video or digital.

The PLM shall meet FCC Part 15 Carrier Current Device, specifications. The unit shall operate on standard 120V AC wires already available in the intersection.

6. INSTALLATION AND TRAINING

The supplier of the video camera shall supervise the installation and testing of the video

and computer equipment. If requested, a factory certified representative from the supplier shall be on site during installation.

Up to two (2) days of training shall be provided to personnel in the operation, setup, and maintenance of the camera. Instruction and materials shall be provided for a maximum of 20 persons and shall be conducted at a location selected by the City.

Instruction personnel are required to be certified by the equipment manufacturer. The User's Guide is not an adequate substitute for practical, classroom training, and formal certification by an approved agency. The supplier shall also provide installation and training material on their website.

7 WARRANTY, MAINTENANCE AND SUPPORT

The camera shall be warranted to be free of defects in material and workmanship for a period of three (3) years from date of shipment from the supplier's facility. During the warranty period, the supplier shall repair with new or refurbished materials, or replace at no charge, any product containing a warranty defect. Product repair or replaced under warranty by the supplier will be returned with transportation prepaid.

During the warranty period, technical support shall be available from the supplier via telephone within four (4) hours of the time a call is made by a user, and this support shall be available from factory certified personnel or factory certified installers.

The supplier shall maintain a program for technical support and software updates following expiration of the warranty period. This program shall be made available to the City of Knoxville for the duration of the contract. Vendor shall provide a price for extended warranty.

The supplier shall maintain an adequate inventory of parts to support maintenance and repair of the cameras.

Each unit shall be permanently labeled with Serial Number, Model Number, and Date Code. If the Date Code is incorporated in the Serial Number, the Date Code may be omitted.

Product Demonstration (1 system to demo for 60 days)

As a part of the evaluation process and prior to an award, **selected** vendors shall participate in an on-street demonstration of their product; on-street demonstration must meet the requirements set forth in this proposal. Demonstration units must be new equipment of the same type/model offered in the proposal. The location and extent of the physical installations for the demonstration will be subject to approval by City Engineering, but the installations and maintenance are to be conducted under the supervision of the vendor and vendor personnel.

- 1. Selected vendors shall provide a minimum of one (1) unit but no more than two (2) units (as directed by the City of Knoxville) at a location determined by the City of Knoxville.
- 2. Selected vendors shall provide a complete system including any hardware, software, cables, and cabinet interface. In addition, technical support shall also be provided by the Vendor to the City of Knoxville.
- 3. The minimal demonstration period shall be at least 60 days, with the possibility of a 30 day extension.
- 4. Selected vendors shall be prepared to coordinate full technical support, via the Purchasing Office, with the City's Information Systems, Engineering, Purchasing, Legal, and Finance Departments.

5. All elements of product demonstration (to include cost of shipping) shall be conducted at no cost to the City.

VI. Contract Requirements

Submitting entities, if selected, must be willing to sign a contract with the City which will include certain provisions, among which are the following:

- 6.1 Contract Documents. The contract shall consist of (1) the RFP; (2) the proposal submitted by the contractor to this RFP; and (3) the contract. In the event of a discrepancy between the contract, the RFP and the submitted proposal, the terms that provide the greater benefit to the City and/or impose the greater obligation to the contractor will prevail.
- 6.2 Administration. The contract will be administered by the City of Knoxville Engineering Department.
- 6.3 Invoices. Invoices for services will be submitted to the City in accordance with the contract terms.
- 6.4 Independent Contractor. The relationship of contractor to the City will be that of independent contractor. The contractor will be solely and entirely responsible for its acts and for the acts of its agents, employees, servants and subcontractors done during the performance of the contract. All services performed by the contractor shall be provided in an independent contractor capacity and not in the capacity of officers, agents, or employees of the City.
- 6.5 Assignment. The contractor shall not assign or transfer any interest in this contract without prior written consent of the City of Knoxville.
- 6.6 Indemnification and Hold Harmless. The successful proposer will be required to sign a contract with the City which contains the following indemnification clause. This indemnification clause will not be altered in any way. Failure to agree with this indemnification clause in the contract may result in the City moving to the next responsible responsive proposer.

Contractor shall defend, indemnify and hold harmless the City, its officers, employees and agents from any and all liabilities which may accrue against the City, its officers, employees and agents or any third party for any and all lawsuits, claims, demands, losses or damages alleged to have arisen from an act or omission of Contractor in performance of this Agreement or from Contractor's failure to perform this Agreement using ordinary care and skill, except where such injury, damage, or loss was caused by the sole negligence of the City, its agents or employees.

Contractor shall save, indemnify and hold the City harmless from the cost of the defense of any claim, demand, suit or cause of action made or brought against the City alleging liability referenced above, including, but not limited to, costs, fees, attorney fees, and other expenses of any kind whatsoever arising in connection with the defense of the City; and Contractor shall assume and take over the defense of the City in any such claim, demand, suit, or cause of action upon written notice and demand for same by the City. Contractor will have the right to defend the City with counsel of its choice that is satisfactory to the City, and the City will provide

reasonable cooperation in the defense as Contractor may request. Contractor will not consent to the entry of any judgment or enter into any settlement with respect to an indemnified claim without the prior written consent of the City, such consent not to be unreasonably withheld or delayed. The City shall have the right to participate in the defense against the indemnified claims with counsel of its choice at its own expense.

Contractor shall save, indemnify and hold City harmless and pay judgments that shall be rendered in any such actions, suits, claims or demands against City alleging liability referenced above.

The indemnification and hold harmless provisions of this Agreement shall survive termination of the Agreement.

6.7 Termination. The City may terminate this Agreement at any time, with or without cause, by written notice of termination to the Contractor.

If the City terminates this Agreement, and such termination is not a result of a default by the Contractor, the Contractor shall be entitled to receive as its sole and exclusive remedy the following amounts from the City, and the City shall have no further or other obligations to the Contractor: the amount due to the Contractor for work executed through the date of termination, not including any future fees, profits, or other compensation or payments which the Contractor would have been entitled to receive if this Agreement had not been terminated.

The City may, by written notice of default to the Contractor, terminate the whole or any part of this Agreement if the Contractor fails to perform any provisions of this Agreement and does not cure such failure within a period of ten (10) days (or such longer period as the Purchasing Agent may authorize in writing) after receipt of said notice from the Purchasing Agent specifying such failure. If this Agreement is terminated in whole or in part for default, the City may procure, upon such terms and in such manner as the Purchasing Agent may deem appropriate, supplies or services similar to those terminated.

- 6.8 Insurance. When applicable and prior to the commencement of the contract, contractor must, at its sole expense, obtain and maintain in full force and effect for the duration of the Agreement and any extension hereof at least the following types and amounts of insurance for claims which may arise from or in connection with this Agreement. Contractor shall furnish the City of Knoxville with properly executed certificates of insurance which shall clearly evidence all insurance required by the City. All insurance must be underwritten by insurers with an A.M. Best rating of A-VIII or better. Such insurance shall be at a minimum the following:
 - A. **Commercial General Liability Insurance**; occurrence version commercial general liability insurance, and if necessary umbrella liability insurance, with a limit of not less than two million dollars each occurrence for bodily injury, personal injury, property damage, and products and completed operations. If such insurance contains a general aggregate limit, it shall apply separately to the work/location in this Agreement or be no less than \$3,000,000.

Such insurance shall:

- (a.) Contain or be endorsed to contain a provision that includes the City, its officials, officers, employees, and volunteers as additional insureds with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts, or equipment furnished in connection with such work or operations. The coverage shall contain no special limitations on the scope of its protection afforded to the above-listed insureds. Proof of additional insured status up to and including copies of endorsements and/or policy wording will be required.
- (b.) For any claims related to this project, Contractor's insurance coverage shall be primary insurance as respects the City, its officers, officials, officers, employees, and volunteers. Any insurance or self-insurance programs covering the City, its officials, officers, employees, and volunteers shall be excess of Contractor's insurance and shall not contribute with it.
- (c.) At the sole discretion of the City, dedicated limits of liability for this specific project may be required.
- B. **Automobile Liability Insurance**; including vehicles owned, hired, and nonowned, with a combined single limit of not less than \$1,000,000 each accident. Such insurance shall include coverage for loading and unloading hazards. Insurance shall contain or be endorsed to contain a provision that includes the City, its officials, officers, employees, and volunteers as additional insureds with respect to liability arising out of automobiles owned, leased, hired, or borrowed by or on behalf of Contractor.
- C. Workers' Compensation Insurance. Contractor shall maintain workers' compensation insurance with statutory limits as required by the State of Tennessee or other applicable laws and employers' liability insurance with limits of not less than \$500,000. Contractor shall require each of its subcontractors to provide Workers' Compensation for all of the latter's employees to be engaged in such work unless such employees are covered by Contractor's workers' compensation insurance coverage.

D. **Other Insurance Requirements.** Contractor shall:

- Prior to commencement of services, furnish the City with original certificates and amendatory endorsements effecting coverage required by this section and provide that such insurance shall not be cancelled, allowed to expire, or be materially reduced in coverage except on 30 days' prior written notice to the City Attorney of Knoxville; P.O. Box 1631; Knoxville, Tennessee 37901. Proof of policy provisions regarding notice of cancellation will be required.
- Upon the City's request, provide certified copies of endorsements and policies if requested by the City in lieu of or in addition to certificates of insurance. Copies of policies will only be requested when contracts are deemed to be extremely or uniquely hazardous, include a dollar amount that is significant to the overall budget of

the City or a City Department, or the coverage(s) may not follow standard insurance forms. A policy will only be requested after the City's Risk Manager has reviewed the contract and proof of coverage has been provided. Should the certificate of insurance refer to specific coverage wording or endorsements(s), proof of such policy wording or endorsement(s) will be required.

- Replace certificates, policies, and endorsements for any such insurance expiring prior to completion of services.
- Maintain such insurance from the time services commence until services are completed. Failure to maintain or renew coverage or to provide evidence of renewal may be treated by the City as a material breach of contract.
- If Contractor cannot procure insurance through an insurer having an A.M. Best rating of A-VIII, Contractor may, in the alternative, place such insurance with insurer licensed to do business in Tennessee and having A.M. Best Company ratings of no less than A. Modification of this standard may be considered upon appeal to the City Law Director.
- Require all subcontractors to maintain during the term of the Agreement Commercial General Liability insurance, Business Automobile Liability insurance, and Workers' Compensation/Employer's Liability insurance (unless subcontractor's employees are covered by Contractor's insurance) in the same manner as specified for Contractor. Contractor shall furnish subcontractors' certificates of insurance to the City without expense immediately upon request.
- <u>Large Deductibles</u>; <u>Self-Insured Retentions</u>. Any deductibles and/or self-insured retentions greater than \$50,000 must be disclosed to and approved by the City of Knoxville prior to the commencement of services. Use of large deductibles and/or self-insured retentions may require proof of financial ability as determined by the City.
- Waiver of Subrogation Required. The insurer shall agree to waive all rights of subrogation against the City, its officers, officials, and employees for losses arising from work performed by Contractor for the City. Proof of waiver of subrogation up to and including copies of endorsements and/or policy wording will be required.
- Occurrence Basis Requirement. All general liability policies must be written on an occurrence basis, unless the Risk Manager determines that a claims made basis is reasonable in the specific circumstance. Use of policies written on a claims made basis must be approved by the City. Risk Manager and retroactive dates and/or continuation dates must be provided to the City prior to commencement of any work performed. Professional Liability and Environmental Liability (Pollution Coverage) are most commonly written on a claims made basis and are generally acceptable in that form.
- 6.9 Ethical Standards. Attention of all firms is directed to the following provisions contained

in the Code of the City of Knoxville: Chapter 24, Article II, Section 24-33 entitled "Debts owed by persons receiving payments other than Salary;" Chapter 2, Article VIII, Division 11. the Contractor hereby takes notice of and affirms that it is not in violation of, or has not participated, and will not participate, in the violation of any of the following ethical standards prescribed by the Knoxville City Code:

A. <u>Section 2-1048</u>. <u>Conflict of Interest.</u>

It shall be unlawful for any employee of the City to participate, directly or indirectly, through decision, approval, disapproval, recommendation, preparation of any part of a purchase request, influencing the content of any specification or purchase standard, rendering of advice, investigation, auditing or otherwise, in any proceeding or application, request for ruling or other determination, claim or controversy or other matter pertaining to any contract or subcontract and any solicitation or proposal therefore, where to the employee's knowledge there is a financial interest possessed by:

- (1) the employee or the employee's immediate family;
- (2) A business other than a public agency in which the employee or member of the employee's immediate family serves as an officer, director, trustee, partner or employee; or
- (3) Any person or business with whom the employee or a member of the employee's immediate family is negotiating or has an arrangement concerning prospective employment.

B. <u>Section 2-1049</u>. <u>Receipt of Benefits from City Contracts by Council Members, Employees and Officers of the City</u>.

It shall be unlawful for any member of council, member of the board of education, officer or employee of the city to have or hold any interest in the profits or emoluments of any contract, job, work or service, either by himself or by another, directly or indirectly. Any such contract for a job, work or service for the city in which any member of council, member of the board of education, officer or employee has or holds any such interest is void.

C. Section 2-1050. Gratuities and Kickbacks Prohibited.

It is unlawful for any person to offer, give or agree to give to any person, while a City employee, or for any person, while a City employee, to solicit, demand, accept or agree to accept from another person, anything of a pecuniary value for or because of:

- (1) An official action taken, or to be taken, or which could be taken;
- (2) A legal duty performed, or to be performed, or which could be performed; or
- (3) A legal duty violated, or to be violated, or which could be violated by such person while a City employee.

Anything of nominal value shall be presumed not to constitute a gratuity under this section.

Kickbacks. It is unlawful for any payment, gratuity, or benefit to be made by or on behalf of a subcontractor or any person associated therewith as an inducement for the award of a subcontract or order.

D. Section 2-1051. Covenant Relating to Contingent Fees.

(a) Representation of Contractor. Every person, before being awarded a contract in

excess of ten thousand dollars (\$10,000.00) with the City, shall represent that no other person has been retained to solicit or secure the contract with the City upon an agreement or understanding for a commission, percentage, brokerage or contingent fee, except for bona fide employees or bona fide established commercial, selling agencies maintained by the person so representing for the purpose of securing business.

- (b) Intentional Violation Unlawful. The intentional violation of the representation specified in subsection (a) of this section is unlawful.
- E. <u>Section 2-1052</u>. <u>Restrictions on Employment of Present and Former City Employees</u>. Contemporaneous employment prohibited. It shall be unlawful for any City employee to become or be, while such employee, an employee of any party contracting with the particular department or agency in which the person is employed.

For violations of the ethical standards outlined in the Knoxville City Code, the City has the following remedies:

- (1) Oral or written warnings or reprimands;
- (2) Cancellation of transactions; and
- (3) Suspension or debarment from being a Contractor or subcontractor under City or City-funded contracts.

The value of anything transferred in violation of these ethical standards shall be recoverable by the City from such person. All procedures under this section shall be in accord with due process requirements, included but not limited to a right to notice and hearing prior to imposition of any cancellation, suspension or debarment from being a Contractor or subcontractor under a City contract.

- 6.10 Firms must comply with the President's Executive Order No. 11246 and 11375 which prohibit discrimination in employment regarding race, color, religion, sex or national origin. Firms must also comply with Title VI of the Civil Rights Act of 1964, Copeland Anti-Kick Back Act, the Contract Work Hours and Safety Standards Act, Section 402 of the Vietnam Veterans Adjustment Act of 1974, Section 503 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990, all of which are herein incorporated by reference.
- 6.11 Firms shall give consideration to the inclusion of minority firms or individuals in this project, and shall advise the City in this proposal of their efforts to do so.
- 6.12 Firms shall give consideration to the use of environmentally sustainable best practices, and shall advise the City in this submittal of qualifications of their efforts to do so.
- 6.13 Federal, State, and Local Requirements. Each submitting entity is responsible for full compliance with all laws, rules and regulations which may be applicable.
- 6.14 Licenses. Before a contract is signed by the City, the submitting entity, if selected, **must** provide the City Purchasing Division with a copy of its valid business license **or** with an affidavit explaining why it is exempt from the business licensure requirements of the City or

county in which it is headquartered. If a contract is signed, the contractor's business license shall be kept current throughout the duration of the contract, and the contractor shall inform the City of changes in its business name or location. The contractor must be a licensed professional as required by the state of Tennessee, see T.C.A. Sections 62-2-101 et. seq., for any services in this contract requiring such licensure.

- 6.15 Funding. The City's performance and obligation to pay under this contract is subject to funding contingent upon an annual appropriation.
- 6.16 Governing Law and Venue. This Agreement shall be governed by and construed in accordance with the substantive laws of the State of Tennessee and its conflict of laws provisions. Venue for any action arising between the City and the Contractor from the Agreement shall lie in Knox County, Tennessee.
- 6.17 Subcontracts to the Agreement. Contractor shall not enter into a subcontract for any of the services performed under this Agreement without obtaining the prior written approval of the City.
- 6.18 Amendments. This Agreement may be modified only by a written amendment or addendum that has been executed and approved by the appropriate officials shown on the signature page of the Agreement.
- 6.19 Captions. The captions appearing in the Agreement are for convenience only and are not a part of the Agreement; they do not in any way limit or amplify the provisions of the Agreement.
- 6.20 Severability. If any provision of the Agreement is determined to be unenforceable or invalid, such determination shall not affect the validity of the other provisions contained in the Agreement. Failure to enforce any provision of the Agreement does not affect the rights of the parties to enforce such provision in another circumstance, nor does it affect the rights of the parties to enforce any other provision of this Agreement at any time.
- 6.21 No Benefit for Third Parties. The services to be performed by the Contractor pursuant to the Agreement with the City are intended solely for the benefit of the City, and no benefit is conferred hereby, nor is any contractual relationship established herewith, upon or with any person or entity not a party to the Agreement. No such person or entity shall be entitled to rely on the Contractor's performance of its services hereunder, and no right to assert a claim against the City or the Contractor, its officers, employees, agents, or contractors shall accrue to the Contractor or to any subcontractors, independently retained professional consultant, supplier, fabricator, manufacturer, lender, tenant, insurer, surety, or any other third party as a result of this Agreement or the performance or non-performance of the Contractor's services hereunder.
- 6.22 Non-Reliance of Parties. Parties explicitly agree that they have not relied upon any earlier or outside representations other than what has been included in the Agreement. Furthermore, neither party has been induced to enter into this Agreement by anything other than the specific written terms set forth herein.

- 6.23 Force Majeure. Neither party shall be liable to the other for any delay or failure to perform any of the services or obligations set forth in this Agreement due to causes beyond its reasonable control, and performance times shall be considered extended for a period of time equivalent to the time lost because of such delay plus a reasonable period of time to allow the parties to recommence performance of their respective obligations hereunder. Should a circumstance of force majeure last more than ninety (90) days, either party may by written notice to the other terminate this Agreement. The term "force majeure" as used herein shall means the following: acts of God; strikes, lockouts or other industrial disturbances; acts of public enemies; orders or restraints of any kind of the government of the United States or of the State or any of their departments, agencies or officials, or any civil or military authority; insurrections, riots, landslides, earthquakes, fires, storms, tornadoes, droughts, floods, explosions, breakage or accident to machinery, transmission pipes or canals; or any other cause or event not reasonably within the control of either party.
- 6.24 EEO/AA. The City of Knoxville is an EE/AA/Title VI/Section 504/ADA/ADEA Employer.
- 6.25 By submitting a proposal, the submitting entity agrees to all terms and conditions established in this RFP, including its contract requirements.

VII. Instructions to Submitting Entities

All submissions of proposals shall comply with the following instructions. These instructions ensure that (1) submissions contain the information and documents required by the City RFP and (2) the submissions have a degree of uniformity to facilitate evaluation.

7.1 General

7.2 Submission Information

Proposals shall include **seven (7) hard copies** (one original and six duplicates—**mark the original as such**) and one electronic copy of the proposal (.pdf format on CD only—**mark the storage device with the company name**); the electronic version shall be an exact duplicate of the original, and the electronic version will be the official document exhibited in the contract.

Electronic submissions must be included with the sealed submissions; do not email your submission.

IMPORTANT NOTE: A minimum of one of the submitted proposals <u>must</u> bear an original signature, signed in ink (duplicated signatures substituted for original ink signatures may result in rejection of the proposals). This document is the official, original submission; the required copies may have copied signatures. The signature must be entered above the typed or printed name and title of the signer. Proposers are reminded that the Purchasing Division receives many proposals and proposals for any number of solicitations; unlabeled submissions are extremely difficult to match to their appropriate solicitations and therefore may be rejected.

Any proposals received after the time and date on the cover sheet will not be considered. It shall be the sole responsibility of the submitting entity to have the proposal delivered to the City of Knoxville Purchasing Division on or before that date.

Late proposals will not be considered. Proposals that arrive late due to the fault of United States Postal Service, United Parcel Service, DHL, FEDEX, any delivery/courier service, or any other carrier of any sort are still considered late and shall not be accepted by the City. 7.3 Format

7.4 Evaluation of Proposals

All qualified submissions received by the deadline will be analyzed by the Evaluation Committee according to the criteria outlined in these specifications. Failure to comply with the provisions of the RFP may cause any proposal to be ineligible for evaluation. Each submittal of proposals will be initially analyzed and judged according to the evaluation criteria below. The maximum score is 100 points.

The City reserves full discretion to determine the capability of proposing entities. Proposers, if asked, will provide, in a timely manner, any and all information that the City deems necessary to make such a decision. In addition to materials provided in the written responses to this RFP, the Committee may request additional material, information, references, a site visit, or a live test demonstration from the submitting entity or others.

The Evaluation Committee may or may not decide to interview any or all proposing entities at a time and date determined by the City in order to address questions and more fully ascertain how the solution to this project satisfies the evaluation criteria. Firms and/or teams responding to this Request for Proposals shall be available for interviews with the Evaluation Committee. Discussions may be conducted with responsible submitting entities for purposes of clarification to assure full understanding of and conformance to the RFP requirements. Selection shall be based on the firms' qualifications applicable to the scope and nature of the services to be performed per this request for proposals. Determination of firms' qualifications shall be based on their written responses to this Request for Proposals and information presented to the Evaluation Committee during oral interviews, if any.

In addition to materials provided in the written responses to this Request for Proposals, the Committee may request additional material, information, or references from the submitting entity or others.

Provided it is in the best interest of the City of Knoxville, the firm or team determined to be the most responsive to the City of Knoxville, taking into consideration the evaluation factors set forth in this Request for Proposals, will be selected to begin contract negotiations. The firm or team selected will be notified at the earliest practical date and invited to submit more comprehensive information if necessary. If no satisfactory agreement can be reached with the "most responsive firm," the City may elect to negotiate with the next best and most responsive firm or team.

7.5 Evaluation of Product (Product Demonstration Evaluation)

As a part of the evaluation process and prior to an award, **selected** vendors shall participate in an on-street demonstration of their product; on-street demonstration must meet the requirements set forth in this proposal. Demonstration units must be new equipment of the same type/model offered in the proposal. At the conclusion of the 60 day demonstration period, products will be evaluated based on a set of specific criteria. The maximum score for product performance is 50 points.

VIII. Evaluation Criteria

An evaluation team, composed of representatives of the City, will evaluate **proposals** on a variety of quantitative and qualitative criteria. Upon receipt of proposals, the City will review to determine whether the proposal is acceptable or non-acceptable based on the criteria outlined below. The criteria and the associated weights upon which the evaluation of the proposals will be based include, but are not limited to, the following:

- 1. Quality and Functionality 40 points: Product proposed that best addresses the City's needs for reliable detection and advanced features. Durability, reliability, features, and functionalities of the proposed product. Vendor's process for providing upgrades to the system. Design, capability, and functionality of the proposed product.
- 2. **Pricing/Cost 30 points:** Proposer shall provide cost of proposed products to include shipping, training, implementation/installation, on-going support, required warranty, extended warranties, and maintenance.
- 3. Experience, Resources, and Implementation 30 points: Proposal shall include information regarding same product installations at locations similar in size and traffic frequency as the City of Knoxville. Proposer must include contact information (contact name, job title, government location, phone number, and email address) for, no less than, three (3) references similar in size to the City of Knoxville. The City will take into consideration the quality, relevance, and number of references; the level of service and responsiveness that the vendor commits to its clients; the amount and extent of user and technical support training; level of assistance provided by the Vendor during the implementation process to users; and any additional information provided to the City by references and users of Vendor's products and services.

Based on the evaluation of proposals, **selected** vendors will be asked to participate in product demonstration. Selected proposers shall provide a model to be evaluated for a time period of 60 days. At the conclusion of the demonstration period, the City will evaluate **product** performance. The criteria and the associated weights upon which the evaluation of the product performance will be based include, but are not limited to, the following:

<u>Service Disabled Veteran-owned business</u> (SDOV) is a continuing, independent, for profit business that performs a commercially useful function, owned by any person who served honorably on active duty in the armed forces of the United States with at least a twenty percent (20%) disability that is service connected. Meaning such disability was incurred or aggravated in the line of duty in the active military, naval or air service, and is at least fifty-one percent (51%) owned and controlled by one (1) or more service disabled veteran.

<u>Small Business</u> (SB) is a continuing, independent, for profit business which performs a commercially useful function and has total gross receipts of not more than ten million dollars (\$10,000,000) average over a three-year period or employs no more than ninety-nine (99) persons on a full-time basis.
