PROJECT DESCRIPTION

The proposed improvements on Conference Drive at Mission Ridge Drive have been planned by the City of Goodlettsville to improve the form and function along with the overall amenity of the project area. The project will rehabilitate sidewalks, landscaping, and crosswalks and create an enhanced entry point into the City of Goodlettsville.

This project will include work at the intersection of Conference Drive and Mission Ridge Drive with a total project length of 320 feet. The project will include the establishment of an island on the south side of the intersection creating a pedestrian safe-haven as well as modifying the existing median on the north side of the intersection. Each median will have improved landscaping along with additional plantings around the outside of the new sidewalks.

There is an existing city welcome sign in the northern median of the intersection. The sign itself will be reused and re-mounted on a proposed freestanding masonry wall and columns
