- Must have a storefront operation within 30 miles of the Williamson County Sheriff's Office at 408 Century Ct., Franklin, TN 37064
- Must include 3 references and their contact information with their bid.
- Must have an in-house seamstress on duty for needed same day alterations.
- Must have a tracking system for all orders. They would need to be able to tell us what items were ordered and what items are on back order.
- Key items must be delivered within 10 business days. The requirements cover breach of contract
 or reimbursement to the Sheriff's Office for the difference, in cost of the key items, should the
 items exceed the successful bidder's price.
- If there is an immediate need and the contracted vendor cannot supply an item immediately,
 Williamson County reserves the right to purchase those items from another vendor without violating the agreement.
- This contract will be a one year term with an option to renew for up to four additional one year terms. Renewals shall be at the discretion of Williamson County.
- The Successful bidder shall provide the Williamson County Sheriff's Office with the name of the person who will represent the bidder in the administration of the Agreement. The person must be within the level of management capable of acting without recourse in making decisions regarding the obligations and terms provided in the Agreement.

This Agreement incorporates the following documents by reference and made a part hereof:

Bid Specification Vendor's Bid Certificate of Insurance Affidavits

In the event of conflicting provisions, all documents shall be construed according to the following priorities: any properly executed amendment or change order to this Agreement (most recent with first priority); this Agreement; Bid Specifications; Vendor's Bid.

ARTICLE I VENDOR'S DUTIES

In addition to any and all other duties, obligations, and responsibilities of the Vendor, the Vendor shall have and perform the following duties, obligations, and responsibilities at Vendor's expense:

- A. The Vendor shall rent uniforms to the County that meet or exceed the specifications provided in the bidding specifications contained in the bid request documents to the location and in the manner specified by the County. The uniforms shall not be considered accepted by the County until such time that the County has had an opportunity to inspect the uniforms;
- B. Vendor warrants that the uniforms and related services shall strictly conform to the requirements of this Agreement;
- C. The Vendor shall strictly supervise the services and bear full responsibility for any and all acts or omissions of those engaged in the provision of uniforms or related services on behalf of the Vendor;
- D. The Vendor hereby warrants that the labor furnished under this Agreement shall be competent to perform the tasks undertaken, that the uniforms and other materials provided shall be of high quality, and will strictly comply with the requirements of this Agreement. Any uniforms or services provided hereunder not strictly complying with the requirements of this Agreement shall constitute a breach of the Vendor's warranty;
- E. Vendor shall be responsible for the cost of storing, moving, and transporting the uniforms and other materials.
- F. Vendor shall provide the uniforms at the location and within the time specified by the County.
- G. SUBSTITUTIONS FOR THE UNIFORMS LISTED IN THE LIST PROVIDED BY COUNTY IN ITS BID PACKAGE ARE NOT PERMITTED UNLESS EXPRESSLY APPROVED BY COUNTY IN WRITING PRIOR TO DELIVERY.

ARTICLE II TERM AND TERMINATION

A. Term. The initial term of this Agreement shall begin on July 1, 2018 and shall extend to June 30, 2019 unless otherwise terminated or extended as provided herein. This Agreement may be extended if agreed in writing by the parties. The option to extend shall be exercised and in the discretion of the Williamson County Mayor. To be effective, any extension must be approved by the County's Attorney and the Purchasing Agent and signed by the Williamson County Mayor. In no event shall the term of this Agreement extend beyond five (5) years.

B. Termination.

1. Termination - Breach. Should Vendor fail to fulfill in a timely and proper manner its obligations under this Agreement or if it should violate any of the terms of this Agreement, County shall have the right to immediately terminate this Agreement. Such termination shall not relieve Vendor of any liability to County for damages sustained by virtue of any breach by Vendor.

2. Termination - Funding. Should the County's legislative body fail to fund the provision of the uniforms or related services, County shall have the right to terminate this Agreement

immediately upon written notice to the Vendor.

3. Termination - Notice. Either party may terminate this Agreement at any time upon the provision of thirty (30) days written notice to the other party.

Termination - Agreement. The parties may terminate this Agreement at any time by

written agreement.

5. Termination - Bankruptcy. County may terminate this Agreement if Vendor, or any successor or assignee of Vendor, shall file a petition in bankruptcy or insolvency or for reorganization under any bankruptcy act, or shall voluntarily take advantage of any such act or shall make assignment for the benefit of creditors or if involuntary proceedings under any bankruptcy laws or insolvency act shall be instituted against Vendor, or if a receiver or trustee shall be appointed for all or substantially all of the property of Vendor, and such proceedings shall not be dismissed or the receivership or trusteeship vacated within sixty (60) days after the institution or appointment.

ARTICLE III FEE – FIXED PRICE

A. Williamson County shall pay and the Vendor shall accept, as full and complete payment for the Vendor's provision of the uniforms and the timely performance of its obligations hereunder, the fees as defined in the Vendor's bid response which is attached hereto and made a part of this Agreement, less any disputed fees. The fee shall not be modified except by written agreement signed by both parties.

B. Neither payment to the Vendor nor acceptance of the goods by the County, nor any other act or omission by the County shall be interpreted or construed as an acceptance of any uniforms provided hereunder that are not strictly in compliance with the type and make of the uniforms provided in the bid

specifications which is part of this Agreement.

- C. In addition to all other rights available to the County, the County shall have the right to refuse to make payment and, if necessary, may demand the return of a portion previously paid to the Vendor due to:
 - 1. The quality or quantity of uniforms not being in accordance with the requirements of this Agreement;

Loss caused by the Vendor or while acting on behalf of the Vendor; or

3. The Vendor's failure or refusal to perform any of its obligations to Williamson County.

D. In the event that County makes written demand upon the Vendor for amounts previously paid by Williamson County as contemplated in this Article, the Vendor shall promptly comply with such demand,

E. If within forty-five (45) days from the date payment to the Vendor is due, Williamson County, without cause or basis hereunder, fails to pay the Vendor any undisputed amount then due and payable to the Vendor, the Vendor shall have the right to cease providing the uniforms until receipt of proper payment after first providing thirty (30) days written notice to the County of the Vendor's intent to cease the provision of the uniforms.

ARTICLE IV REPRESENTATIONS OF THE VENDOR

- A. In order to induce County to execute this Agreement and recognizing that the County is relying thereon, the Vendor, by executing this Agreement, makes the following express representations to Williamson County:
 - 1. It is fully qualified to act as the vendor and has, and shall maintain, all licenses, permits, or other authorizations necessary to act as the vendor to provide the uniforms and all related services required by this Agreement;

2. It is not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from covered transactions by any Federal Department, State Department or

local department;

3. It has not, within a three (3) year period preceding this Agreement, been convicted of or had a civil judgment rendered against it for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, State or local) transaction or contract under a public transaction; violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;

It is not presently indicted for or otherwise criminally or civilly charged by a

governmental entity (Federal, State or local) with commission of other similar crimes;

5. It has not within a three (3) year period preceding this application/proposal had one or more public transactions (Federal, State or local) terminated for cause or default;

6. It will comply with all Federal, State, and local governmental laws, rules, and regulations relating to its responsibilities, as set forth in the bid specification; and

It does not have any delinquent business taxes

ARTICLE V ETHICAL STANDARDS

A. It shall be a breach of ethical standards for any person to offer, give, or agree to give any Williamson County employee or former Williamson County employee, or for any Williamson County employee or former Williamson County employee to solicit, demand, accept, or agree to accept from another person, a gratuity or an offer of employment in connection with any decision, approval, disapproval, recommendation, preparation of any part of a program requirement or a purchase request, influencing the content of any specification or procurement standard, rendering of advice, investigation, auditing or in any other advisory capacity in any proceeding or application, request for ruling, determination, claim or controversy or other particular matter, pertaining to any program requirement or a contract or subcontract or to any solicitation or proposal therefor.

B. It shall also be a breach of ethical standards for any payment, gratuity, or offer of employment to be made by or on behalf of a subcontractor under a contract to the Vendor or higher tier subcontractor or

any person associated therewith, as an inducement for the award of a subcontract or order.

C. It shall also be a breach of ethical standards for a person to be retained, or to retain a person, to solicit or to secure a contract with Williamson County upon the agreement or understanding for a contingent commission, percentage, or brokerage fee, except for the retention of bona fide employees or bona fide established commercial selling agencies for the purpose of securing business.

D. The Vendor affirms that it has not retained anyone in violation of this Article V. A breach of ethical standards is a material breach of this Agreement and could result in civil or criminal sanctions and debarment or suspension from being a contractor or subcontractor under contracts with the County.

ARTICLE VI INDEMNIFICATION AND HOLD HARMLESS

- A. Vendor shall indemnify and hold harmless Williamson County, its officers, agents and employees from:
 - 1. Any claims, damages, costs and attorney fees for injuries or damages arising, in part or in whole, from the negligent or intentional acts or omissions of Vendor, its officers, employees and/or agents, including its sub or independent contractors, in connection with the performance of the Agreement;

2. Any claims, damages, penalties, costs and attorney fees arising from any failure of Vendor, its officers, employees and/or agents, including its sub or independent contractors, to observe applicable laws including, but not limited to, copyright laws, labor laws, and minimum

wage laws; and

3. Any claims, damages, penalties, costs and attorney fees arising from any action brought against Williamson County by any of Vendor's officers, employees and/or agents arising out of any injury incurred by such officer, employee and/or agent in the course of the performance of this Agreement, regardless of the cause of such injury.

B. Williamson County will not indemnify, defend or hold harmless in any fashion the Vendor from any claims arising from any failure, regardless of any language in any attachment or other document that the Vendor may provide.

Vendor shall pay Williamson County any expenses incurred as a result of Vendor's failure to fulfill

any obligation in a professional and timely manner under this Agreement.

ARTICLE VII INSURANCE REQUIREMENTS

- Without limiting its liability under this Agreement, the Vendor will procure and maintain at his/her expense during the life of this Agreement any/all applicable insurance types and in the minimum amounts stated as follows:
 - 1. General Liability Must be on an Occurrence Form, Claims Made is Not Acceptable, and will include:

a) Per Occurrence limit of not less than \$ 1,000,000 b) General Aggregate will not be less than \$ 2,000,000

- Medical Expense Limit will not be less than \$5,000 on any one person. c)
- d) Completed Operations, including on-going operations in favor of the Additional Insured

e) Contractual Liability

2. Business Auto Liability (including owned, non-owned and hired vehicles)

Combined Single Limit \$ 1,000,000 or a)

b) Split Limit:

Bodily Injury:

4. Workers Compensation

The Commercial General Liability policy will name Williamson County Government as an Additional Insured with respect to this Agreement only. Said insurance will be written by a company or companies licensed to do business in the State of Tennessee and satisfactory to Williamson County Government Risk Management. Before commencing any work hereunder, a Certificate of Insurance evidencing the maintenance of said insurance will be furnished to Williamson County Government Risk Management. All insurance provided by Vendor or Vendor's subcontractors in compliance with this Agreement shall be primary as to any other insurance or self-insurance programs afforded to or maintained by County.

ARTICLE VIII GENERAL PROVISIONS

Resolution by Court of Law, Non-binding Mediation. Claims, disputes, or other matters in question between the parties to this Agreement arising out of or relating to this Agreement or breach thereof, shall be subject to and decided by a court of law. The parties can agree to non-binding mediation prior to litigation.

B. Arbitration. Any arbitration clause included in this Agreement or any other documentation related to this Agreement is void.

Choice of Law. The validity, construction and effect of this Agreement and any and all extensions C. and/or modifications thereof shall be exclusively governed by the laws of the State of Tennessee.

Tennessee law shall govern regardless of any language in any attachment or other document that the Vendor may provide

D. Venue. Any action between the parties arising from this Agreement shall be exclusively maintained in the courts of Williamson County, Tennessee.

E. Attorney Fees. Vendor agrees that, in the event either party deems it necessary to take legal action to enforce any provisions of this Agreement, and in the event County prevails, Vendor shall pay all expenses of such action including attorney fees and court costs at all stages of litigation.

F. Notices.

1. <u>Delivery</u>. Except as otherwise provided herein, any notice or other communication between the parties regarding the matters contemplated by this Agreement may be sent by United States mail (first class, airmail or express mail), commercial courier, facsimile or electronic mail,

in each case delivered to the address set forth below for the recipient.

2. Receipt. Communications shall be deemed received, if by mail, on the earlier of receipt or the third calendar day after deposit in the mail with postage prepaid; if by courier, when delivered as evidenced by the courier's records; if by facsimile, upon confirmation of receipt by the sending telecopier; and if by electronic mail, when first available on the recipient's mail server. If received on a day other than a business day, or on a business day but after 4:30 p.m., recipient's local time, the communication will be deemed received at 9:00 a.m. the next business day.

G. Assignment. The provisions of this Agreement shall inure to the benefit of and be binding upon the respective successors and assignees of the parties hereto. Assignment of this Agreement or any of the rights and obligations of Vendor hereunder, in whole or in part, requires the prior written consent of County. Any such assignment shall not release Vendor from its obligations hereunder without the express written consent of County.

H. Limitation of Legal Avenues. County does not agree to any terms that limit its rights or opportunities to legal recourse in any way in a court of competent jurisdiction, including but not limited

to, modification of the statute of limitations or binding arbitration.

I. Tennessee Open Records Act. Vendor understands that County is subject to the Tennessee Open Records Act. This may require the County to provide requested documents to members of the public or press including, but not limited to, a copy of this Agreement. Compliance by County with the Open Records Act shall not be a breach of this Agreement.

J. Severability. Should any court of competent jurisdiction declare any provision of this Agreement invalid, then such provision shall be severed and shall not affect the validity of the remaining provisions of

this Agreement.

K. Entire Agreement. The complete understanding between the parties is set out in this Agreement, and this Agreement supersedes and voids all prior and contemporaneous understandings, proposals, letters, agreements, or conditions expressed or implied, oral or written, except as herein contained. Any amendment, modification, waiver, or discharge of any requirement of this Agreement will not be effective unless in writing signed by the parties hereto or by their authorized representatives.

L. Drug Free Work Place. If applicable, Vendor agrees to abide by all requirements set forth in Tennessee Code Annotated, Section 50-9-113, by establishing a drug free workplace program and to

execute the drug free affidavit, included herewith, evidencing Vendor's compliance.

M. Employment Practices. Vendor shall not subscribe to any personnel policy which permits or allows for the promotion, demotion, employment, dismissal or laying off of any individual due to race, creed, color, national origin, age, sex or which is in violation of applicable laws concerning the employment of individuals with disabilities. Vendor, if applicable, agrees to execute the Fair Employment Affidavit included in this Agreement evidencing Vendor's compliance of this policy.

N. Employment of Illegal Immigrants. The Vendor shall not knowingly hire any unauthorized employees or fail to comply with record keeping requirements set forth in the Federal Immigration Reform and Control Act of 1986, Chapter 878 of the 2006 Tennessee Public Acts and all other applicable

laws. Failure to comply with the requirements of these immigration laws or other applicable laws is considered a material breach of this Agreement and may lead to civil penalties and debarment or suspension from being a contractor or subcontractor under contracts with Williamson County."

O. Relationship Between the Parties. The relationship of the parties shall be that of an independent Vendor. No principal-agent or employer-employee relationship is created by this Agreement. The parties hereto shall not hold itself out in a manner contrary to the terms of this paragraph. No party shall become liable for any representation, act or omission of any other party contrary to the terms of this paragraph.

P. Authority of a Governmental Entity. Williamson County cannot agree to any terms which limit its rights or opportunities to legal recourse in a court of competent jurisdiction, including but not limited to, modification of the statute of limitations or binding arbitration. To limit the legal rights of Williamson County granted by constitution or statute, may require legislation by the Williamson County Board of Commissioners and/or the Tennessee State Legislature. Any limitation described in this paragraph included in this Agreement or any other document provided for the Vendor is void.

Q. Maintenance of Records. Vendor shall maintain documentation for all charges against Williamson County. The books, records and documents of the Vendor, insofar as they relate to the goods and services performed or money received under this Agreement, shall be maintained for a period of three (3) full years from the date of final payment and will be subject to audit, at any reasonable time and upon reasonable notice, by the Vendor or its duly appointed representatives. The books and records shall be maintained in accordance with generally accepted accounting principles.

R. Anti-Deficiency Clause. Nothing contained in this Agreement shall be construed as binding Williamson County to expend any sum in excess of appropriations made by its Legislative Body for the purposes of this Agreement, or as involving Williamson County in any contract or other obligation for the further expenditure of money in excess of such appropriations.

S. Time is of the Essence. Since the goods and services are funded by public money, the parties agree that time is of the essence for the provision of goods and the satisfactory completion of all services and within the time limitations defined by the County. Failure to provide goods or fully complete the services within the time limitations shall subject the Vendor to reduction of the fee paid to Vendor. This section does not limit any other remedy available to the County.

T. Conflicting Terms. The parties agree that should the language in this Agreement conflict with any language included in any documentation whether provided for by Vendor or not, then the language or terms of this Agreement shall be controlling.

U. Headings. The headings in this Agreement are for convenience and reference and are not intended to define or limit the scope of any provisions of this Agreement.

V. Effective Date. This Agreement shall not be binding upon the parties until it has been signed first by Vendor and then by the authorized representatives of the Williamson County government and has been filed in the office of the Williamson County Mayor. When it has been so signed and filed, this Agreement shall be effective as of the date first written above.
