Fleet Vehicle Tires and Associated Supplies

I. **PURPOSE**

The City of Chattanooga, Fleet Services Division is seeking bids from tire dealers and/or manufacturers for tires and associated for the purpose of contracting the supply of these commodities to Fleet Services at the lowest cost possible and with the highest service levels.

II. **BACKGROUND**

Currently, the City of Chattanooga operates two maintenance facilities, which include two full service tire shops. The tire shops, located at 12th and Park Avenue and Amnicola Highway, service a wide variety of vehicles ranging from small lawn tractors, automobiles, heavy trucks and large off-road equipment.

Some of these commodities are currently being purchased from various local vendors using provisions of the Tennessee State tire contract.

III. **SCOPE**

1. The selected contractor(s) shall supply all required tire sizes in the brand names currently listed. (see attached).
2. On occasion, the City will need to purchase tires not included on the list. Price discount percentage to be identical to listed tires.
3. The City of Chattanooga reserves the right to award to multiple contractors.
4. Contractor(s) to supply ITRA Training for four (4) technicians for five (5) days.

IV. **PERFORMANCE MEASURES**

1. The City of Chattanooga will require four-hour maximum delivery time for all tires used by Fleet Services that are currently maintained in Fleet inventory.
2. The City of Chattanooga will require a 48 hr. delivery for non-contract tires not maintained in Fleet inventory
3. If performance measures are not met, the City reserves the right to purchase tires elsewhere.
4. If performance measures are not met on a regular basis, the City reserves the right to void or set aside contract.
5. Annual and/or monthly tire usage reports shall be made available from selected contractor(s) to facilitate the meeting of performance measures.
6. All tires delivered will need to have a receipt and signature of acceptance.

V. ***CATALOGS***

Contract holders will be required to furnish copies of the Government Price Catalogs to Fleet Services Division and to Contract Administrator listed on bid document.

VI. ***PROOF OF TESTING AND QUALIFICATION***

Shall be required for Pursuit tires added to future catalogs as replacement for tires in current catalog.

Please list the required ply rating for Big Truck tires.

Please list the speed rating for the Emergency and Pursuit vehicle tires.

VII. ***PRODUCT SUBSTITUTION***

Substitutions shall require the approval of Fleet Services Division and the Contract Administrator listed on the bid document. Any products that do not meet specifications shall be returned to contractor at contractor's expense.

In all construction contracts or subcontracts in excess of \$10,000 to be performed for the City of Chattanooga, any contractor and/or subcontractor is further required to file in duplicate within ten (10) days of being notified that it is the lowest responsible bidder, an affirmative action plan with the EEO Director of the City of Chattanooga. This plan shall state the Contractor's goals for minority and women utilization as a percentage of the work force on this project.
5. This Plan or any attachments thereto shall further provide a list of all employees annotated by job function, race, and sex who are expected to be utilized on this project. This plan or attachment thereto shall further describe the methods by which the Contractor or Subcontractor will utilize to make good faith efforts at providing employment opportunities for minorities and women.

During the term of this contract, the Contractor upon request of the City, will make available for inspection by the City of Chattanooga copies of payroll records, personnel documents and similar records or documents that may be used to verify the Contractor's compliance with these Equal Opportunity provisions.

6. The Contractor will include the portion of the sentence immediately preceding paragraph 1 and the provisions of paragraphs 1 through 6 in every subcontract so that such provisions will be requested of each subcontractor. The Contractor agrees to notify the City of Chattanooga of any subcontractor who refuses or fails to comply with these equal opportunity provisions. Any failure or refusal to comply with these provisions the Contractor and/or Subcontractor shall be a breach of this contract.
