It is the intent of this Request for Quote to establish a term contract for routine and emergency repair services and or refurbishment of interior and exterior doors to be performed on an "as needed" basis.

The successful contractor shall perform, as needed, routine and emergency repair service and/or refurbishment of interior/exterior doors. All work shall be performed in accordance with the applicable manufacturer's recommended procedures.

Work required may include, but is not limited to, adjusting, repairing or replacing of doors, panic bar devices, closure devices, edge guards, door moldings, weather stripping, installation of protective panels to door jams/kick plates, and installation of floor mount and wall mount door stops and holders.

City buildings not included in the contract that require repair/refurbishment work similar to that specified in these bid documents may also utilize the contract using the bid prices.

The successful Contractor shall provide all materials, supplies, parts, tools, equipment, labor, supervision, transportation, and all other things necessary to perform the work required under this contract.

ROUTINE SERVICE

For bid purposes, work that does not constitute an emergency but should be completed as soon as possible to prevent possible damage to buildings and equipment or to eliminate inconvenience to building occupants shall be defined as routine service.

The successful contractor shall perform a service call within twenty-four (24) hours after being notified of the need for service and, upon receiving authorization from the City, shall perform the necessary repair(s)/refurbishment. Unless instructed otherwise by an authorized City representative, routine work shall be completed during normal working hours.

EMERGENCY SERVICE

For bid purposes, work required due to immediate safety hazards, security threats, inevitable damage to buildings and equipment or reduction in operational effectiveness shall be defined as emergency service.

The successful contractor shall respond on-site within four (4) hours after being notified of the need for emergency service and, upon receiving authorization from the City, shall perform the necessary repair(s)/refurbishment. The City shall bear the sole responsibility in determining what constitutes an emergency and the successful contractor shall respond on-site upon the City's request.

Emergency service completed during normal working hours in which the four (4) hour response time is not met shall be billed at the routine service hourly labor rate.

HOURLY LABOR RATES

Hourly labor rate bid prices shall be the hourly rate to perform routine and emergency repair service and or refurbishment and shall exclude only the cost of parts and materials.

All other applicable costs, including (but not limited to): supplies, tools, equipment, labor, supervision, delivery, loading/unloading, truck charges, mileage, travel time, per diem, fuel, fuel surcharges, energy surcharges, hazardous material handling fees, environmental impact fees, and waste disposal fees must be included in the hourly labor rate bid prices.
