

Shoulder:

- Installation of 2' Flexi-Pave shoulder along the Eastside Trail from Irwin Street to Monroe Drive.
- Contractor must be a certified Flexi-Pave installer.
- Lighting was recently installed along the corridor. Upon project award, contractor must field verify with ABI the exact area of flexi-pave shoulder.

# Scope of Work





#### Drainage:

- Existing drainage conditions at Drewry street are causing water to run off site, into the Midtown Promenade parking lot.
- Existing headwall at Drewry Street will be converted to a junction box.
- The new pipe crossing the trail will require a trail closure. A temporary detour must be constructed from gravel or mulch during the closure.
  - ABI will approve closures and detours
  - Advance notification of trail closures to the public
