The City of Parkland, Florida is seeking to obtain Bids from qualified contractors to furnish and install Irrigation Pump Stations specified or their equivalent according to the specifications. This also includes the removal and disposal of the existing pump stations, in accordance with the terms, conditions, and scope of services of this bid (ITB).

Sealed Bids will be received at the City of Parkland City Hall 6600 University Drive, Parkland, Florida, 33067, until 6/2/2020, 2:00PM local time, at which time they will be publicly opened and read. All Bidders or their representatives are invited to be present. Bids shall be delivered and addressed to, **City of Parkland, Attn: Jill Woods, Buyer, 6600 University Drive, Parkland, Florida 33067** and shall be labeled “SEALED BID FOR IRRIGATION PUMP STATION REPLACEMENT AT PINE TRAILS PARK”.

Any Bidder who wishes his/her bid to be considered is responsible for making certain that his/her bid is received in the City by the proper time. No oral, telegraphic, electronic, facsimile, or telephonic Bids or modifications will be considered unless specified. Bids received after the scheduled Bid Submittal Deadline will not be considered. It is the responsibility of the Bidder to see that any bid submitted shall have sufficient time to be received by the City before the Bid Submittal Deadline. Late Bids will be returned to the Bidder unopened.

Bidders must submit one (1) identified original copy, one (1) electronic copy (either CD/DVD or flash drive) and one (1) copy of the bid including any attachments with the submission. The bid shall be signed by a representative who is authorized to contractually bind the Bidder.

A pre-bid conference is scheduled for 5/12/2020 at 2:00 PM at the City of Parkland City Hall, 6600 University Drive, Parkland FL 33067. Attendance at the pre-bid conference is strongly encouraged. This information session presents an opportunity for the Bidders to clarify any concerns regarding the bid requirements and visit the site location. Although the pre-bid conference is optional, no modification or changes will be allowed because of the failure of the Bidder to have not visited the site or attend the conference and carefully review all available information. City staff will only be available to show the site at the time of the scheduled appointment, otherwise, vendors can visit the site locations at their own convenience.

Typically, such meetings last one hour or less, though such is not guaranteed. The purpose of this meeting is to assist prospective Bidders to have a full understanding of the ITB documents so that he/she feels confident in submitting an appropriate bid; therefore, at this conference the City will conduct a brief overview of the ITB documents, including the attachments. Prospective Bidders may also ask questions, though the City may require that such questions are delivered in writing prior to a response being delivered. Whereas the purpose of this meeting is to review the ITB documents, attendees should have their copy of the ITB documents available at the time of this conference.

To protect public health and mitigate the risk of the spread of Coronavirus, the City of Parkland City Hall will remain closed to the public but public participation shall be permitted utilizing communications media technology in the manner provided for below and in accordance with the Governor's Executive Order #20-69.

On March 20, 2020, Governor DeSantis issued Executive Order #20-69 suspending any Florida Statute that requires a quorum to be present in person or requires a local government body to meet at a specific public place. The Order further allows for local government bodies to utilize communications media technology, such as telephonic and video conferencing.. The City Commission has adopted Resolution 2020-016, authorizing the City to hold meetings through the use of communications meeting technology. **SECTION 1 - INTRODUCTION AND INFORMATION****1.1 CITY OF PARKLAND OVERVIEW:**

The City of Parkland (CITY) was incorporated in 1963 and is located in the northwest corner of Broward County. The City has a park-like setting and is a predominantly single-family residential community. Some original areas of the community include large estate lots with one dwelling unit per 2.5 acres and estate lots with one dwelling unit per acre. Newer portions of the community are generally gated single family home developments. Commercial development in the City is limited to a handful of shopping plazas which are for the most part concentrated on the SR7 corridor. The current population is estimated at 31,507 people and the median income of residents is estimate at \$128,292<sup>1</sup>. Parkland has earned a reputation for safety, excellent public schools, parks and open spaces, and its “home City” feel.

In 2009, the City annexed approximately 2,000 acres commonly referred to as “the Wedge”. This annexation increased the size of the City from approximately 11 square miles to nearly 13 square miles. Development of the Wedge is still ongoing but at build-out (approximately 2025), is projected to increase the City’s population from roughly 14,000 to approximately 45,000 people. As with the rest of the City, development of the Wedge to date and going forward will be residential in nature.

**1.2 BID REQUEST:**

The City of Parkland, Florida (CITY) is requesting bids from qualified, licensed, insured and experienced contractors to provide and install Irrigation Pump Stations in accordance with the specifications detailed herein. Contractor shall provide all supervision, labor, service vehicles, materials, tools, equipment and appurtenances necessary for the completion of this contract, in the manner specified in this solicitation.

**1.3 INFORMATION/CLARIFICATION:**

For information concerning this ITB contact Jill Woods, Buyer, (954) 757- 4180. Such contact is to be for clarification purposes only. Changes, if any, to the technical specifications or bid procedures will only be transmitted by written addendum acknowledged by Bidder.

**1.4 ADDENDA, CHANGES OR INTERPRETATIONS DURING BID:**

Any inquiry or request for interpretation received prior to the last day for questions/clarification will be given consideration. Changes or interpretations may only be made by a written document in the form of an addendum and, if desired, will be mailed or sent by available means to all known prospective Bidders no later than seven (7) days prior to the established Bid Submission deadline. Each prospective Bidder shall

acknowledge receipt of such addenda in the space provided in the bid form. In case any Bidder fails to acknowledge receipt of such addenda or addendum, his/her bid will nevertheless be considered as though it had been received and acknowledged and the submission of his bid will constitute acknowledgment of the receipt of same. All addenda are a part of the contract documents and each Bidder will be bound by such addenda, whether or not received by him/her. It is the responsibility of each prospective Bidder to verify that he/she has received all addenda issued before Bids are opened. No verbal interpretations may be relied upon.

1.6 INITIAL CONTRACT PERIOD AND CONTRACT RENEWAL:

Not applicable.

1.7 ELIGIBILITY:

To be eligible to respond to this ITB, prospective firms or principals must demonstrate that they, or the principals assigned to the project, have successfully provided services similar magnitude to those specified in the Scope of Services section of this ITB to at least one CITY similar in size and complexity to the City of Parkland or can demonstrate they have the experience with large scale private sector clients and the managerial and financial ability to successfully perform the services.

- a. Contractor shall comply with any/all local, state, and federal regulations pertaining to removal, installation and maintenance of systems.
- b. Contractor shall be a licensed General Contractor in the State of Florida. (Please provide current license).

1.8 ☐ BID SECURITY: *(Applicable if box checked)*

1.8.1 Each Bid must be accompanied by a certified or cashiers check or by a Bid Bond made payable to the City of Parkland on an approved form, duly executed by the Bidder as principal and having as surety thereon a surety company acceptable to the CITY and authorized to write such Bid Bond under the laws of the State of Florida, in an amount not less than five percent (5%) of the amount of the Base Bid (including any allowances) exclusive of any bid alternates. The City reserves the right to reject any and all security tendered to the City.

1.8.2 The ITB Security of the Successful Bidder will be retained until such Bidder has executed the Contract and furnished the required payment and performance bonds, whereupon the ITB Security will be returned. If the Successful Bidder fails to execute and deliver the Contract and furnish the required Bonds within fifteen

(15) calendar days of the Notice of Award, CITY may annul the Notice of Award and the entire sum of the ITB Security shall be forfeited. ITB Security will be returned to unsuccessful Bidder upon execution of a Contract with the successful Bidder. The attorney in fact or other officer who signs a Bid Bond for a surety company must file with such a Bond a certified copy of his power of attorney authorizing him to do so.

- 1.8.3 The ITB Security filed with the Bid shall be forfeited in its entirety to the CITY as liquidated damages if the Bidder to whom the Contract is awarded fails to execute the Contract Documents within fifteen (15) calendar days of the Contract Award.

1.9 ☐ PERFORMANCE AND PAYMENT BONDS/IRREVOCABLE LETTER OF CREDIT: *(Applicable if box checked)*

- 1.9.1 Within fifteen (15) calendar days after the Contract Award or prior to commencement of any work, whichever is sooner, the Successful Bidder shall execute and furnish to CITY a performance bond and a payment bond, each written by a corporate surety, having a resident agent in the State of Florida and having been in business with a record of successful continuous operation for at least five (5) years. The surety shall hold a current certificate of authority from the Secretary of Treasury of the United States as an acceptable surety on federal bonds in accordance with United States Department of Treasury Circular No. 570. If the amount of the Bond exceeds the underwriting limitation set forth in the circular, in order to qualify, the net retention of the surety company shall not exceed the underwriting limitation in the circular and the excess risks must be protected by coinsurance, reinsurance, or other methods, in accordance with Treasury Circular 297, revised September 1, 1978 (31 DFR, Section 223.10, Section 223.11). Further, the surety company shall provide CITY with evidence satisfactory to CITY, that such excess risk has been protected in an acceptable manner. The surety company shall have at least the following minimum qualifications in accordance with the latest edition of A.M. Best's Insurance Guide, published by Alfred M. Best Company, Inc., Ambest Road, Oldwick, New Jersey 08858:

Financial Size – VIII

- 1.9.2 Two (2) separate bonds are required and both must be approved by the CITY. The penal sum stated in each bond shall be the amount equal to the total amount payable under the terms of the contract. The performance bond shall be conditioned that the Successful Bidder perform the contract in the time and manner prescribed in the contract. The payment bond shall be conditioned that the Successful Bidder promptly make payments to all persons who supply the Successful Bidder with labor, materials and supplies used directly or indirectly by the Successful Bidder in the prosecution of the work provided for in the contract and shall provide that the surety shall pay the same in the amount not exceeding the sum provided in such bonds, together with interest at the maximum rate

allowed by law; and that they shall indemnify and save harmless the CITY to the extent of any and all payments in connection with the carrying out of said contract which the CITY may be required to make under the law. The bond shall insure payment of laborers, material suppliers, and subcontractors and the timely completion of the project and be in a form acceptable to the City.

1.9.3 Such bonds shall continue in effect for one (1) year after final payment becomes due except as otherwise provided by law or regulation or by the Contract Documents with the final sum of said bonds reduced after final payment to an amount equal to twenty five percent (25%) of the Contract Price, or an additional bond shall be conditioned that the Successful Bidder correct any defective or faulty work or material which appear within one (1) year after final completion of the Contract, upon notification by CITY. ALL BONDS MUST BE APPROVED BY THE CITY ATTORNEY.

1.9.4 Failure of the successful Bidder to execute a Contract, file any required Performance and Payment Bonds shall be just cause for the annulment of the award and the forfeiture of the ITB security to the City, which forfeiture shall be considered, not as a penalty, but as liquidation of damages sustained.

1.10 INSURANCE:

The successful bidder shall not commence operations; construction and/or installation of improvements pursuant to the terms of this ITB and the attached Contract, until certification or proof of the insurance requirements set forth within the attached contract have been received and approved by the City's Insurance Agent. Any questions as to the intent of meaning of any part of the insurance requirements set out in the attached contract should be directed to the Purchasing Department (See Section 4.4 for additional information).

**SECTION 2 - STANDARD TERMS AND GENERAL CONDITIONS****2.1 SUBMISSION AND RECEIPT OF BIDS:**

To receive consideration, bids shall be submitted in accordance with this ITB. Any erasures or corrections on the bid must be made in ink and initialed by Bidder in ink. All information submitted by the Bidder shall be printed, typewritten or filled in with pen and ink. Bids should be signed in blue ink. Separate bids must be submitted for each ITB issued by the CITY in separate sealed envelopes properly marked. When a particular ITB requires multiple copies they may be included in a single envelope or package, properly sealed and identified. Bidders shall use the bid forms provided by the CITY. These forms may be duplicated, but failure to use the forms may cause the bid to be rejected as non-responsive.

2.1.1 The original document must have an original manual signature of the authorized representative of the Bidder in blue ink. Bids shall contain an acknowledgment of receipt of all Addenda. The address, e-mail and telephone number for communications regarding the Bid must be shown.

2.1.1.1 Bids by corporations must be executed in the corporate name by the President or other corporate officer accompanied by evidence of authority to sign. The corporate address and state of incorporation must be shown below the signature.

2.1.1.2 Bids by partnerships must be executed in the partnership name and signed by a partner, whose title must appear under the signature and the official address of the partnership must be shown below the signatures.

2.1.2 All Bids received from Bidders in response to the Invitation to Bid will become the property of the City of Parkland and will not be returned to the Bidders. In the event of Contract award, all documentation produced as part of the Contract shall become the exclusive property of the CITY.

**2.2 QUALIFICATIONS STATEMENT:**

2.2.1 Each Bidder shall complete the Qualifications Statement and submit the same with his Bid. Failure to submit the Qualifications Statement and the documents required there under with the Bid may constitute grounds for rejection of the Bid.

2.2.2 The City of Parkland reserves the right to make a pre-award inspection of the Bidder's facilities and equipment prior to award of the Contract.

**2.3 BIDDERS' COSTS:**

The CITY shall not be liable for any costs incurred by Bidders in responding to this ITB.

**2.4 BID ACCEPTANCE:**

Bidder warrants by virtue of submitting his/her Bid that the prices quoted will be firm for acceptance by the CITY for a period of 90 days from the date of bid opening unless otherwise stated in the ITB.

**2.5 NO EXCLUSIVE CONTRACT/ADDITIONAL SERVICES:**

Bidder agrees and understands that, unless specifically and expressly provided for herein, the Contract shall not be construed as an exclusive arrangement and further agrees that the CITY may, at any time, secure similar or identical services at its sole option.

**2.6 MISTAKES:**

Bidders are cautioned to examine all terms, conditions, specifications, drawings, exhibits, addenda, delivery instructions, and special conditions pertaining to the ITB. Failure of the Bidder to examine all pertinent documents shall not entitle him to any relief from the conditions imposed in the contract and may lead to rejection of a bid.

**2.7 REJECTION OF BIDS:**

The CITY reserves the right to accept or reject any or all bids, part of bids, and to waive minor irregularities or variations to specifications contained bids, and minor irregularities in the bid process.

**2.8 RESOLUTION OF PROTESTED SOLICITATIONS AND PROPOSED AWARDS:**

All bid protests shall be filed and processed as set forth in Section 2-145 of the City Procurement Code.

**2.9 LEGAL REQUIREMENTS:**

2.9.1 Applicable provisions of all federal, state, and county laws, and local ordinances, rules and regulations, shall govern development, submittal and evaluation of all bids received in response hereto and shall govern any and all claims and disputes which may arise between person(s) attaching a bid response hereto and the CITY by and through its officers, employees and authorized representatives, or any other person, natural or otherwise. Lack of knowledge by any Bidder shall not constitute a cognizable defense against the legal effect thereof.

2.9.2 The Legal Advertisement, Notice of Request for Bid, Standard Terms and General Conditions, Special Conditions, Specifications, Instructions to Bidders, Exhibits, Addenda and any other pertinent document form a part of this BID and by reference are made a part of any response to this BID.

2.9.3 Pursuant to Section 838.32(1) Florida Statutes, it is unlawful for a bidder or Bidder to knowingly and intentionally influence or attempt to influence any competitive solicitation of the City of Parkland.

2.10 BACKGROUND CHECKS:

As per City Ordinance Sec. 2-142.4. – Criminal Background Checks, for any contracts which require a contractor, subcontractor, consultant or subconsultant to perform work in or on City property where the contractor or any subcontractors or employees will perform work or services in close proximity to facilities with minors, the elderly or persons with special needs or where the services are of a nature which would reasonably warrant background checks, the City shall include a requirement with the contractor, subcontractor, consultant or sub-consultant who is doing the work in or on City property.

All criminal background checks must be conducted prior to any covered individual's initial access to City's property and, depending on the contract's term, on an annual basis thereafter. The contractor or consultant shall be required to submit an affidavit on the form included with the bid documents, certifying that background checks have been completed for all employees as set forth in subsection (2) of the code and certify that no employee who has been convicted or who has entered a plea of nolo contendere for any crime set forth within subsection (4) of the code shall perform work on City property as referenced above.

2.11 SPECIAL CONDITIONS:

Any and all Special Conditions contained in this ITB that may be in variance or conflict with the General Conditions shall have precedence over the General Conditions. If no changes or deletions to General Conditions are made in the Special Conditions, then the General Conditions shall prevail in their entirety.

2.12 PROHIBITION OF INTEREST:

No contract will be awarded to a Bidder who has CITY elected officials, officers or employees affiliated with it, unless the Bidder has fully complied with current Florida State Statutes and CITY Ordinances relating to this issue. Bidders must disclose any such affiliation. Failure to disclose any such affiliation will result in disqualification of the Bidder and removal of the Bidder from the CITY's Bidder's List and prohibition from engaging in any business with the CITY.

2.13 CONFLICT OF INTEREST:

The Bidder covenants that they presently have no interest and shall not acquire any interest, directly or indirectly, which would conflict in any manner or degree with the performance of the services hereunder. The Bidder further covenants that no person having any such known interest shall be employed or conveyed an interest, directly or indirectly, in the contract.

2.13.1 The BIDDER represents itself to be an independent firm offering such services to the general public and shall not represent itself or its employees to be employees of the City of Parkland. Therefore, the Bidder shall assume all legal and financial responsibility for taxes, FICA, employee fringe benefits, worker's compensation, employee insurance, minimum wage requirements, overtime, and other expenses, and agrees to indemnify, save, and hold the City of Parkland, its officers, agents, and employees, harmless from and against, any and all loss; cost (including attorney fees); and damage of any kind related to such matters.

2.14 NO CONTINGENT FEE:

Bidder warrants that it has not employed or retained any company or person, other than a bona fide employee working solely for the Bidder to solicit or secure the Contract and that it has not paid or agreed to pay any person, company, corporation, individual or firm, other than a bona fide employee working solely for the Bidder, any fee, commission, percentage, gift, or other consideration contingent upon or resulting from the award or making the Contract. For the breach or violation of this provision, the CITY shall have the right to terminate the Contract without liability at its discretion.

2.15 PUBLIC RECORDS / CONFIDENTIAL INFORMATION:

Florida law provides that municipal records shall at all times be open for personal inspection by any person, unless otherwise exempt. Information and materials received by the City in connection with a Bidder's response shall be deemed to be public records subject to public inspection. However, certain exemptions to the public records law are statutorily provided for in Section 119.07, F.S. Section 119.07, F.S. provides an exemption from public records law for sealed bids, bids, or replies received by an agency pursuant to a competitive solicitation until such time as the agency provides notice of an intended decision or until 30 days after opening the bids, bids, or final replies, whichever is earlier.

**THE CONTRACTOR SHALL COMPLY WITH THE REQUIREMENTS OF CHAPTER 119, FLORIDA STATUTES WITH RESPECT TO ALL PUBLIC RECORDS.**

## SPECIFICALLY, THE CONTRACTOR SHALL:

1. Keep and maintain public records required by the CITY to perform the service.
2. Upon request from the CITY's custodian of public records, provide the CITY with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in this chapter or as otherwise provided by law.
3. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if the contractor does not transfer the records to the public agency.
4. Upon completion of the contract, transfer, at no cost, to the CITY all public records in possession of the contractor or keep and maintain public records required by the CITY to perform the service. If the contractor transfers all public records to the CITY upon completion of the contract, the contractor shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the contractor keeps and maintains public records upon completion of the contract, the contractor shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to the CITY, upon request from the CITY's custodian of public records, in a format that is compatible with the information technology systems of the CITY.
5. REQUEST FOR RECORDS; NONCOMPLIANCE.—
  - (a) A request to inspect or copy public records relating to a City's contract for services must be made directly to the City. If the City does not possess the requested records, the City shall immediately notify the CONSULTANT of the request, and the CONSULTANT must provide the records to the City or allow the records to be inspected or copied within a reasonable time.
  - (b) If a CONSULTANT does not comply with the City's request for records, the City shall enforce the contract provisions in accordance with the contract.
  - (c) A CONSULTANT who fails to provide the public records to the City within a reasonable time may be subject to penalties under s. 119.10.

2.16 RESERVED:2.17 PUBLIC ENTITY CRIMES INFORMATION STATEMENT:

A person or affiliate who has been placed on the convicted vendor list following a conviction for public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to public entity, may not be awarded or perform work as a Bidder, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017, for CATEGORY TWO For a period of thirty-six (36) months from the date of being placed on the convicted vendor list.

2.18 NON-COLLUSIVE AFFIDAVIT:

Each Bidder shall complete the Non-Collusive Affidavit Form and shall submit the form with the Bid. The CITY considers the failure of the Bidder to submit this document to be a major irregularity and may be cause for rejection of the Bid.

2.19 SUB-CONTRACTORS:

If the Bidder proposes to use subcontractors in the course of providing these services to the CITY, this information shall be a part of the ITB response. Such information shall be subject to review, acceptance and approval of the CITY, prior to any Contract award. The CITY reserves the right to approve or disapprove of any subcontractor candidate in its best interest.

2.20 CONE OF SILENCE: A Cone of Silence shall apply as follows:

2.20.1 A Cone of Silence shall be in effect during a Competitive Solicitation beginning upon the advertisement for requests for bids, requests for qualifications and competitive bids. The Cone of Silence shall terminate at the time the City Commission makes final award of a bid or gives final approval of a contract or contract amendment, rejects all bids or responses to the Competitive Solicitation, or takes other action which ends the Competitive Solicitation. The Cone of Silence shall continue through the negotiation phase for requests for bids and requests for qualifications and shall not end until the Commission gives final approval of the contract.

2.20.2 Any person or entity that seeks a contract, contract amendment, award, recommendation, or approval related to a Competitive Solicitation or that is subject to being evaluated or having its response evaluated in connection with a Competitive Solicitation, including a person or entity's representative shall not have any communication with any City Commissioner, the City Manager and their respective support staff or any person or group of persons appointed or designated by the City Commission or the City Manager to evaluate, select, or make a recommendation to the City Commission or the City Manager regarding a Competitive Solicitation.

2.20.3 The Cone of Silence shall not apply to written or oral communications with legal counsel for the CITY or the Purchasing Department for the CITY.

2.20.4 Any action in violation of this section shall be cause for disqualification of the bid or the proposal. The determination of a violation shall be made by the City Commission.

## 2.21 MINORITY PARTICIPATION:

Disadvantaged Business Enterprises (DBE) participation. Bidders are advised that the City promotes equal employment opportunity (EEO) and encourages the participation of minority and women business enterprises (M/WBE) as well as small business enterprises (SBE) in all aspects of contracting. Joint venturing at the prime and sub-consultant levels is encouraged where the joint venture results in a more qualified and/or more diverse Bidder. Bidders shall make efforts to maintain no less than fifteen (15) percent DBE participation for contracts over one hundred thousand dollars (\$100,000.00). The City will accept certifications from offerors, including their subcontractors identified in their response, as defined and certified by the Florida Department of Management, Office of Supplier Diversity or other certifying organizations or jurisdictions in accordance with Section 287.0943 (1) and (2) Florida Statutes.

## 2.22 LOCAL PREFERENCE:

For all competitive solicitations in which objective factors are used to numerically evaluate the responses from vendors by the selection committee, and price is one of several of the criteria for award among otherwise qualified vendors, where a non-local business is the highest ranked Bidder and the ranking of a local Bidder is within five (5%) of the ranking obtained by the non-local Bidder, the highest ranked local Bidder (within 5%) shall have the opportunity to proceed to negotiations with the City upon approval of such ranking by the City Commission (or staff if the award does not need commission approval). If the City determines that it is, in its sole and exclusive discretion, unable to negotiate an acceptable contract, then it shall proceed to negotiate with the next highest ranked Bidder, whether local or non-local.

The City has the sole discretion in determining whether a business meets the criteria to qualify for a local business preference and reserves the right to revoke this preference at any time if the City determines the business no longer meets the following criteria:

- (a) The principal place of business is located in the City of Parkland; and
- (b) the business has held a valid City business license for at least one (1) year prior to the date of application; and
- (c) the business maintains its status as a local bidder throughout the term of the contract; if it fails to do so the contract shall entitle the City, in its sole discretion, to terminate the contract.

## 2.23 CONTRACT:

A sample contract is made a part of this ITB. The final Contract shall include any additional terms and conditions as approved by the City Manager.

**2.24 DRUG FREE WORKPLACE:**

In accordance with Florida Statute 287.087, preference shall be given to businesses with drug-free workplace programs. Whenever two (2) or more bids which are equal with respect to price, quality, and service are received by the City for the procurement of commodities or contractual services, a bid received from a business that completes the attached DFW form certifying that it is a DFW shall be given preference in the award process.

**2.25 COMPLIANCE WITH LAWS:**

The selected firm, its officers, agents, employees, and contractors, shall abide by and comply with all federal, state, and local laws. It is agreed and understood that if City calls the attention of Contractor to any such violations on the part of the Contractor, its officers, agents, employees, contractors, then contractor shall immediately desist from and correct such violation. If contractor is in violation of any law, contractor shall be solely responsible for coming into compliance with such law and shall be solely responsible for the payment of any fine charged for such violation.

**2.26 BIDDER'S REPRESENTATION:**

By virtue of its submission of this response to the ITB, Bidder represents that it has reviewed all information which it has reason to believe is relevant to the making of this bid, including any necessary site inspections and field inspections, measurements and visits and that there is no information which it does not possess which it believes is necessary to make a fully informed and accurate bid.

**2.27 ADDITIONAL PROVISIONS:****2.27.1 Correction on bids.**

(a) Mathematical errors - Errors in extension of unit prices or mathematical calculations may be corrected by the Purchasing Department or designee prior to award. The unit prices shall not be changed.

(b) A bidder shall be permitted to correct clerical, non-judgmental mistakes of fact in their bid by Purchasing Director through a written directive.

(c) Voluntary reduction of price—The City may accept a voluntary reduction from a low bidder after bid opening, if such reduction is not conditioned on, nor results in, the modification or deletion of any condition contained in the invitation for bids. A voluntary reduction may NOT be used to ascertain the lowest responsive bidder.

**2.27.2 Cancellation of bids.**



- (a) Any time prior to bid opening date and time, the City may cancel or postpone the bid opening or cancel the invitation for bid in its entirety.
- (b) After bids are open, any or all bids may be rejected by the City.

2.27.3 Withdrawal of bids.

- (a) Any bidder may voluntarily withdraw or amend their bid at any time prior to the bid opening by providing written notice to the City. Amendments should be forwarded to the Purchasing Director, sealed and identified.
- (b) After bid opening, vendors shall not be allowed to withdraw a bid in less than ninety (90) days, or a specific time period stated in the invitation to bid with the following exception—The bid is so outrageous as to be a prima facie evidence of a bid mistake, but a mistake that cannot be corrected by correction of mathematical computation.

2.28 CANCELLATION FOR UNAPPROPRIATED FUNDS:

The obligation of the City for payment to a Contractor is limited to the availability of funds appropriated in the current fiscal period, and continuation of the contract into a subsequent fiscal period is subject to appropriation of funds, unless otherwise authorized by law.

2.29 DAMAGE TO PUBLIC OR PRIVATE PROPERTY:

- (a) The Contractor shall at all times use all means necessary to protect property. Damage to public and/or private property shall be the responsibility of the Contractor and shall be repaired and/or replaced at no additional cost to the City.
- (b) If property (public or private) is damaged while contractor is performing work specified or is removed for the convenience of the work, it shall be repaired or replaced at the expense of the contractor in a manner acceptable to the City of Parkland prior to the final acceptance of the work. Contractor will be responsible for applying and securing any permits that may be required to complete such repairs. Such property shall include but not be limited to: existing facilities and all of its components, site amenities, concrete and/or asphalt surfaces, vehicles, structures, sidewalks, curbs and gutters, driveways, utilities, etc.
- (c) Contractor must provide protection necessary to prevent damage to property being repaired or replaced.
- (d) If the work site has any pre-existing damage, the Contractor shall notify the Public Works/Capital Projects Department in writing. Failure to do so shall obligate the contractor to make repairs per the above section.

**SECTION 3 – CRITERIA FOR AWARD****3.1 CRITERIA FOR AWARD:**

3.1.1 The award of the bid shall be to the lowest, responsive, and responsible bidder that is in the best interest of the City. In determining the lowest responsive and responsible bidder, in addition to price, the City shall consider the following:

- (a) The ability, capacity and skill of the bidder to perform the contract.
- (b) Whether the bidder can perform the contract within the time specified, without delay or interference.
- (c) The character, integrity, reputation, judgement, experience and efficiency of the bidder.
- (d) The quality of performance on previous public or private contracts of similar type.
- (e) The previous and existing compliance by the bidder with laws and ordinances relating to this contract.
- (f) The ability of the bidder to provide future maintenance and service.

3.1.2 Tie bids. The tie may be broken and the successful Bidder selected by the following criteria presented in order of importance and consideration:

- (a) Quality of the items or services if it is ascertainable.
- (b) Except as prohibited by Federal or State law, location of business, specifically those located within the city limits (as evidenced by a business tax receipt), or
- (c) If no business is located within the city limits, to a county-based business or a certified minority business enterprise, as defined in F.S. § 288.703
- (d) Time of delivery if provided in the bid.
- (e) If the criteria in subsections (g)(1) through (g)(4) do not resolve the tie, the city may award a contract to that vendor whose bid was received first as indicated by the time stamp on the envelope containing the bid.
- (f) If the criteria in subsections (g)(1) through (g)(5) of this section do not resolve the bid tie, contract award shall be made by a lot drawn by the purchasing director before at least one (1) witness.

The City reserves the right to award a contract to a bidder other than the lowest-priced bidder, considering the above factors. The city also reserves the right to reject all bids and shall document its rationale for any bid rejection.

**3.2 CONSIDERATION FOR AWARD/AWARD PROCEDURES:**

City staff shall evaluate bids and report to the Commission the results of the evaluation.

3.2.1 **COMMISSION ACTION:** The City Commission shall review the staff evaluation and award to the lowest, responsible and responsive Bidder in the best interests of the

City unless the said bid received is under fifty thousand dollars (\$50,000.00) where the Purchasing Director is then authorized to award said bid to the lowest most responsive Bidder that is in the best interest of the City and is authorized to enter into a contract with the Bidder.

- 3.2.2 In the event that grant funds are not made available for this project, the City Manager is authorized to reject all bids without City Commission consent.
- 3.2.3 After award of the contract, the Bidder/Contractor shall be instructed to commence the Work by written instruction in the form of a Purchase Order issued by the Purchasing Division and/or a Notice to Proceed issued by the Contract Administrator. The first Notice to Proceed and/or Purchase Order will not be issued until Bidder/Contractor's submission to CITY of all required documents and after execution of the Contract by both parties.

**SECTION 4 - SPECIAL CONDITIONS****4.1 ☒ TIME FOR COMPLETION/ LIQUIDATED DAMAGES (Applicable if box checked):**

Failure to complete all the work within the time specified in this bid, including any extension granted in writing by the Contract Administrator, shall obligate the Contractor to pay the City, as liquidated damages and not as a penalty, an amount equal to \$150.00 for each calendar day of delay in the completion of all the work. If any liquidated damages are unpaid by the Contractor, the City shall be entitled to deduct these unpaid liquidated damages from the monies due the Contractor. The CONTRACTOR will make every attempt to supply the awarded services within the time frame(s) requested. Liquidated damages are hereby fixed and agreed upon by the parties, recognizing the impossibility of precisely ascertaining the amount of damages that will be sustained by CITY as a consequence of such delay, and both parties desiring to obviate any question or dispute concerning the amount of said damages and the cost and effect of the failure of CONTRACTOR to complete the services within the applicable Time and Performance.

**4.2 ☒ COUNTY/STATE LICENSE REQUIREMENTS (Applicable if box checked):**

Bidder shall be licensed and qualified to do business in its area of expertise and shall submit copies of all applicable licenses/certifications with their bid. The successful Bidder will be required to maintain the appropriate licenses and certificates throughout the term of the contract.

Any bid that is submitted by a Bidder who is not properly licensed/certified at the time the bid is submitted may be rejected as non-responsive.

**4.3 INDEMNIFICATION:**

CONTRACTOR shall at all times hereafter indemnify, hold harmless and, at the City Attorney's option, defend or pay for an attorney selected by the City Attorney to defend CITY, its officers, agents, servants, and employees from and against any and all causes of action, demands, claims, losses, liabilities and expenditures of any kind, including attorney fees, court costs, and expenses, caused or alleged to be caused by intentional or negligent act of, or omission of, CONTRACTOR, its employees, agents, servants, or officers, or accruing, resulting from, or related to the subject matter of this Contract including, without limitation, any and all claims, losses, liabilities, expenditures, demands or causes of action of any nature whatsoever resulting from injuries or damages sustained by any person or property. In the event any lawsuit or other proceeding is brought against CITY by reason of any such claim, cause of action or demand, CONTRACTOR shall, upon written notice from CITY, resist and defend such lawsuit or proceeding by counsel satisfactory to CITY or, at CITY's option, pay for an attorney selected by City Attorney to defend CITY. The provisions and obligations of this section shall survive the expiration or earlier termination of this contract. To the extent considered necessary by the Contract Administrator and the City Attorney, any sums due CONTRACTOR under this Contract may

be retained by CITY until all of CITY's claims for indemnification pursuant to this Contract have been settled or otherwise resolved; and any amount withheld shall not be subject to payment of interest by CITY. Nothing herein shall be deemed a waiver or limitation of any sovereign immunity provided by law or any limitation of the City's liability in any statute or as otherwise provided by law.

**SECTION 5 – SPECIFICATIONS and BID REQUIREMENTS****5.1 PURPOSE:**

The purpose of this Invitation to Bid (“ITB”) is to obtain Bids from qualified contractors to furnish and install irrigation pump stations specified or their **equivalent** according to the specifications, in accordance with the terms, conditions, and scope of services of this bid. Base Bid entails scope of work outlined in 5.2.1 and 5.2.2. An add/alternate scope includes work outlined in 5.2.3.

**5.2 SCOPE OF SERVICES:**

The selected contractor shall have the ability to perform and carry out in a professional manner the services necessary to complete the assigned project.

5.2.1 Remove two (2) existing irrigation pump stations and deliver said equipment to the City of Parkland Public Works yard located within the Pine Trails Park location. Removal scope of services to include the following two (2) numbered items:

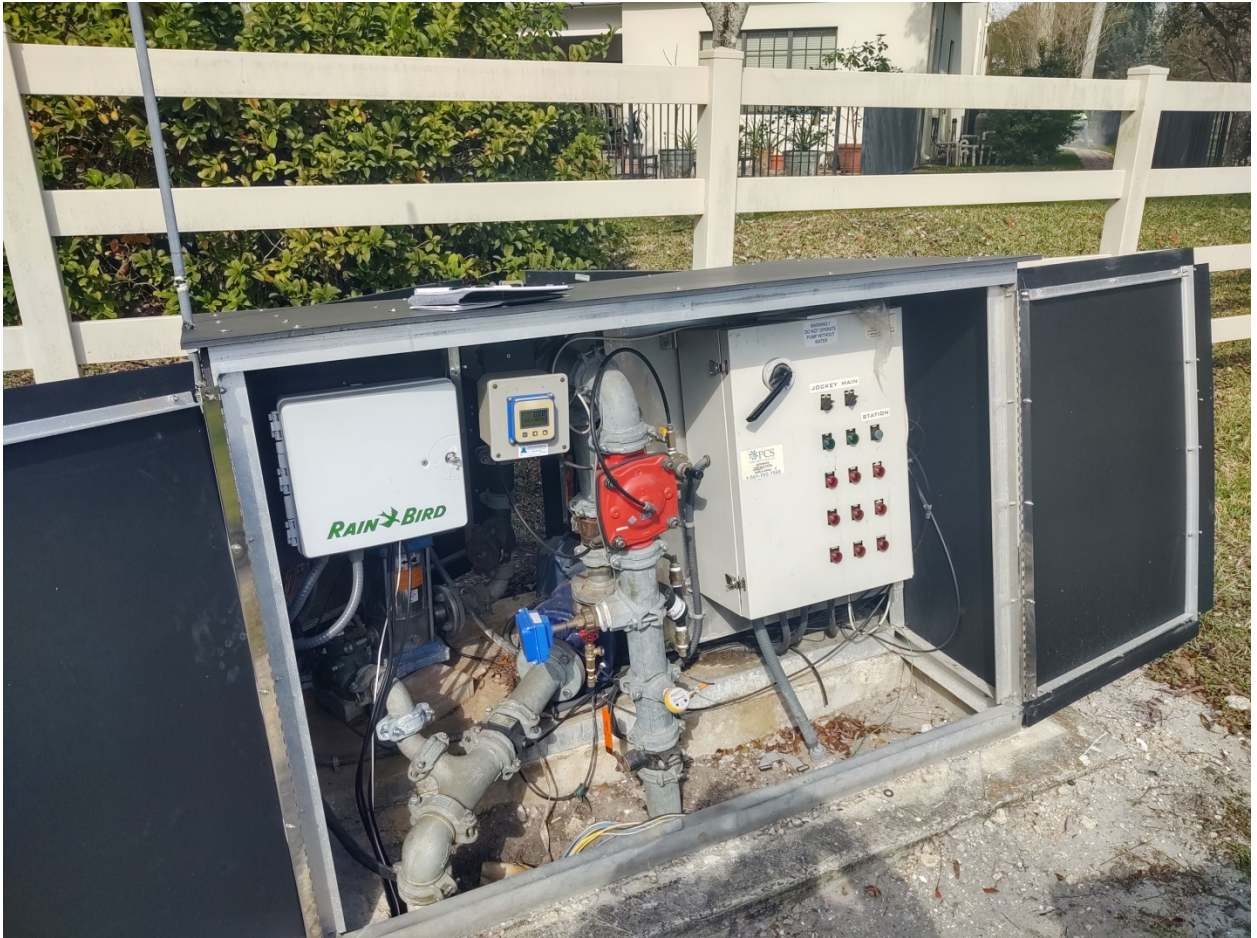


Figure 1 - Existing Pump Station 'A1' to be removed in its entirety

1) Furnish necessary labor, materials, and equipment to remove existing irrigation pump station ‘A1’ further described and illustrated below (see figures 1 and 3). All components, including but not limited to those noted below, shall be removed to allow installation of a new Pump Station ‘C’ in the general location of the existing Pump Station ‘A1’. All that should remain is the existing irrigation control wires from pump ‘A1’ and any of the existing power infrastructure which will be required to re-power the new irrigation pump station ‘C’.

**Pump Station ‘A1’**

- Aluminum framed, composite pump enclosure bolt to concrete slab
- A single 15hp 460 volt 3 phase horizontal centrifugal main pump
- A single 5hp 460 volt 3 phase horizontal centrifugal jockey pump

- Irrigation Controller and control wires (bundle/label control wires ‘A1’ to remain)
- Flow sensor and associated wiring

2) Furnish necessary labor, materials, and equipment to remove existing irrigation pump station 'B1' further described and illustrated below (see figures 2 and 3). All components, including but not limited to those noted below, shall be removed to allow installation of a new Pump Station 'C' in the general location of the existing Pump Station 'A1'. All that should remain is the existing irrigation control wires from pump 'B1' and any of the existing power infrastructure which will be required to re-power the new irrigation pump station 'C'.

- A single 30 hp 460 volt 3 phase horizontal centrifugal main pump

- Irrigation Controller and control wires (bundle/label control wires B1 to remain)
- Flow sensor and associated wiring

## 5.2.2 Install new irrigation Pump Station 'C' as follows:

1) Furnish necessary labor, materials, and equipment to install new irrigation Pump Station 'C' generally described below and further illustrated and detailed in **Exhibit 'A'**:

- Site One Green Tech pump station model PIB-20-C-463-D/F6-12FC-6013A1, or equal
- Dual (two) 20.0 hp horizontal centrifugal pumps with TEFC motors
- Variable frequency drive, IGBT based
- Insertion flow sensor
- Stainless Steel, GTV-060 filter, using Suction Scanner Technology with 120 Micron screen and auto-flush capabilities
- HDPE Suction line
- Pump Assembly shall be a UL 778 Compliant Packaged Pump System
- 460 VAC 3 Phase power
- Drive Watch - Remote monitoring
- Two new Irrigation Controllers labeled A1 and B1

2) Reconnect existing irrigation control wires to their corresponding new A1 and B1 irrigation controllers. Both irrigation controllers shall be mounted on the outside of the pump station enclosure and connected to separate rain sensors as noted in the specifications.

3) Existing Site electrical (for two existing pump stations shall be removed/reconfigured, as necessary to provide power to new Pump Station 'C' per local, county, state, Federal and N.E.C. requirements). This may include new power cable from transformer to existing or new electrical panel, and new power cable from new/existing electrical panel to pump station power panel. The requirements to utilize existing power infrastructure is the responsibility of the bidder to determine prior to bidding.

4) Install new HDPE suction lines as required by specifications.

5) Connect pump station 'C' discharge header to both existing irrigation mainlines previously attached to pump station A1 and B1. Utilize class 200 PVC piping to make these connects and size this piping to insure pipe velocities do not exceed five (5) feet per second (fps). Restrain piping as required by piping manufacturers.

5.2.3 ADD/ALTERNATE - Contractor to provide pricing for removing/installing the following components from pump station 'C' as alternates to the base bid.

1) Add/Alternate #1 - Delete screen filter assembly with suction scanner technology from the Pump Station 'C' installation (Screen Filter is described in section 6 of the SiteOne specifications in Exhibit 'A') and replace with a Netafim Apollo disc filtration unit described below and further illustrated and detailed in **Exhibit 'A1' Add/Alternate:**

- a. SiteOne model number DFAAP04A-24AHP - four (4) stem Apollo Angle Filter
- b. A four cartridge Netafim Apollo filtration battery with automated flushing
- c. 120 mesh disc filter
- d. Flushing Controller for eight (8) stems
- e. 6" HDPE manifold with isolation valves
- f. 4" HDPE flushing manifold
- g. Stand Alone Powder Coated Enclosure – Tan in color – set on prefabricated slab
- h. HDPE piping from pump discharge to Apollo filtration unit
- i. Install required electrical for filtration unit

### 5.3 PROTECTION OF PROPERTY:

- (a) The Contractor shall at all times guard against damage or loss to City property and any other persons in or around the work site, and shall be responsible for replacing or repairing any such damage or loss. The Contractor will be required to report any such damages or loss immediately to the Facilities Superintendent or his designee.

requirements and such obligation shall be the sole responsibility of the Contractor to immediately address upon the City's notification to the Contractor's supervisory staff on-site or the managerial point of contact designated to the contract.

- iii. The Contractor's personnel performing work on City property shall be in uniforms with the company's name, clean, courteous, sober and competent. The Contractor agrees to be responsible for such personnel. All Contractor's personnel dealing with the public under this contract, shall be identified by name through the use of a nametag or embroidered name on his/her uniform and a photo identification badge. Working without a shirt and proper identification is not permitted and shall be grounds for removal from City property. The Contractor agrees that the owners of the company, or officers if a corporation, shall be held fully responsible, except as otherwise prohibited by law, for acts of their personnel while on duty.
- iv. At least one (1) employee in a supervisory role at the worksite must be able to communicate clearly and fluently in the "English" language.
- v. All contractor's employees/service technicians shall be properly trained and qualified to work on the systems covered under this contract.
- vi. Contractor employees shall immediately report any damages done to City property to their supervisor. The supervisor shall then report such damage to the city contract administrator.
- vii. No smoking by Contractor's employees will be permitted at any time while on City property during the performance of services under this agreement.

(b) Contractor's Vehicles

- i. Contractor's vehicles used for the maintenance services shall be clean and presentable, in good working condition, identified with the name of the company and properly licensed.
- ii. Contractor's vehicles will have assigned vehicle ID numbers and display company name and logo so City staff can denote which vehicles were working at which locations during site inspections.

### SCOPE OF WORK

It is the intention of this specification to describe a pre-fabricated and self-contained pump station for turf irrigation applications. The station shall be assembled utilizing standard "off the shelf" components conforming to the following specifications. This application is suction lift.

The type of water source in this application is surface water containing suspended solids. The suction lift or vertical lift conditions in feet of head, (TDH) from the surface of the water will not exceed 12 feet. Water quality information such as dissolved solids, pH and salinity has been determined by others and is safe for use as an irrigation source.

The pumping station shall be model number PIB-20-C-463-D Series Centrifugal/Submersible Pump Assembly by SiteOne Green Tech – 4305 St Johns Pkwy - Sanford, FL 32771.

### SECTION 1: GENERAL

1.1 The pump motors shall operate at no more than 3500 RPM. The power supply to the station shall be 460 VAC 3 Phase.

1.2 The station shall be completely wired, piped, and pressure tested prior to shipment.

1.3 Operational sequence: The pump shall activate automatically upon detecting a drop in pressure in the irrigation main line. Operation shall be maintained at or above a minimum demand. The pump shall be automatically retired when the demand falls below the minimum flow for an adjustable time delay.

1.4 Construction: Construction shall be of modular form utilizing a base structurally adequate to support pumps, piping, and electrical equipment as a single integral assembly. All nuts, bolts washers, and fasteners shall be stainless steel, zinc or cadmium plated for corrosion resistance.

## **SECTION 2: PUMP AND MOTOR**

### **2.1 END SUCTION CENTRIFUGAL PUMP**

Each pump shall be driven by a 20HP horizontal motor with mechanical shaft seal, volute case and impeller. The shaft seal shall be a self-adjusting mechanical type to prevent leakage and eliminate the need for a drain piping. The volute case shall be precision machined from gray cast iron and engineered to modern hydraulic standards. It shall be possible to rotate the discharge connection to any of four positions. A heavy cast iron bracket shall maintain alignment between the motor and volute case. The impeller shall be an enclosed type and balanced to provide smooth operation. The impeller shall be keyed to the shaft and locked with a special cap screw and washer. The motor shaft is to be manufactured from high grade steel and of reduced length to increase shaft rigidity, extend bearing life, and reduce the overall length of the pump and motor assembly. The pump shaft shall be protected with a replaceable stainless steel sleeve. The pump, motor and impeller shall be removable from the back of volute case for service without disturbing the plumbing.

### **2.2 HORIZONTAL TEFC MOTOR**

Pump motor shall be as a standard TEFC (Totally Enclosed Fan Cooled) horizontal solid shaft type. The pump impeller shall be direct mounted and keyed to the motor shaft with a stainless steel protective sleeve. The temperature rise of the motor shall be to NEMA Standard for class B or Class F insulation. Radial and thrust bearings of ample capacity to accommodate the hydraulic thrust of the pump shall be incorporated into the motor.

## **SECTION 3: PIPING MANIFOLD, VALVES, GAUGES AND OTHER MECHANICAL EQUIPMENT**

### **3.1 FABRICATED PIPING**

All fabricated piping shall conform to ASTM specifications A53 for Grade B schedule 40 pipe. All connections shall be grooved type. All fittings shall be seamless, ASTM Specification A234, with pressure rating not less than 150 PSI. Standard construction shall consist of galvanized Sch 40 grooved pipe, groove fittings & couplings that meet FM standards with a minimum operating pressure of 150 PSI.

### **3.2 CHECK VALVE**

The check valve shall be grooved connected cast iron bodied, spring loaded swing type. The check valve shall be 6" size to handle the maximum discharge flow of the pump. Pressure drop across the check valve shall not exceed 2.5 PSI at full flow. This suction lift application is using surface water as a source. The check valve shall be located at the end of the suction piping beyond the stationary concrete pier and just after the intake strainer.

### **3.3 STATION DISCHARGE ISOLATION VALVE**

Pump shall be isolated by means of a groove connected butterfly valve before the piping exits the station enclosure. Isolation valves shall be butterfly type with ten position lever, rated for 200 PSI WOG working pressure. Trim shall include stainless steel stem, bronze or nickel coated iron streamlined disk with full faced resilient seat design to eliminate need for flange gaskets.

### **3.4 DRAIN PLUGS**

Drain plugs shall be provided from all low points in the system and shall consist of 1/4" pipe plugs.

### 3.5 PRESSURE GAUGES

Pressure gauges shall be located upstream and downstream of the pump for easy reading of the intake and discharge pressure. Pressure gauges shall be 304 stainless steel case and bezel construction. Gauges shall be 2-1/2" diameter, liquid filled. Pressure sensing connection shall be 1/4" NPT lower gauge connection.

### 3.6 WATER METER

The Pump Station shall have a totaling water meter that has the proper meter run per manufacturers requirements.

## SECTION 4: ELECTRICAL CONTROLS

### 4.1 GENERAL PANEL

The electrical components shall be integral to the Pump Assembly panel assembly and in accordance with the provisions of the National Electrical Code. The Pump Assembly shall be a **UL 778 Compliant Packaged Pump System**. The assembly shall include the certification mark of the Nationally Recognized Testing Laboratory (NRTL).

### 4.2 MAIN STATION DISCONNECT AND FUSING

A three-pole service rated main station disconnect shall be integral to the pump station enclosure for servicing the pump assembly without incoming power energized.

### 4.3 PUMP THERMAL SWITCH

When required, the temperature of the pump shall be sensed by a thermal switch. The thermal switch shall be located on the pump volute. Externally mounted snap disc type thermal switches will not be accepted. The thermal switch shall activate upon a temperature rise above 150 degrees Fahrenheit.

### 4.4 FLOW SENSOR

The pump station discharge manifold shall incorporate an OPTIONAL insertion type flow for continuous output to an independent irrigation controller with a compatible pulse rate.

### 4.5 PRESSURE TRANSDUCER

A solid state pressure transducer shall provide a noise free, linear output proportional to discharge pressure. Transducer shall be solid state, strain gauge type with integral voltage regulating and output accuracy not less than 0.5%. Transducer shall be constructed of stainless steel and rated for the maximum pump station discharge pressure.

### 4.6 VARIABLE FREQUENCY DRIVE (VFD)

The variable frequency drive shall be IGBT based with selectable carrier frequency up to 16 KHZ. The VFD shall include terminals for incoming power, motor output power and control terminals. The VFD shall generate a sine-coded, variable voltage/frequency, three-phase output for optimum speed control. The VFD shall incorporate power loss ride-through. VFD protective features shall include current limit, short circuit protection, electronic motor overload protection and ground fault protection. The VFD shall have push button programming display for easy access to operation parameters.

### 4.7 NATIONAL ELECTRICAL CODE STANDARDS

Electrical controls shall conform to National Electrical Code Standards.

#### CONTROL ALARMS:

##### 4.8 LOW SYSTEM PRESSURE SAFETY SHUTDOWN

When the station discharge pressure remains below an adjustable set point for the time called out in the Technical Specifications, the pumps will be de-energized and remain so until the alarm is manually reset. The Low Pressure alarm will be indicated on the processor display.

##### 4.8(a) HIGH SYSTEM PRESSURE SAFETY SHUTDOWN

When the station discharge pressure remains above an adjustable set point for the time called out in the Technical Specifications, the pumps will be de-energized and remain so until the alarm is manually reset. The High Pressure alarm will be indicated on the processor display.

##### 4.9 HIGH PUMP VOLUTE TEMPERATURE SHUTDOWN

If the pump volute case temperature rises above 150 degrees F. for the pre-programmed time, the pump will be de-energized and remain so until the alarm is manually reset. The High Temperature alarm will be indicated on the processor display.

##### 4.10 MOTOR OVERLOAD SHUTDOWN

If the over current condition lasts longer than the pre-programmed limit the motor will be de-energized and remain so until the alarm is manually reset. The overload alarm will be indicated on the processor display.

##### 4.11 PHASE LOSS (THREE PHASE POWER SUPPLIES ONLY)

The controls will sense a phase loss on the incoming power supply. If the phase loss is for longer than the drive ride through time, the motor will be de-energized and remain so until the alarm is manually reset. The Phase Loss alarm will be indicated on the processor display.

##### 4.12 VFD FAULT SHUTDOWN

The VFD shall sense additional internal faults that will cause the VFD to shutdown for system protection. These faults will be indicated on the processor display.

##### 4.13 LIGHTNING ARRESTOR

The main power supply to the pump station shall be equipped with a secondary lightning arrestor having a breakdown current rating of not less than 60,000 Amps at 14,000 Volts discharge. Power supplies 300 Volts and less shall use a 300 Volt arrestor with an 800 Volt spark-over Voltage. Power supplies up to 600 Volts shall use a 600 Volt rated arrestor with a 1,000 Volt spark-over Voltage.

#### **SECTION 5: MOUNTING BASE AND ENCLOSURE**

##### 5.1 MOUNTING BASE

Construction shall include a fabricated marine grade aluminum base assembly with integral fork lift slots to support all components during shipping and to serve as the installed mounting base. Pump station base shall be formed from a single sheet of 1/8" plate resulting in a seamless, one piece base with rounded

edges and corners. Base height must be a minimum 4" inches. The base shall be strategically reinforced beneath as required to provide additional support and strength. The base shall be drilled, allowing the pump to be secured to the base. The base material shall be properly prepped to bare metal prior to powder coating process.

## 5.2 ENCLOSURE

Construction shall include a vandal and weather resistant 10 gauge or equivalent, all metal aluminum powder coated enclosure. The front & sides of the enclosure shall have oversized cooling vents. The enclosure is to be supplied with a two internally mounted support arms that shall extend to keep the access door open. All components are to be accessible from top and front sides with the door completely open. Enclosure is to be suitable for mounting to the pump station base as an integrated assembly and shall include openings for suction and discharge piping, either through the sides or base floor as required.

## SECTION 6: AUTOMATIC FILTRATION

The pump station shall have an integral SiteOne Green Tech automatic vertical configuration filter(s), model number GTV-060 with 150# grooved inlet and outlet pipe connections. The unit shall continuously filter flow through a 120-micron screen, with a standard 2-year limited warranty, commissioning, and onsite training.

The filtration assembly shall be model number F6-12FC-6013A1 Series Automatic Suction Scanner Screen Filtration by SiteOne Green Tech – 4305 St Johns Pkwy. - Sanford, FL 32771.

### 6.1 OPERATION DESCRIPTION

Water shall flow from the inlet flange into the filter body and through the stainless steel fine screen filter element. Water flowing from the inside of the filter element to the outside and begins to deposit suspended solids on the element's surface; as these solids accumulate they form a filter cake. An adjustable Differential Pressure Switch (DPS) shall sense the pressure differential across the filter as a filter cake builds up on the element. The DPS shall signal the control panel (electronic processor) to initiate the cleaning cycle of the filter when the filter cake causes a pressure differential of 7 PSI. During the flushing cycle, there shall be no interruption of flow. The filter operation and flushing shall be controlled and monitored by an electronic processor control panel. The control panel, and its related circuitry, shall be housed in a wall-mounted NEMA 4 rated enclosure.

### 6.2 CLEANING MECHANISM

The filter cleaning mechanism will consist of a spiral moving dirt collector, and a rinse valve connected to atmosphere. By opening a rinse valve the dirt collector will create high efficiency suction force on each of the cleaning nozzles attached to the dirt collector. The nozzle head distance from the screen surface shall be manually or automatically adjustable to maximize cleaning efficiency during the cleaning cycle. The cleaning cycle shall be completed in 5 -16 seconds. During that time, the nozzles shall cover the entire surface area of the fine screen. The minimum pressure required for flushing shall be 30 PSI.

### 6.3 DRIVING MECHANISM

The dirt collector shall be driven by a hydraulic motor and piston assembly. The combination of these two components allows a simultaneous spiral or helix action to occur. The movement created by the rotation and linear motion, along with the vacuum effect of the nozzles achieves 100% cleaning of the filter element.

### 6.4 FILTRATION ELEMENT

The filter element shall be constructed of a combination of multi-layer 130 micron sintered together in

order to maximize both open area and mechanical strength. The collective screen shall be made of 316L stainless steel unless elsewhere defined in the specifications. The screen's external support will be constructed of perforated plate for mechanical strength. The fine weaved-wire screen shall be protected between coarser layers. The total surface area of the screen shall be 700 square inches and shall be able to withstand an internal / external pressure differential of 250 PSI without any damage. The filtration degree of the screen elements shall be available from 5000 to 5 microns with complete interchangeability in the same body.

#### 6.5 HOUSING CONSTRUCTION

The filter housing shall be powder coated carbon steel design operating pressure of the body shall be 150 PSI and the design maximum operating temperature shall be 150° F unless specified elsewhere.

#### 6.6 FILTER FLUSH CONTROLLER

The 110vac filter control system shall consist of a GTFC-500 electronic processor that will control all aspects of the filter operation, including monitoring the DPS, controlling the rinse valve.

#### 6.7 FILTER FLUSH DISCHARGE PIPING

The exhaust piping beyond the filter flush valve shall return debris to the water source or other location shown on the construction drawings. The piping size shall be 2" Sch. 40 PVC.

### SECTION 7: IRRIGATION CONTROLLER

A SiteOne Green Tech two SA03-RB05 satellite assembly shall be incorporated into the pump assembly as an integral part of the package. Power to the controller shall be supplied by pump station. Both controllers shall be mounted on the outside of the pump station enclosure along with two pole mounted rain sensors.

#### 7.1 FLOW SENSING

The PIB-20-C-463-D pump package shall incorporate two FS-350-SS flow sensor and a properly sized meter run to accommodate input of flow into each SA03-RB05.

#### 7.2 MASTER VALVE

The PIB-20-C-463-D pump package described in this written specification shall include a properly sized 24VAC master valve for each automatic isolation of both irrigation mainline from the pump station in the event of a MAIN LINE BREAK as indicated by the SA03-RB05.

### SECTION 8: SUCTION PIPING

#### MATERIAL OF CONSTRUCTION

The suction piping shall be IPS standard dimensioned fabricated HDPE (High Density Polyethylene) DR17. Fusion welding shall be conducted by certified technicians. A swing type suction check valve with groove connections will be provided and installed by the contractor at the well head. The buried suction piping extending out to the pond from the pump station shall be SiteOne Green Tech #SCS6HDPE-STATIC.

### SECTION 9: TESTING

When required, the pump station and all its component parts shall undergo a hydraulic and electrical test prior to shipment from the factory.

**SECTION 10: OWNERS MANUAL**

Complete start up instructions shall be provided by the manufacturer in the form of an owner's manual.

**SECTION 11: WARRANTY**

The manufacturer shall warrant the pump station to be free of defects for one year (12 months) from date of start-up or fifteen months after shipment, whichever occurs first. Failures caused by lightning strikes, power surges, vandalism, operator abuse, or acts of God are excluded from warranty coverage.

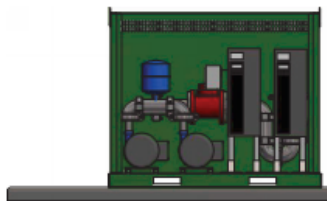
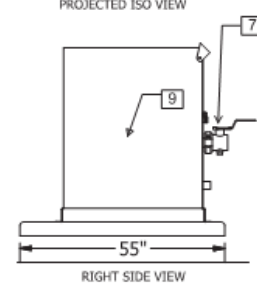
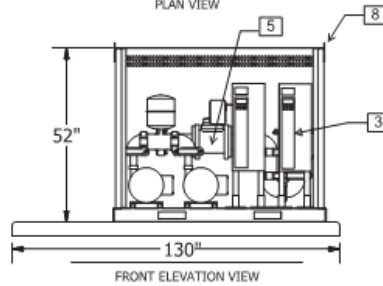
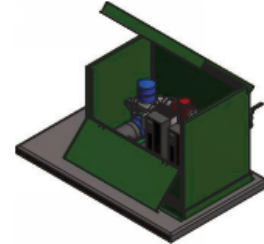
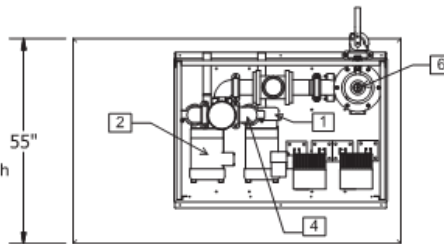
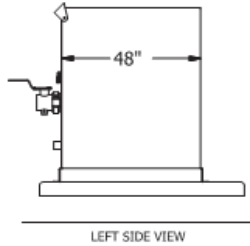

- 1.3 Except as specifically modified herein, CONTRACTOR shall be bound by the terms and conditions and prices as set forth in the ITB and the CONTRACTOR'S Response to the ITB. When the terms and conditions of this Contract may be read as consistent with the ITB, then and in that respect, the terms of both the ITB and this Contract shall be read as being consistent and shall be binding on both parties. Where terms and conditions of this Contract contradict anything as set forth in the ITB or the response to the ITB, then the terms and conditions of this Contract shall be binding and in full force and effect to the extent of any inconsistency.
- 1.4 This is a non-exclusive contract. The CITY may, in its sole and absolute discretion, utilize other parties to provide any of the services listed in the ITB, or any aspect of the Services if the CITY deems it to be in the best interest of the CITY.
- 1.5 CONTRACTOR acknowledges and agrees that the Contract Administrator has no authority to make changes that would increase, decrease, or otherwise modify the Scope of Services to be provided under this Contract.

## ARTICLE 2

### TERM AND TIME OF PERFORMANCE

- 2.1 The initial Contract term shall commence upon final execution of the Contract by the CITY and shall expire \_\_\_\_\_ (\_\_) years from that date. The CITY reserves the right to extend the Contract for \_\_\_\_\_ (\_\_) additional one (1) year term(s) providing all terms conditions and specifications remain the same, both parties agree to the extension, and such extension is approved by the CITY. The CONTRACTOR shall be compensated for the service at the rate in effect when this extension clause is invoked by the CITY.
- 2.2 Time shall be deemed to be of the essence in performing the duties, obligations and responsibilities required by this Contract.

## ARTICLE 3

### COMPENSATION

- 3.1 CITY agrees to pay CONTRACTOR, in the manner specified herein, the amounts set forth in CONTRACTOR's Response for work actually performed and completed pursuant to this Contract, which amount shall be accepted by CONTRACTOR as full compensation for all such work. It is acknowledged and agreed by CONTRACTOR that this amount is the maximum payable and constitutes a limitation upon CITY's obligation to compensate CONTRACTOR for its services related to this

Contract. This amount, however, does not constitute a limitation, of any sort, upon CONTRACTOR's obligation to perform all items of work required by or which can be reasonably inferred from the Scope of Services. No amount shall be paid to CONTRACTOR to reimburse its expenses.

- 3.2 CONTRACTOR may submit invoices for compensation no more often than on a monthly basis, but only after the services for which the invoices are submitted have been completed. An original invoice plus one copy are due within fifteen (15) days of the end of the month except for the final invoice which must be received no later than sixty (60) days after this Contract expires. Invoices shall designate the nature of the services performed and/or the expenses incurred and may be in form as determined by the CITY.
- 3.3 CITY shall pay CONTRACTOR within thirty (30) calendar days of receipt of CONTRACTOR's proper invoice. To be deemed proper, all invoices must comply with the requirements set forth in this Contract and must be submitted on the form and pursuant to instructions prescribed by the Contract Administrator. Payment may be withheld for failure of CONTRACTOR to comply with any term, condition, or requirement of this Contract.
- 3.4 Notwithstanding any provision of this Contract to the contrary, CITY may withhold, in whole or in part, payment to the extent necessary to protect itself from loss on account of inadequate or defective work which has not been remedied or resolved in a manner satisfactory to the Contract Administrator or failure to comply with this Contract. The amount withheld shall not be subject to payment of interest by CITY.

#### ARTICLE 4

#### INDEMNIFICATION

CONTRACTOR shall at all times hereafter indemnify, hold harmless and, at the CITY Attorney's option, defend or pay for an attorney selected by the CITY Attorney to defend CITY, its officers, agents, servants, and employees from and against any and all causes of action, demands, claims, losses, liabilities and expenditures of any kind, including attorney fees, court costs, and expenses, caused or alleged to be caused by intentional or negligent act of, or omission of, CONTRACTOR, its employees, agents, servants, or officers, or accruing, resulting from, or related to the subject matter of this Contract including, without limitation, any and all claims, losses, liabilities, expenditures, demands or causes of action of any nature whatsoever resulting from injuries or damages sustained by any person or property. In the event any lawsuit or other proceeding is brought against CITY by reason of any such claim, cause of action or demand, CONTRACTOR shall, upon written notice from CITY, resist and defend such lawsuit or proceeding by counsel satisfactory to CITY or, at CITY's option, pay for an attorney selected by CITY Attorney to defend CITY. The provisions and obligations of this section shall survive the expiration or earlier termination of this Contract. To the extent considered necessary by the Contract Administrator and the CITY Attorney, any sums due CONTRACTOR under this Contract may be retained by CITY until all of CITY's claims for indemnification pursuant to this Contract have been settled or otherwise resolved; and any amount withheld shall not be subject to payment of interest by CITY.

Nothing herein shall be deemed a waiver or limitation on CITY'S sovereign immunity or any limitations on CITY liability in any state statute or as otherwise provided by law.

#### ARTICLE 5

INSURANCE

CONTRACTOR shall provide the insurance to the extent required in the ITB. Evidence of said insurance shall be provided within ten (10) days of execution by the City of this Contract or prior to the commencement of any work, whichever event occurs first.

ARTICLE 6TERMINATION OR SUSPENSION

- 6.1 This Contract may be terminated for convenience by the CITY. Termination for convenience by the CITY shall be effective on the termination date stated in written notice provided by CITY, which termination date shall be not less than thirty (30) days after the date of such written notice. This Contract may also be terminated by the CITY Manager upon such notice as the CITY Manager deems appropriate under the circumstances in the event the CITY Manager determines that termination is necessary to protect the public health or safety. The parties agree that if CITY erroneously, improperly or unjustifiably terminates for cause, such termination shall be deemed a termination for convenience, which shall be effective thirty (30) days after such notice of termination for cause is provided.
- 6.2 This Contract may be terminated for cause for reasons including, but not limited to, CONTRACTOR's repeated (whether negligent or intentional) submission for payment of false or incorrect bills or invoices, failure to suitably perform the work; or failure to continuously perform the work in a manner calculated to meet or accomplish the objectives as set forth in this Contract.
- 6.3 Notice of termination shall be provided in accordance with the "NOTICES" section of this Contract except that notice of termination by the CITY Manager, which the CITY Manager deems necessary to protect the public health, safety, or welfare may be verbal notice that shall be promptly confirmed in writing in accordance with the "NOTICES" section of this Contract.
- 6.4 In the event this Contract is terminated for convenience, CONTRACTOR shall be paid for any services properly performed under the Contract through the termination date specified in the written notice of termination. CONTRACTOR acknowledges and agrees that it has received good, valuable and sufficient consideration from CITY, the receipt and adequacy of which are, hereby acknowledged by CONTRACTOR, for CITY's right to terminate this Contract for convenience.
- 6.5 In the event this Contract is terminated for any reason, any amounts due CONTRACTOR shall be withheld by CITY until all documents are provided to CITY pursuant to Section 8.1 of Article 8.
- 6.6 Should at any time during the term of this Contract, including any option terms, the CONTRACTOR is in violation of any of the terms and conditions of this Contract, the CITY shall have the right to suspend the CONTRACTOR until the violation is resolved to the satisfaction of the CITY. If the violation is not promptly resolved or is of such serious

nature that the CITY determines that suspension is not adequate, the CITY reserves the right to terminate for cause.

6.6.1 In the event a CONTRACTOR is terminated, the CITY may assign the Contract to another CONTRACTOR, or seek a new CONTRACTOR, until the Contract is re-let, or until the end of the Contract term then in effect, at its sole option and shall reserve all legal remedies for damages and other relief.

## ARTICLE 7

### EEO AND ADA COMPLIANCE

- 7.1 CONTRACTOR shall not unlawfully discriminate on the basis of race, color, national origin, sex, religion, age, political affiliation or disability in the performance of this Contract, the solicitation for or purchase of goods or services relating to this Contract, or in subcontracting work in the performance of this Contract. CONTRACTOR shall include the foregoing or similar language in its contracts with any subcontractors or sub consultants, except that any project assisted by the U.S. Department of Transportation funds shall comply with the non-discrimination requirements in 49 C.F.R. Parts 23 and 26, as amended. Failure to comply with the foregoing requirements is a material breach of this Contract, which may result in the termination of this Contract or such other remedy as CITY deems appropriate.
- 7.2 CONTRACTOR shall not unlawfully discriminate against any person in its operations and activities or in its use or expenditure of funds in fulfilling its obligations under this Contract. CONTRACTOR shall affirmatively comply with all applicable provisions of the Americans with Disabilities Act (ADA) in the course of providing any services funded by CITY, including Titles I and II of the ADA (regarding nondiscrimination on the basis of disability), and all applicable regulations, guidelines, and standards. In addition, CONTRACTOR shall take affirmative steps to ensure nondiscrimination in employment against disabled persons.

## ARTICLE 8

### MISCELLANEOUS

#### 8.1 RIGHTS IN DOCUMENTS AND WORK

Any and all reports, photographs, surveys, and other data and documents provided or created in connection with this Contract are and shall remain the property of CITY; and, if a copyright is claimed, CONTRACTOR grants to CITY a non-exclusive license to use the copyrighted item(s) indefinitely, to prepare derivative works, and to make and distribute copies to the public. In the event of termination of this Contract, any reports, photographs, surveys, and other data and documents prepared by CONTRACTOR, whether finished or unfinished, shall become the property of CITY and shall be delivered by CONTRACTOR to the Contract Administrator within seven (7) days of termination of this Contract by either party. Any compensation due to CONTRACTOR shall be withheld until all documents are received as provided herein.



## 8.2 AUDIT RIGHT AND RETENTION OF RECORDS

CITY shall have the right to audit the books, records, and accounts of CONTRACTOR and its subcontractors that are related to this Project. CONTRACTOR and its subcontractors shall keep such books, records, and accounts as may be necessary in order to record complete and correct entries related to the Project. All books, records, and accounts of CONTRACTOR and its subcontractors shall be kept in written form, or in a form capable of conversion into written form within a reasonable time, and upon request to do so, CONTRACTOR or its subcontractor, as applicable, shall make same available at no cost to CITY in written form.

CONTRACTOR and its subcontractors shall preserve and make available, at reasonable times for examination and audit by CITY, all financial records, supporting documents, statistical records, and any other documents pertinent to this Contract for the required retention period of the Florida Public Records Act, Chapter 119, Florida Statutes, as may be amended from time to time, if applicable, or, if the Florida Public Records Act is not applicable, for a minimum period of three (3) years after termination of this Contract. If any audit has been initiated and audit findings have not been resolved at the end of the retention period or three (3) years, whichever is longer, the books, records, and accounts shall be retained until resolution of the audit findings. If the Florida Public Records Act is determined by CITY to be applicable to CONTRACTOR's and its subcontractors' records, CONTRACTOR and its subcontractors' records, CONTRACTOR and its subcontractors shall comply with all requirements thereof; specifically to:

- Keep and maintain all records that ordinarily and necessarily would be required by the City to perform the service.
- Provide the public with access to public records on the same terms and conditioned that the City would provide for the records and at a cost that does not exceed the cost provided in Chapter 119, or as otherwise provided by law.
- Ensure the public records that are exempt or confidential and exempt from public records disclosure are not disclosed except as authorized by law.
- Meet all requirements for retaining public records and transfer, at no cost, to the City all public records in possession of the Contractor upon termination of the contract and destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements All records stored electronically must be provided to the public agency in a format that is compatible with the information technology systems to the public agency.
- If CONTRACTOR does not comply with this section, the City shall enforce the contract in accordance with the contract provisions and may unilaterally cancel this contract in accordance with state law.

No confidentiality of non-disclosure requirement of either federal or state law shall be violated by CONTRACTOR or its subcontractors. Any incomplete or incorrect entry in such books, records, and accounts shall be a basis for City's disallowance and recovery of any payment upon such entry.

CONTRACTOR shall, by written contract, require its subcontractors to agree to the requirements and obligations of this section 8.2.

8.3 BACKGROUND CHECKS: The City reserves the right to require background checks of any personnel assigned by the successful proposer to perform services under this contract.

8.4 COMPLAINTS AND DISPUTES:

All complaints concerning misconduct on the part of the CONTRACTOR or disputes between CITY staff and the CONTRACTOR are referred to the CITY Manager or his/her designee, who shall conduct investigations and inquiries, including discussions with the CONTRACTOR and involved staff. The determinations of the CITY Manager or designee shall be binding upon the parties, and failure of the CONTRACTOR to follow any such determination could be considered a material breach and subject the CONTRACTOR to termination for cause. The CONTRACTOR agrees that any complaints received by the CITY concerning misconduct on the part of the CONTRACTOR, such as excessive charges, poor business practices etc., will be referred to the Office of the CITY Manager for appropriate action. The CONTRACTOR agrees to make any complaints concerning the CITY available to the Office of the CITY Manager for action as required.

8.5 PUBLIC ENTITY CRIME ACT

CONTRACTOR represents that the execution of this Contract will not violate the Public Entity Crime Act, Section 287.133, Florida Statutes, as may be amended from time to time, which essentially provides that a person or affiliate who is a contractor, consultant, or other provider and who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to CITY, may not submit a bid on a contract with CITY for the construction or repair of a public building or public work, may not submit bids on leases of real property to CITY, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with CITY, and may not transact any business with CITY in excess of the threshold amount provided in Section 287.017, Florida Statutes, as may be amended from time to time, for category two purchases for a period of 36 months from the date of being placed on the convicted vendor list. Violation of this section shall result in termination of this Contract and recovery of all monies paid by CITY pursuant to this Contract, and may result in debarment from CITY's competitive procurement activities.

In addition to the foregoing, CONTRACTOR further represents that there has been no determination, based on an audit, that it committed an act defined by Section 287.133, Florida Statutes, as a "public entity crime" and that it has not been formally charged with committing an act defined as a "public entity crime" regardless of the amount of money involved or whether CONTRACTOR has been placed on the convicted vendor list.

8.6 INDEPENDENT CONTRACTOR

CONTRACTOR is an independent contractor under this Contract. Services provided by CONTRACTOR pursuant to this Contract shall be subject to the supervision of CONTRACTOR. In providing such services, neither CONTRACTOR nor its agents shall act as officers, employees, or agents of CITY. No partnership, joint venture, or other joint relationship is created hereby. CITY does not extend to CONTRACTOR or CONTRACTOR's agents any authority of any kind to bind CITY in any respect whatsoever. CONTRACTOR IS BEING HIRED FOR ITS TRAINING, EDUCATION, AND EXPERIENCE AND WILL NOT BE TRAINED BY THE CITY. THE CONTRACTOR SHALL PROVIDE ITS SERVICES BASED ON ITS TRAINING AND EXPERIENCE AND SHALL DETERMINE THE APPROPRIATE AND PROFESSIONAL MANNER IN WHICH TO PROVIDE THE SERVICES PROVIDED FOR HEREIN.

In providing the services, CONTRACTOR shall determine the employees and subcontractors necessary to provide the services and shall be responsible for their supervision. CONTRACTOR shall be entitled to no CITY employment benefits of any kind whatsoever.

#### 8.7 THIRD PARTY BENEFICIARIES

Neither CONTRACTOR nor CITY intends to directly or substantially benefit a third party by this Contract. Therefore, the parties agree that there are no third party beneficiaries to this Contract and that no third party shall be entitled to assert a right or claim against either of them based upon this Contract.

#### 8.8 NOTICES

Whenever either party desires to give notice to the other, such notice must be in writing, sent by certified United States Mail, postage prepaid, return receipt requested, or sent by commercial express carrier with acknowledgement of delivery, or by hand delivery with a request for a written receipt of acknowledgment of delivery, addressed to the party for whom it is intended at the place last specified. The place for giving notice shall remain the same as set forth herein until changed in writing in the manner provided in this section. For the present, the parties designate the following:

## 8.9 ASSIGNMENT AND PERFORMANCE

Neither this Contract nor any right or interest herein shall be assigned, transferred, or encumbered without the written consent of the other party. CITY may terminate this Contract, effective immediately, if there is any assignment, or attempted assignment, transfer, or encumbrance, by CONTRACTOR of this Contract or any right or interest herein without CITY's written consent.

CONTRACTOR represents that each person who will render services pursuant to this Contract is duly qualified to perform such services by all appropriate governmental authorities, where required, and that each such person is reasonably experienced and skilled in the area(s) for which he or she will render his or her services.

CONTRACTOR shall perform its duties, obligations, and services under this Contract in a skillful and respectable manner. The quality of CONTRACTOR's performance and all interim and final product(s) provided to or on behalf of CITY shall be comparable to the best local and national standards.

## 8.10 CONFLICTS

Neither CONTRACTOR nor its employees shall have or hold any continuing or frequently recurring employment or contractual relationship that is substantially antagonistic or incompatible with CONTRACTOR's loyal and conscientious exercise of judgment and care related to its performance under this Contract.

CONTRACTOR further agrees that none of its officers or employees shall, during the term of this Contract, serve as an expert witness against CITY in any legal or administrative proceeding in which he, she, or CONTRACTOR is not a party, unless compelled by court process. Further, CONTRACTOR agrees that such persons shall not give sworn testimony or issue a report or writing, as an expression of his or her expert opinion, which is adverse or prejudicial to the interests of CITY in connection with any such pending or threatened legal or administrative proceeding unless compelled by court process. The limitations of this section shall not preclude CONTRACTOR or any persons in any way from representing themselves, including giving expert testimony in support thereof, in any action or in any administrative or legal proceeding.

In the event CONTRACTOR is permitted pursuant to this Contract to utilize subcontractors to perform any services required by this Contract, CONTRACTOR agrees to require such subcontractors, by written contract, to comply with the provisions of this section to the same extent as CONTRACTOR.

## 8.11 MATERIALITY AND WAIVER OF BREACH

CITY and CONTRACTOR agree that each requirement, duty, and obligation set forth herein was bargained for at arms-length and is agreed to by the parties in exchange for quid pro quo, that each is substantial and important to the formation of this Contract and that each is, therefore, a material term hereof.

CITY's failure to enforce any provision of this Contract shall not be deemed a waiver of such provision or modification of this Contract. A waiver of any breach of a provision of this Contract shall not be deemed a waiver of any subsequent breach and shall not be construed to be a modification of the terms of this Contract.

8.12 COMPLIANCE WITH LAWS

CONTRACTOR shall comply with all applicable federal, state, and local laws, codes, ordinances, rules, and regulations in performing its duties, responsibilities, and obligations pursuant to this Contract.

8.13 SEVERANCE

In the event a portion of this Contract is found by a court of competent jurisdiction to be invalid, the remaining provisions shall continue to be effective unless CITY or CONTRACTOR elects to terminate this Contract. An election to terminate this Contract based upon this provision shall be made within seven (7) days after the finding by the court becomes final.

8.14 JOINT PREPARATION

Each party and its counsel have participated fully in the review and revision of this Contract and acknowledge that the preparation of this Contract has been their joint effort. The language agreed to expresses their mutual intent and the resulting document shall not, solely as a matter of judicial construction, be construed more severely against one of the parties than the other. The language in this Contract shall be interpreted as to its fair meaning and not strictly for or against any party.

8.15 JURISDICTION, VENUE, WAIVER OF JURY TRIAL

This Contract shall be interpreted and construed in accordance with and governed by the laws of the state of Florida. All parties agree and accept that jurisdiction of any controversies or legal problems arising out of this Contract, and any action involving the enforcement or interpretation of any rights hereunder, shall be exclusively in the state courts of the Seventeenth Judicial Circuit in Broward County, Florida, and venue for litigation arising out of this Contract shall be exclusively in such state courts, forsaking any other jurisdiction which either party may claim by virtue of its residency or other jurisdictional device. **BY ENTERING INTO THIS CONTRACT, CONTRACTOR AND CITY HEREBY EXPRESSLY WAIVE ANY RIGHTS EITHER PARTY MAY HAVE TO A TRIAL BY JURY OF ANY CIVIL LITIGATION RELATED TO THIS CONTRACT.**

8.16 AMENDMENTS

No modification, amendment, or alteration in the terms or conditions contained herein shall be effective unless contained in a written document prepared with the same or similar formality as this Contract and executed by the CITY and CONTRACTOR or others delegated authority to or otherwise authorized to execute same on their behalf.

**8.17 PRIOR CONTRACTS**

This document represents the final and complete understanding of the parties and incorporates or supersedes all prior negotiations, correspondence, conversations, Contracts, and understandings applicable to the matters contained herein. The parties agree that there is no commitment, Contract, or understanding concerning the subject matter of this Contract that is not contained in this written document. Accordingly, the parties agree that no deviation from the terms hereof shall be predicated upon any prior representation or Contract, whether oral or written.

**8.18 INCORPORATION BY REFERENCE**

The truth and accuracy of each "Whereas" clause set forth above is acknowledged by the parties. The ITB, Exhibit "A", the CONTRACTOR'S Response, Exhibit "B", and the attached Exhibits \_\_\_\_\_ are incorporated into and made a part of this Contract.

**8.19 REPRESENTATION OF AUTHORITY**

Each individual executing this Contract on behalf of a party hereto hereby represents and warrants that he or she is, on the date he or she signs this Contract, duly authorized by all necessary and appropriate action to execute this Contract on behalf of such party and does so with full legal authority.

**8.20 MULTIPLE ORIGINALS**

Multiple copies of this Contract may be executed by all parties, each of which, bearing original signatures, shall have the force and effect of an original document.
