The qualifications shall indicate the scope of services to be completed by any sub-consultants.

The City will evaluate the current prequalification statements on file for those submitting qualifications and choose several firms who would make viable candidates from which to invite proposals and/or presentations. The factors that will be considered in evaluation of proposals are:

- a. Past experience in the required disciplines with TDOT and other clients.
- b. Past experience specific to traffic safety improvements and streetscape projects.
- c. Qualification and availability of staff.
- d. Demonstrated ability to meet schedules without compromising sound engineering practice.
- e. Evaluations on prior projects with TDOT and other clients, if available.
- f. Size of project.
- g. Amount of work under contract with TDOT and other clients.
