Franklin County is requesting a bid for Builders Risk insurance from qualified insurance companies.

- 1. The responding insurance companies should meet the following criteria:
 - a. Licensed in the state of Missouri
 - b. AM Best rating of A or higher
 - c. Coverage must be written on special form with replacement costs
- 2. The following information may be used to quote:
 - a. Location of the project: #1 Bruns Lane, Union, MO 63084
 - b. Total Number of Structures: One (two additions to original structure)
 - c. Completed Value of Structure: approximately \$30,000,000
 - d. Number of stories: Small addition is one story, Jail addition has one story and in jail area is one story with a partial mezzanine
 - e. Total square footage: Two additions are 57, 532 sqft total (4,580 plus 52,952), Remodeled component is 49,140 sqft
 - f. Flood and Earthquake Sublimit required:
 - g. Contractor on the project: TBD
 - h. Construction Budget: \$25,772,284
 - i. Any Soft Costs included in the budget: Soft costs are not included above current budget for soft costs is \$4,699,531
 - j. Timeline of the project: new addition estimated to begin construction late May, 2019 and extend through October 2020, remodel estimated to begin construction October 2020 and extend through May 2021
- 2. Project is fully sprinklered, load bearing masonry walls with structural steel.
- 3. The jail will be occupied while construction is taking place.
- 4. Since the jail is occupied, there will be foot patrols around the exterior after hours.
- 6. Construction Phase Estimates are as follows:
 - a. Phase I (Areas 1, 2, 4) New Construction/ Additions to existing building. Existing building will remain occupied during new construction. Approximately May 2019-October 2020, Hard Construction costs \$22,500,000

- b. Phase II (Areas 3, 5, 6, 7, 9) Remodel of Existing Building/Partially occupied during renovation. Approximately November 2020 April 2021, Hard Construction costs \$3,100,000
- c. Phase III covered under existing policy
- 7. Bidders to submit separate bids for Phase I and Phase II.
