

## INVITATION TO BIDDERS

The City of Gatlinburg is accepting sealed bids on the supply and delivery of vehicle service supplies to various City Departments. Supplies shall consist of oils, grease, lubricants, and other miscellaneous supplies for the period of twenty-four (24) months.

The City of Gatlinburg reserves the right to extend the contract for an additional twenty-four (24) months. Bulk of deliveries shall be made to the Gatlinburg Service Center on Newman Road, with other locations listed in bid specifications.

Bid forms and specifications may be obtained from Delea Patterson, AP/Purchasing, Gatlinburg City Hall, 1230 Parkway East, Suite 2, P.O. Box 5, Gatlinburg, Tennessee 37738, Telephone Number (865) 436-1409. Email: deleap@gatlinburgtn.gov.

Bid specifications will also be available on the City of Gatlinburg website at www.gatlinburgtn.gov under "Out for Bids" tab. This bid tab is located under Gatlinburg Government, and then Purchasing. Bid results are posted in the same area as shortly after bid opening as possible.

Bids shall be received until **2:30 p.m.**, **May 26, 2016**, at which time they will be publicly opened and read aloud. No bid may be withdrawn for thirty (30) days.

Bids shall be submitted in a sealed envelope with the Bidder's name, address, date and time of the bid opening, and the Quotation "Bid on Service Supplies" stated clearly on the outside of the envelope containing the bid.

The City of Gatlinburg reserves the right to waive any informalities in, or to reject any or all bids and to accept the bid deemed most favorable to the interests of the City.

## GENERAL PROVISIONS

Prices quoted shall not include Federal or State taxes, if any are applicable. The successful bidder shall furnish tax exemption forms, if required, with their invoices.

The prices quoted are that for which the materials or services will be delivered F.O.B. Gatlinburg, Tennessee.

Any additions, deletions, or variations from the following specifications must be noted.

Inspection of the materials or equipment will be made by an agent of the City of Gatlinburg, and if found defective or fails in any way to meet the terms of this agreement, it will be rejected. Rejected materials or equipment will be replaced at the expense of the bidder.

The City of Gatlinburg reserves the right to purchase additional units or services under the same terms and conditions for a period of twenty-four (24) months if mutually agreeable with vendor.

The City of Gatlinburg and/or the successful bidder shall cancel this agreement with a thirty (30) day written notice due to an escalation in pricing by either party.

The City of Gatlinburg reserves the right to defer payment for thirty (30) days after delivery. The City of Gatlinburg also reserves the right to reject any and/or all bids.

The bidder agrees to indemnify the City of Gatlinburg from any and all liability, loss or damage the City may suffer as a result of claims, demands, costs, or judgments against it arising from any and all work under this agreement.

The bidder agrees to notify the City, in writing, within thirty (30) days, by registered mail, at the City's address as stated in this agreement, of any claim against the bidder on the obligations indemnified against.

It is the policy of the City of Gatlinburg not to discriminate on the basis of race, color, national origin, age, sex, or disability in its hiring and employment practices, or in admission to, access to, or operation of its programs, services and activities. With regard to all aspects of this contract, contractor certifies and warrants it will comply with this policy.

## <u>SPECIFICATIONS FOR VEHICLE SERVICE SUPPLIES</u>

- 1. Twenty-four (24) month delivery of the following supplies:
  - a. 275 gallon x 3 per year 5w-30 Pennzoil or equal motor oil in 60" tall x 27" wide x 44" long bulk tank CD/CC/SJ specifications.
  - b. 275 gallon x 3 per year 10w hydraulic oil in 60" tall x 27" wide x 44" long bulk tank (Shell Spirax S4TXM or Equal) specifications.
  - c. 275 gallon x 3 per year 15w-40 diesel motor oil in 60" tall x 27" wide x 44" long bulk tank CD/CC/SJ specifications, (Mobil Delvac 1300 or equal)
  - d. 1 x 55 gallon gear lube 75 w 90 synthetic in 55 gallon containers (Shell Spirax 56 or equal)
  - e. 100 gallons 80w/140 gear lube in 35 gallon containers posi-traction formula
  - f. 80-90 tubes chassis grease moly base (price based on 80)
  - g. 8 cases (12 per case) power steering fluid OEM specifications (12oz. bottles)

- 2. All deliveries will be made as ordered to the Gatlinburg Service Center on Newman Road or other City Departments as necessary.
  - 2a. Orders will be taken by a sales representative on site every two (2) weeks.
- 3. Deliveries will be made on an on-call basis within 24 hours of notification.
- 4. The City of Gatlinburg will be billed for deliveries by the 5th of each month and payment will be made by the last day of each month.
- 5. Any escalation clause will be included in the bid. Price increases shall only be accepted as are passed on to the supplier, with approval of the City. Price changes may be reason for cancellation by the City.
- 6. <u>SUBMISSION OF BIDS</u>: Bids shall be submitted in a sealed envelope. The envelope shall be addressed to the City of Gatlinburg and shall be identified on the outside with the Bidder's name and address, the project name "Bid on Service Supplies",

the date and time of the bid opening and such other information as the Bidder may feel necessary to identify it as a sealed bid and prohibit its premature opening. Bids may be submitted and withdrawn up to the bid opening time. Modification must be <u>received in writing</u> prior to the time of the bid opening.

- 7. Bid may be revoked at anytime for failure to meet any of the above specifications.
- 8. In the event that the contract is extended for an additional twenty-four (24) months from the expiration of the first contract, the additional twenty-four (24) month contract shall contain a non-appropriations clause such that should funds not be appropriated for the execution of this contract during any fiscal year, of the contract period, the contract shall be cancelled.
