### REPLACEMENT ROOFING SYSTEM FOR WARNER PARK STORAGE BARN FOR CITY OF CHATTANOOGA, TENNESSEE

The project consists of the following major elements of construction including but not limited:

Repair of the existing roofing system at the Warner Park Storage Barn in Warner Park, 301 N. Holtzclaw Ave., 37402. The existing metal roof is to be repaired and coated with a silicone roofing coating system from a contractor and manufacturer capable of providing a minimum 10 year warranty. Additional work consists of removal of skylights, replacement of metal decking, rooftop vents, and gutters and downspouts, installation of new wall vents, and repair of metal siding. An alternate bid will be requested on installation of a flute filler TPO system for the roof with similar additional work and a 20 year warranty.




