

### Specifications for Tire Recapping Blanket Contract

The City of Chattanooga is seeking bids for a blanket contract for recapping and, when necessary, repairing and recapping tires for the City of Chattanooga fleet vehicles.

## Scope:

- Recapping of all truck tire sizes as specified on the bid document
- Section repairs will be separate cost item
- Wheel reconditioning will be a separate cost item

All repairs other than section repairs shall be built in to the price of the recapped tire bid. This excludes nail holes and bead repair.

The City of Chattanooga time limit for turnaround of these recapped tires will be seven (7) working days.

### NOTE:

Quantities shown on the Bid Document form are estimated annual usage. Prices per tire should be submitted.

### Clarification of Item Descriptions

The item descriptions which specify the Michelin retread process are hereby amended to also include the Bandag and/or Goodyear retread processes as well.

Any of these three (3) retread processes are acceptable for bidding this blanket contract.

### Affirmative Action Plan

The City of Chattanooga is an equal opportunity employer and during the performance of this Contract, the Contractor agrees to abide by the equal opportunity goals of the City of Chattanooga as follows:

- 1. The Contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, national origin, or handicap.
