For a “no-bid” response, return the signature page signed and marked “no bid”. Non-response may result in removal from active bidders list.

The attached specifications are being provided to potential bidders as guidelines that describe the type and quality of equipment, supply, and/or service the City of Decatur is seeking to purchase. The bidder must indicate compliance or list exceptions to each specification item for consideration. Failure to comply with this provision could be cause for rejection of the bid.

Bid responses must be received in the office of the Purchasing Department not later than the date and time specified.

The Purchasing Department will not accept facsimile (fax) nor email transmissions of bids.

Changes or modifications of this Invitation to Bid are allowed only by written authority of the Purchasing Agent.

Non Appropriation of Funds: Continuation of any agreement between the City of Decatur and a bidder beyond a fiscal year is contingent upon continued legislative appropriation of funds for the purpose of this bid and any resulting agreement. Non availability of funds at any time shall cause any agreement to become void and unenforceable and no liquidated damages shall accrue to the City as a result. The City will not incur liability beyond the payment of accrued agreement payment.

Descriptive Literature: Reference to brand names and numbers is not restrictive, unless otherwise specified. Bids on equivalent items meeting the standards of quality indicated will be considered, providing the bid clearly describes the item offered and indicates how it differs from the referenced brands. Descriptive

literature on any supplemental information necessary for comparison purposes shall be submitted with the bid or the Purchasing Agent may reject the bid for that item. Reference to literature submitted with a previous bid, or on file with the Purchasing Department will not satisfy this requirement.

The City of Decatur reserves the right to modify all or any portion of this Invitation to Bid when the best interest of the City is involved. The City reserves the right to award this bid to a single vendor or multiple vendors when in the best interest of the City.

The City of Decatur reserves the right to seek clarification of bid responses from vendors submitting responses.

The City of Decatur is exempt from all Federal, sales and use taxes.

All bidders shall maintain such insurance as will protect bidder and the City of Decatur from claims under Workman's Compensation Acts and from claims for damage and or personal injury, including death, which may arise from the operation and/or fulfillment of the resulting contract of this Invitation to Bid. Insurance shall be written by companies authorized to do business in Decatur, Alabama. Evidence of insurance shall be furnished to the City of Decatur Purchasing Department with submitted bids when requested.

Any individual, company, or corporation doing business with the City of Decatur must possess and show proof thereof all proper licenses and/or proper certifications required by Federal, state and local statutes and regulations prior to award when requested.

The City of Decatur reserves the right to terminate any contract resulting from this bid for just and reasonable cause whereby it appears to be in the best interest of the City.

The successful bidder agrees, by entering into this contract, to defend, indemnify, and hold the City of Decatur harmless from any and all causes of action or claims of damages arising out of or related to bidder's performance under this contract.

Item 1 Description:

Thermoplastic Supply Haul Trailer

1. 2019 18' Bumper Pull Titan Trailer with drop deck.
2. 16,000 lb total GVW
3. 8 Bolt Hubs w/ 5/8" Studs.
4. 2 5/16" ball hitch for towing.
5. Electric Brakes on all 4 Wheels.
6. Spare Tire- 235/R16 - 14 ply Tire.
7. Sealed Beam Recessed L.E.D. Lights.
8. Breakaway Battery Box with Charger and Tester.
9. Coated Interframe Under Floor.
10. 7-Prong heavy cord installed.
11. Single Spring Loaded Dual Pin Jack.
12. 96"W x 96"L drop deck and 96"W x 120"L upper deck.
13. Pressure treated 2"x8" Floor Boards
14. Pierced beam for 21" height deck.
15. 3" Crossmembers on 16" Centers
16. Deck height over axles, 36".
17. Ground clearance from drop deck frame 10".
18. Two (2) 84" x 72" wide spring loaded ramps with 2" inch tubing and raised expanded metal.
19. Trailer painted BLACK
20. Conspicuity tape mounted around the steel bed.
21. Two (2) LED flood lights to illuminate MM400 loading area, deck area and rear trailer area.
22. Fabricated steel riser to raise pre-melter off rear deck. Includes two (2) popping pans.

Item 2 Description:

Skid-mounted, diesel fired, air-jacketed, vertical design thermoplastic pre-melting kettle set ((2) 4,000 lbs. / total melting capacity). Minimum 21 HP liquid cooled diesel hydraulic power plant, hydraulic pump, hydraulic reservoir.

1. Self-contained "Hi-torque" hydraulic agitator drive motors with directional control valves.
2. "Auger" enhanced steel agitator shaft assemblies.
3. Steel abrasion resistant agitators shaft assemblies with replaceable hardened "stub" shafts and replaceable hardened bushings.
4. High temperature ceramic insulation installed on combustion chamber floor.
5. Thermostatically controlled, automatic electronic ignition system with fuel safety shutdown feature.
6. Anti-splash material feed chutes with safety "flash" deflectors.
7. Two (2) internal plug type material outlet valves mounted on the melter body.
8. Stainless steel lined burner compartments with floating stainless steel deflector plates to enhance burner compartment durability.
9. Minimum 2" Insulation jacket between material tank and exterior panels for superior heat retention and operator safety.
10. Removable steel feed step assembly with side handrails.
11. Fork-lift channels installed in melter base.
12. Custom fabricated steel riser with (2) two popping pans to lift the melter off the deck area of the trailer.

Item 3 Description:

Self-propelled thermoplastic ride-on detail striper

1. Welded tubular steel frame.
2. 4-wheel self-propelled chassis with rear steering via a dual wheel, rear pivot steering system.
3. Minimum 25hp LPG engine with electric start to power the hydraulic system. Engine hour meter.
4. Hydrostatic one pedal forward, 0-7.5 mph (0-12km) and reverse drive system with disc emergency/ parking brake.
5. 400lb. / 182kg. capacity oil jacketed non-pressurized thermoplastic material tank with integral thermoplastic material pump. Electronically controlled Pump RPM with RPM indicator gauge.
6. Thermostatically controlled LPG heat transfer oil heating system with oil circulation pump and digital controls.
7. Ribbon extrusion gun with adjustable slides that allow application widths of 4" – 13" (10cm - 33 cm).

8. Ribbon extrusion gun air lift control with locking pin for transport.
9. Single drop glass bead system with 100lb. / 45kg bead hopper, three (3) glass bead guns equipped with adjustable air injection system. Double Drop Bead System.
10. 8 cfm 110psi air compressor with adjustable air unloader and moisture separator for glass bead system, operating solenoids, ribbon gun lift and thermoplastic material “blow down” system.
11. Electrical control console with electronic burner control, gun on/off switches, gun test switches, pilot light and remote E-Stop engine shutdown switch. Skip-Line MST-14 timing system.
12. Adjustable alignment pointer guide equipped with operator activated air lift.
13. Safety lighting package as follows: Three (3) LED night lights - one to illuminate material tank fill port, one to illuminate forward work area and one to illuminate the application gun carriage. Two (2) LED amber strobes. One mounted on the rear of the unit, one mounted on a vertical mast above the machine.
14. 40 LB. LPG tank with mounting hardware. 10 LB. fire extinguisher and mount.
15. Secure travel latch built on front of machine, steel latch lock to install on trailer bed.
16. Powder coat options of Signal Yellow, Safety White, Traffic Orange and Lime Squeeze Green with silver material tank.
