More specifically the work includes, but is not limited to, mobilization/demobilization; asphalt milling and re-surfacing; spot repairs to subgrade and base; grade adjustments at affected grate inlets and valve box covers; sanitary sewer manhole frame and cover replacements; traffic control; pavement markings and stop bars; installation of ADA compliant curb ramps at street intersections; complete surface restoration; and all other work and appurtenances required.

All work must be completed within 90 consecutive calendar days from receipt of written Notice to Proceed.

The bid bond shall be forfeited to the City of Waycross as liquidated damages if successful bidder fails to execute a Contract and provide Performance and Payment bonds within ten (10) days after being notified of contract award.
