PROJECT DESCRIPTION

Roadway and Streetscape Improvements for West 7th Street

This project involves roadway and streetscape improvements to West 7th Street (SR 99/US 412). The project is located in Columbia TN on West 7th St., between Beckett St. and High St. The work to be done consists of reconstruction of West 7th St. to include a three lane typical section, sidewalks and shared use path, bike lanes, streetscape features, landscaping, lighting, underground utilities, signalization and resurfacing. The total length of the project is 0.33 miles.
