# FOR Carnival Rides, Games, and Services PR 22-015

All responses due by September 3, 2021, 3:00 P.M., Local Time, Phoenix, Arizona. Please email your response to Jill Lin at <a href="mailto:jlin@avondaleaz.gov">jlin@avondaleaz.gov</a>.

<u>The Purpose</u>: The City of Avondale (the "City") Parks and Recreation Department is seeking one (1) qualified Carnival Company ("Contractor") to furnish, operate and provide amusement and carnival rides for Avondale special events that meets the requirements listed in this Informal Request for Proposal ("RFP") for a period of one year, with four renewable one-year options. Contractor must submit a response by following instruction in Section II.

#### Section I - Project Information

- 1.1. <u>Scope of Work:</u> The Contractor shall provide Carnival rides, games, food trailers and services for Billy Moore Days October 14 17, 2021.
  - 1.1.1. Billy Moore Days event Dates and Time of Operation

Thursday, October 14, 6pm-10pm Friday, October 15, 6pm-11pm Saturday, October 16, 11am-11pm Sunday, October 17, 12pm-10pm

In subsequent years it will be held the third week in October. The City reserves the right to modify schedule and will notify the Contractor in advance. The City may require additional services for other special events.

1.1.2. Location:

Deconcini Park 351 E. Wester Ave. Avondale, AZ 85323

- 1.1.3. Required Rides, Games and Food: Minimum 9 and maximum 15 adult & youth rides; and minimum 3 and maximum 10 skill-oriented games are to be provided.
  - 1.1.3.1. The adult rides may include, but are not limited to, a Ferris wheel, round-up, scrambler, swing, paratrooper, tilt-a-whirl, zipper and bumper cars.

- 1.1.3.2. The kiddie rides may include, but are not limited to, giant slide, boat, car or plane ride, carousel, etc. All rides shall generally be of high capacity.
- 1.1.3.3. The skill-oriented games may include, but are not limited to, basketball free-throw type games and balloon dart games.
- 1.1.3.4. Food concessions may include cotton candy, pizza, candy apples, corn dogs, hot dogs, ice cream, funnel cakes, and other similar foods. The City will approve the types of items sold at each trailer.
- 1.1.4. The event attracts\_up to 13,000 visitors each year, weather permitting, from throughout the Phoenix Metropolitan Area.
- 1.1.5. The event site is on grass in Deconcini Park, A map of the site is provided in Exhibit B.
- 1.1.6. For Kiddie rides where a responsible adult is expected to ride with a child, no ticket was required for the adult.
- 1.1.7. The amusement ride(s) for this specification must conform to all applicable ASTM (American Society for Testing and Materials) amusement ride standards in effect at the time of contract award.
- 1.1.8. The rides must adhere to the following conditions:
  - 1.1.8.1. Operating conditions must be able to set up on grass.
  - 1.1.8.2. The ride must be self-contained operationally.
  - 1.1.8.3. The proposed Rides must be able to occupy the space parameters allocated and have a proven history of being popular with children/family riders.
  - 1.1.8.4. The City, in consultation with the Contractor, will select the Rides most appropriate for the placement.
  - 1.1.8.5. Meet ADA accessibility requirements for the rides and the carnival operating area.
- 1.1.9. Provide all necessary labor and equipment to erect the rides. Access to the site on which the rides for the 2021 event are to be erected will be permitted at 6:00 am on Wednesday, October 13, 2021. The game trailers shall be permitted on the site for set-up at 6:00 a.m. on Wednesday, October 13, 2021. The rides will be appropriately located, securely erected and of such state of repair as to safeguard the health and safety of participants and all other persons while such equipment is located at the site of the Billy Moore Day.
- 1.1.10. Maintain, on site at the location of the rides, one (1) person at least 21 years of age capable of maintaining and supervising the operation of all rides and equipment. A qualified operator, minimum of 18 years of age and trained to operate the ride in a safe and proper manner shall be provided for each ride. Two (2) operators meeting the above criteria shall be provided, if necessary, to assist in the loading/unloading of passengers. One person, minimum of 21 years of age, must be provided for security at each of two emergency exits.

- Two (2) persons, at least 21 years of age, capable of interacting with the public, must be provided to assist at the ticket entrance gate
- 1.1.11. An amusement ride operator may deny entry to the amusement ride of any person if, in the opinion of the operator, the entry may jeopardize the safety of the person or any other amusement ride patron.
- 1.1.12. All rides shall be equipped with adequate stanchions to securely provide line control for rides and minimize the opportunity for line jumping. All high-capacity rides shall have line control to accommodate up to 100 riders. Other line controls shall accommodate up to 60 riders.
- 1.1.13. Supply all rides with electrical or generated power.
- 1.1.14. Operate and maintain all rides in such a manner as to avoid the creation of a nuisance, protect the health, safety and general welfare of its employees, persons in attendance or who use the rides at the event, and those who work or reside in the area where the event will be held. Rides to be provided shall be clean, well maintained, and painted as required. The Rides seating must be free of excessive wear, tears etc. The City reserves the right to refuse a ride which does not meet these standards.
  - 1.1.14.1. The Rides must be owned or leased by the Respondent amusement company and not subcontracted from a third party.
  - 1.1.14.2. The Contractor must be certified and possess all certification to operate amusements within the State of Arizona.
- 1.1.15. Contractor shall protect grass surfaces and other areas where the equipment may contact ground surfaces. Contractor shall not dispose used cooking oil on site.
- 1.1.16. The amusement company must provide a staff of properly trained and experienced personnel for all related operation, repairs and required maintenance of the Rides through the full stay at the event site. The City requires, at minimum, all onsite personnel have successfully passed illegal drug, criminal and sex offender screenings. All personnel are to adequately perform the following duties while the Rides are open to the public:
  - 1.1.16.1. Collect ride tickets or verify wristbands, load and unload passengers in a safe and orderly fashion, monitor the safety of the passengers in and around the rides, and, alert City Staff of any safety concerns.
- 1.1.17. The Contractor shall be responsible for the sale and collection of carnival and game tickets. All revenues collected will be submitted to the City at the end of each day's business. The Contractor shall provide a daily detailed accounting. A minimum of eight ticket sellers shall be provided during all evening hours and six at all other times. Ticket sellers are to be in place thirty minutes prior to the scheduled opening of the event. Alternative revenue collection methods in lieu of on-site ticket sales such as online sales and imbedded chip cards may be considered

- 1.1.18. All rides, games or food trailers are to be family-friendly.
- 1.1.19. Games may not include any guns (other than water guns), knives, or other types of items that may be construed as weapons. Use of live prizes (such as gold fish, etc.) or inducements, balls, or types of items that may be construed as weapons are not permitted.
- 1.1.20. All carnival ride operators and staff shall have clean appearance and maintain a positive customer interaction. Smoking by carnival staff is not permitted during event operating hours within the carnival area. Personnel are not permitted to sleep on site. Only security personnel shall be permitted on the event site after nightly closing. Space for camping vehicles or other housing is not available within the event area.

#### 1.2. Minimum Record Requirements:

- 1.2.1. A current written certificate of inspection: The certificate shall be issued by an insurer, a person with whom the insurer has contracted or an amusement ride inspector provided by a municipality or county who is experienced and educated in amusement ride inspections in compliance with the amusement rides and devices standards of the American Society of Testing and Materials.
- 1.2.2. Procure insurance for the amusement ride from an insurer authorized to do business in this state pursuant to section 20-217 or by an insurer on the list of qualified unauthorized insurers pursuant to section 20-413, insuring the owner or operator against liability for injury to persons arising from the use of the amusement ride, in an amount of not less than one million dollars for bodily injury and five hundred thousand dollars for property damage per occurrence or in an amount of two million dollars per occurrence for a combined single limit.
  - 1.2.2.1. Contractor shall include insurance coverage for carnival midway
  - 1.2.2.2. Contractor shall furnish a copy of valid insurance certificate to the City before carnival opens.
  - 1.2.2.3. Contractor shall include City of Avondale as Additional Insured upon award of contract.
- 1.2.3. Maintain at all times the applicable written permit for operation of the amusement rides.
- 1.2.4. Provide to City where the amusement ride is operated documentation of compliance with the insurance, inspection and permit requirements.
- 1.2.5. Records of serious injuries in the last two years: Serious injuries actually caused by the amusement ride that are consistent with the recording standards of the American society of testing and materials.

#### 1.3. Contractor's Responsibilities:

1.3.1. Contractor must perform in accordance with the scope of work and coordinate attendance and schedule with City of Avondale contact.

- 1.3.2. Contractor shall provide insurance coverage required in section 1.2.2 and furnish a copy to the City before carnival opens.
- 1.3.3. Contractor shall provide its own electricity.
- 1.3.4. Contractor shall be responsible for cleaning the area after the carnival is removed (i.e. picking up all trash, removing all cords and wiring, etc.).
- 1.3.5. Contractor shall be responsible for all set up, tear down, loading, and hauling of carnival items.
- 1.3.6. Contractor shall have exclusive rights to sell all rides, games, cotton candy, candy apples, and corndogs.
- 1.3.7. Contractor shall remain in place and set up for the duration of the event.
- 1.3.8. Contractor shall supply all staff needed to run rides, games, midway, and food areas.
- 1.3.9. Contractor shall pay the City at least \$10,000 or 15% of ride gross revenue, whichever higher after sales tax.
- 1.3.10. Contractor shall purchase necessary permits and undergo inspections deemed necessary by the City
- 1.3.11. Contractor shall supply the City with Arizona sales tax number and health departments permits for any food trailers.
- 1.3.12. Contractor will remove carnival immediately following the close of the event on Sunday, October 17, 2021.

#### 1.4. <u>City's Responsibilities</u>

- 1.4.1. The Recreation Department will provide a trash container for carnival use.
- 1.4.2. Provide a source of potable water for the carnival use from the time it enters the area until it leaves.
- 1.4.3. Provide a location that is agreeable for both the City and Contractor.

#### **Section II – Instructions and Conditions**

2.1. <u>Quantities</u> as described in Section I above are estimates only, based upon available information. The City reserves the right to adjust the quantities as necessary to meet its needs.

- 2.2. Submission Requirements: Respondents shall submit the complete Contractor Application and any supporting documentation(s) to Jill Lin, Senior Buyer at jlin@avondaleaz.gov.
- 2.3. Format and Content: Respondents must submit the following information:
  - 2.3.1. Exhibit A Contractor Application, completed and signed.
  - 2.3.2. Supporting documentation such as copies of resume(s), certification(s), permit(s), pictures and license(s).
  - 2.3.3. Proof of Insurance: Proof of liability insurance. Contractor shall include City of Avondale as Additional Insured upon award of contract.
- 2.4. <u>Evaluation</u>: The City will evaluate the responses in accordance with the criteria below. The evaluation of the responses shall be within the sole judgment and discretion of the Selection Committee. Contractor may be required to submit additional information to clarify their proposals at any time throughout the evaluation process.
  - 2.4.1. [25 Points] Types, variety and quality of rides proposed to include quality, condition and age of rides, ability to maintain equipment, and availability to meet the needs of the City, please attach pictures of the proposed rides.
  - 2.4.2. [5 Points] Proposed price for rides.
  - 2.4.3. [20 Points] Proposed distribution of revenues from sale of tickets for rides and games as proposed on attached form.
  - 2.4.4. [10 Points] Proposed type of skill games, pricing, and prizes.
  - 2.4.5. [10 Points] Comments and observations from references where the carnival has performed. (Past Performance and Related Experience)
  - 2.4.6. [30 Points] Safety Liability/loss records for last two years; demonstration of properly licensed and mechanically sound rides for the past two years; current safety policies and procedures.
- 2.5. Award will be made to the Contractor whose proposal is the most advantageous to the City.
- 2.6. Complete all exhibits and attachments and email your proposal packet to Jill Lin, Senior Buy at jlin@avondaleaz.gov.
- 2.7. Contractor shall provide the Services in accordance with a safety plan that is compliant with Occupational Safety and Health Administration ("OSHA"), American National Standards Institute and National Institute for Occupational Safety and Health standards. If, in the Contractor's sole determination, the Services to be provided do not require a safety plan, Contractor shall notify the City, in writing, describing the reasons a safety plan is unnecessary. The City reserves the right to request a safety plan following such notification.

#### **Section III – Ticket Price Proposal:**

- 3.1. Enter the ticket price on the Contractor Application, Exhibit A. Price shall include applicable State and local taxes.
- 3.2. The City intends to award this contract to the Contractor that it considers will provide the best overall approach to providing the service.
- 3.3. All responses shall be considered firm for a period of 90 calendar days, commencing the day following the date of the request for proposal due date. Any responses specifying any time less than 90 calendar days shall be deemed non-responsive.

#### Section IV - Execution and Submission

By executing this document and submitting a proposal to the City of Avondale, the authorized agent agrees (i) he/she has read the City's Standard Terms and Conditions, dated March 16, 2020, as set forth on the City of Avondale website (http:// https://www.avondaleaz.gov/government/departments/finance-budget/standard-terms), which are incorporated into and become a part of the company's proposal offer as if set forth fully herein and (ii) the company shall be bound by the Standard Terms and Conditions, dated March 16, 2020. By signing below the company is offering to provide the services set forth in Scope of Work, Exhibit A and B and upon written acceptance of the company's offer by the City, it will have entered into a binding agreement. The offer shall be considered held open for 90 days from the quotes due date set forth above.
