Bids will be opened, publicly acknowledged, and read aloud, at two-thirty o'clock PM (2:30 PM) on Tuesday, October 2, 2018, in the Purchasing Department, 340 St. Charles Street, Building #3 Houma, Louisiana 70360.

Bids for the property located at 222 Connely Street, Houma, LA shall be accompanied by a deposit of ten percent (10%) of the appraised value of **One Million Nine-Hundred and Thirty Thousand (\$1,930,000) dollars**, equal to **\$193,000.00** in the form of a **CERTIFIED CHECK OR MONEY ORDER** made payable to the Terrebonne Parish School Board. NOTE: The deposit of the unsuccessful bidder(s) will be refunded by the Terrebonne Parish School Board. The deposit of the successful bidder will be held and will be credited toward the sale price of the subject property. The minimum bid price must be equal to or more than eighty-five percent (85%) of the appraised value.

Notice is hereby given that the Terrebonne Parish School Board will receive bids for the following surplus property, to be sold as a whole, belonging to Terrebonne Parish School Board situated in Terrebonne Parish, Louisiana. One certain lot of ground, together with all buildings and improvements located thereon and all rights, ways, privileges and servitudes thereunto belonging or in anywise appertaining, situated in the City of Houma, State of Louisiana, more particularly described as:

A certain tract of land situated in Section 96, Township 17 S, Range 17 E, in the Parish of Terrebonne, State of Louisiana, which is more particularly described as being comprised within the following boundaries, to-wit:
