5. Add paragraph to Section V "Proposal Requirements" paragraph #7 as follows:

Documentation confirming in network status with Medicaid is required as part of the proposal. Confirmation of submission for in-network credentialing with all Medicaid MCOs will be required before the County will assign clients to an agency.
