



Request For Bids **Pre-K Rubber Mulch Installation**

The School District of the City of Saginaw is currently requesting bids for the installation of rubber mulch for the Pre-K Playgrounds at the locations listed below. Installation shall meet or exceed the specifications noted below. Typical measurements can be obtained via Google Maps or Saginaw GIS. Bidders are solely responsible for determining proper quantities needed. Bidders shall visit sights during off-school hours to get measurements if needed, after 3:30 PM M-F or on weekends. The Pre-K playgrounds are the ones that are completely enclosed by their own independent fencing system, all other playgrounds are to remain the as-is.

Installation shall include removal of existing material and legal disposal off-site, base preparation with borders, geotextile fabric supply and installation and approved rubber mulch supply and installation to a 6" compacted depth.

Geotextile fabric shall have a 30 year or higher rating.

Rubber Mulch MUST be 100% wire free. Preferred product is Jelly Bean shredded rubber playground safety surfacing. Alternates are welcome and must include certifications and meet the required safety standards.

Color selections shall be coordinated with the Owner and the awarded bidder.

Installation shall be completed by September 3rd, 2024

Chester Miller and Handley locations do not currently have PreK Playgrounds, they will be installed this summer. Awarded Bidder shall coordinate with the installer to facilitate completion. Please base your bid on 2,436 s.f. of coverage for Chester Miller and 2,541 s.f. of coverage for Handley.

Henry Doerr PreK Playground will be getting additional equipment this summer. Awarded bidder shall coordinate with the installer to facilitate completion. The new equipment will require an additional 2,604 s.f. of coverage in addition to amounts required for existing equipment.

All Bids are due by 2:00 PM on Tuesday, April 16th at which time there will be a public opening. No late bids will be accepted. The school district reserves the right to refuse any bid that does not meet the desired specifications or for any other reason. All bids MUST include signed and notarized Iran Business and Familial Disclosure Forms.

The Owner reserves the right to reject any, part of any or all bids and to waive all informalities in the bidding procedures. The Owner reserves the right to reject any bid when Bidder fails to submit data required by the Bidding Documents, or if the bid is submitted incomplete or irregular. No telephonic, telegraphic, email, fax bids or modification to a submitted bid will be received or considered by the Owner.

Each bid that exceeds Fifty Thousand Dollars (\$50,000) must be submitted with an attached certified check or bid bond from a surety company approved to do business in the State of Michigan, payable to the Owner in an amount not less than five percent (5%) of the base bid.

Bids may not be withdrawn for a period of sixty (60) days after the bid date.
