#### REQUEST FOR PROPOSALS

The City of Shelbyville is requesting proposals for Cabinets, Countertop and Sink for Recreation Center Kitchen at Shelbyville Recreation Center located at 220 Tulip Tree Road, Shelbyville, TN as specifications included in this document.

Proposals will be accepted by the City of Shelbyville Purchasing Office, 201 N. Spring St., Shelbyville, TN 37160 or may be mailed to P.O. Box 185, Shelbyville, TN 37162 until 2:00 P.M., December 20, 2018. Proposals should be submitted in sealed envelopes marked "Cabinets, Countertop and Sink for Recreation Center Kitchen at Shelbyville Recreation Center". Any proposals received after the scheduled closing time for receipt of proposals will be returned to the bidder unopened.

Proposals will be opened at public meeting of council appointed bid committee on Thursday, December 20, 2018 at 2:00 P.M. at the Shelbyville City Hall, 201 N. Spring Street. Award of the proposal will be made at the next scheduled City Council Meeting (January 10, 2018) at the Shelbyville City Hall Annex.

### MINIMUM SPECIFICATIONS:

Installation of new cabinetry, countertop and sink as diagram attached.

#### Cabinets:

- Demolition of old cabinets will be taken care of by City staff prior to installation date
- Cabinets to be made of a solid hard wood (oak, maple, hickory)

- Cabinets to be brown/dark brown in color. Specify options available.
- Cabinet doors to be standard or "half"
- NO cabinet hardware
- Color choice to be approved by Parks and Recreation Director, Mike Alsup

#### Countertop:

- Granite countertops to be installed according to diagram
- Countertops to be pre-sealed or sealed by installer
- All design options to be included in submission finish, edges, backsplash, etc.
- Color choice and design options to be approved by Parks and Recreation Director, Mike Alsup

#### Sink:

• Include new sink and installation of sink specified during countertop install. Eagle Group SR16-19-13.5-3 or equal

This installation does not involve any plumbing or electrical work, but requires installer to work with existing and future plumbing and electrical. Appliance information is provided in this document for measurement purposes only.

Any insulation work should be included as needed.

## Site survey is highly recommended.

- Complete detail of installation and any other details relevant to project
- Proposed price
- Proof of liability insurance
- Proof of Workers Compensation insurance
- Warranty
- Estimate of completion date

Interested parties may turn in more than one proposal.

Any reference to name brands in this Request for Proposal is for example only. An approved equal will be accepted.

Vendor selection will be based upon the best offer deemed acceptable by the City of Shelbyville's council appointed bid committee and City Council. Proposal to all or part of the RFP indicates a willingness to supply part or all of the proposal. The City of Shelbyville reserves the right to reject any and all proposals.

Successful bidder must carry commercial liability insurance and worker's compensation insurance. A current business license is

also required.

All bidders must comply with A.D.A. guidelines if required.


