NOTICE TO BIDDERS: We wish to notify all vendors attending the mandatory job walk on April 13, 2021 of the following changes and/or clarifications to the original Contract Documents and Site Walk Specifications. This addendum shall supersede stated specifications and shall take precedence over anything to the contrary therein. All other conditions remain unchanged. Please attach this addendum to the documents in your possession. The proposer shall acknowledge receipt of any addenda's, listing the Addenda by number(s) and date(s) in their Letter of Interest.

The clarification is as follows:

Item #1: RFQ Vs. RFP

This is a Request for Qualifications (RFQ) for Design-Build Solar and Energy Generation Services. Upon further discussion about the process there will be no Request for Proposals (RFP) to follow the RFQ.

As noted in the RFQ, OUSD expects to award a contract to the vendor that, in their sole opinion, is the most capable of providing the range of services described in the RFQ, and in the long-term best interest of the District.

Item # 2 defining the ongoing process

In order to clarify the process going forward here is what we expect to see happen:

- a. The RFQ states the qualifications will be presented by April 30, 2021.
- b. OUSD will evaluate and score the qualifications for each vendor and post to our website
- c. OUSD may decide to have interviews with the key representatives of vendors in order to gain additional information and insight on their qualifications.
- d. On or about May 21, 2021, OUSD will select one vendor to move forward with a design / build project. The specific details of the project will be determined as a function of the cooperative development of the project, with that one vendor.
