INFORMATION FOR BIDDERS

General Requirements

The District requires an Air Purification unit with technology that utilizes oxygen and water molecules to create oxidizers to seek and destroy DNA and RNA viruses including, but not limited to, SARS-CoV-2 (novel coronavirus), Swine Flu (H1N1), Avian Bird Flu (H5N8), Hepatitis A (HAV) and MS2 bacteriophage. The bidder will provide the unit's effectiveness (kill rate for SARS-CoV-2 (novel coronavirus)) and documentation to support the stated effectiveness of the unit. The unit must have a proven kill rate of at least 93% for SARS-CoV-2 (novel coronavirus) within 3 hours in a real-world environment. The unit should provide coverage for an area of at least 1,000sq.ft.
