- 1. Change to Bid Schedule:** The due date for bids for this solicitation is hereby extended to **January 6, 2023, at 2:00 PM**, at which time bids received will be publicly opened and read, in accordance with the bid instructions, specifications and/or bid conditions. Bidders who have already submitted bids may withdraw their bid and resubmit. Bids withdrawn will be returned to bidders by KCKPS unopened.

2. Response to Bidder Questions:

1	In the attachment A it states a bid bond/ performance bond is (applicable to Construction/Remodel/ Repair Projects, unless Waived by the District).
KCKPS	No Bid Bond/Performance Bond is required for this project.
2	Is there a reason why KCKPS is not using Global tops with Global bases?
KCKPS	KCKPS has chosen to use SICO tops for the purpose of cost-efficiency.
3	Does SICO tops on Global bases invalidate any warranty?
KCKPS	Warranty claims based on the specifications of the solicitation, where SICO tops are placed on Global bases, would be assumed and remedied by the successful bidder.
4	Is KCKPS wanting the "armor edge" details on these above tables?
KCKPS	Yes. The District is requiring Armor Edge or a Comparable edge that is equal to or better than Armor Edge in the judgment of the District.
5	Will KCKPS accept global tops in place of SICO tops?
KCKPS	KCKPS will accept alternative tops in place of SICO tops, if the required specifications are met with the alternative tabletops.
6	For ADA tables, will KCKPS accept tables that will lose the stool seats and in place insert openings for wheel chair accessibility?
KCKPS	Yes. The District understands that there will be loss of affixed seating due to the ADA feature of the table.
7	Will KCKPS accept National Public Seating tables, so we can upgrade to ergo Max stools?
KCKPS	Substitution of the National Public Seating Tables is acceptable.

- 3. Approved Substitutions:** KCKPS reserves the right to request to a sample be provided, or access to a sample be granted, prior to recommendation for award so that a final determination as to suitability can be determined.

4. No Other Changes: No other changes or modification are intended by this Addendum. All other terms and conditions of the solicitation remain in effect.
