I. INTRODUCTION

Spartanburg Downtown Memorial Airport (KSPA) requests proposals from established Aviation Businesses to lease Hanger B at KSPA, located in Spartanburg, South Carolina. The City of Spartanburg owns and operates the Airport, which an Airport Director manages. The City will enter into an appropriate agreement ("Hangar B Lease Agreement") with the successful proposer

Hangar B is125.5 ft by140 feet with a hangar opening door at 90 feet wide and a door height of 20 feet. It is a prefabricated steel building aircraft hangar with 17,640-unit sq. ft. with sliding hangar doors. The hangar can accommodate most modern airplanes like the PC-24, the PC-12, and the PC6, in addition to the Embracer Phantom 100 and Beechcraft King Air 350s.

Hangar B is one of the largest and most visible hangars available for rent at the Airport, and as such, the tenant of Hangar B will be a substantially physical and perceived presence at the Airport. The City is seeking a well established Aviation Business, with a solid history and reputation in the aviation community in the Upstate of South Carolina, that will complement and reflect well upon the Airport.

This RFP is for an Established Aviation Business; the awarded lease will be for 2 (10) year periods, with provisions for up to one (5) year extension for a maximum of five (25) years based on periodic performance reviews from the City.

II. PROPOSAL SUBMITTAL AND DUE DATE:

III. AVIATION BUSSINESS QUALIFICATIONS

- 1. An established Aviation Business.
- 2. Have an Equal Opportunity Employment Program Plan.
- 3. A Detailed File Report on their corporation or Limited Liability Company
- 4. Provide Corporation/LLC Search/Certificate of Good Standing
- 6. No Ongoing Litigation.

IV. CONTENT OF PROPOSALS

Proposals must address, in detail, Section III of this RFP in order to be considered. Please provide any additional information, aviation services, or products that should be considered in the evaluation of your proposal. If any proposal fails to address the specified requirements, the proposal shall be deemed non-responsive and will be disqualified.

Each proposal, in addition to the Sections cited above, shall include:

- Name, representative, address, and contact information for the proposer.
- A narrative of the Company's qualifications and performance record with existing or past clients.
- Three references with contact phone numbers.
- Details of insurance program to be provided by aviation business
- Details of aviation products offered.
- Estimated fuel purchases from the City of Spartanburg over 25 years
- A proposal on upgrading the hangar B to fit the needs of the Lessee
- Payment per sq. ft to offer as rent for the Lessee over 25 years.
- A visual representation of the proposer's brand/logo/signage.

V. REJECTION OF PROPOSALS

KSPA may reject any proposals that are not in compliance with this RFP. The City of Spartanburg reserves the right to reject all proposals if it is in the best interest of the City.

VI. PROTESTS

Any complaints of perceived inequities related to the RFP shall be submitted to Carl Wright,

Procurement & Risk Manager, at the address listed in this RFP within five (5) days after notification of the selected aviation business.

Any protests or objections of the Owner's Request for Proposal, selection of aviation business award process must be submitted in writing to Carl Wright, Procurement & Property Manager, City of Spartanburg, P.O. Drawer 1749, Spartanburg, South Carolina 29304 (certified letter) within 10 calendar days from date of awarding the contract.

VII. COSTS

The City of Spartanburg is not liable for any costs incurred by a proposer in preparing proposals.

VIII. EVALUATION AND AWARD

The evaluation shall be done using a points system. Criteria of the proposals will include: (100 points)

- 1. Proposer's overall qualifications and experience, including references' comments. (30 points)
- 2. Proposer's ability to meet/provide listed contents of the proposal. (40 points)
- 3. Proposer's payment per sq. ft as rent for the Lessee over a 25-year period and estimated fuel purchases. (30 points)
- 4. FAA violations will result in a decrease of 5 points per violation.

The Evaluation Committee will select the proposer it feels is most qualified and meets the needs to lease hangar B. Selection will not be made solely on hangar rent. The Airport Director will make a recommendation to the City of Spartanburg for the selection of the best-qualified proposer based on the Evaluations Committee's choice.

The successful proposer may begin providing services only after receiving written notice of their selection as Aviation Business for Hangar B and after the completion of a fully executed service agreement or contract.
