Legal Notice Request for Qualifications On Call Environmental Engineering Consultants

NOTICE IS HEREBY GIVEN that The City of Spartanburg seeks to qualify firms for various Environmental Engineering assignments over the next three (3) years.

The intent of the Request for Qualifications is to seek qualified consultants to form an on-call list to assist the City with environmental engineering and consultant services for various City projects.

The following is a general description of work included in this Contract:

Assistance to various City departments shall include site assessments, hazardous materials testing, reporting, abatement and remediation design, quantity determinations and cost estimates, monitoring and final reporting, indoor air-quality testing, radon testing, site-soil remediation design and the like typically performed by an environmental engineering consultant. Work may include project management and administration, inspections, testing and assessments, analytical laboratory samples analysis, report preparation, contract document preparation, consultations during construction, and monitoring of contractors, etc.

The City expects to request proposals from the consultants on the On-Call List for the work of a particular project and will select the proposal that is in the City's best interests in terms of availability, ability to mobilize, completion on schedule, price, and other relevant factors.

Provide technical advice regarding design, construction, or program modifications and for future City projects, selected firms will submit pricing proposals.

The City of Spartanburg will act affirmatively to ensure that all disadvantaged and women's business enterprises will be afforded full opportunity to participate in this request and that it will not discriminate on the basis of gender, race, color, or national origin in consideration of a contract award.

The City of Spartanburg reserves the right to reject any or all proposals and waive any informality in the qualifications process. All proposals may be held by the City of Spartanburg for a period not to exceed sixty (60) days from the date of the opening of the proposals so that the City may fully investigate the qualifications of prospective parties, prior to awarding of the Contract. The vendor that is selected will be required to obtain a City of Spartanburg Business License.

Request for Qualifications for Professional Environmental Engineering Services

The City of Spartanburg, South Carolina requests a letter of interest and qualifications from consulting engineering firms experienced in providing civil engineering, design services, hydrologic studies, services for roadway and bridge projects, site plan review services, and general civil engineering services on an as-needed basis. The period covered by this contract will not exceed three years but may be reduced depending on consultant performance. Four to six firms will be selected as "On-Call" Consultants. This process will streamline the consultant selection process for the City of Spartanburg environmental projects. Individual project assignments will be determined at the discretion of the City of Spartanburg. Contract costs will be on the basis of actual cost plus fixed fee, lump sum, or approved unit cost basis at the discretion of the City of Spartanburg.

The following information and materials are to be included in the proposal:

- 1. Contact information. Name, street and email address, and phone number of the firm.
- 2. Form of organization. Whether firm is a partnership, corporation, or sole proprietorship, where it is organized, and the names of principals, officers, and directors of the firm. Is the firm a certified MWBE or DBE enterprise or work with subcontractors that are certified MWBE or DBE enterprise?
- 3. Brief description of the firm's experience in providing environmental engineering services for public entities and/or private sector. The description of the firm's experience should include projects undertaken in the past three (3) years and name(s) and telephone number(s) of the client's project manager.
- 4. Resume(s) of primary contact professionals.
- 5. List of all lawsuits contractor has been involved in within the last 5 years related to environmental engineering services.
- 6. Availability. A brief statement of the availability of key personnel of the firm to undertake the proposed project.
- 7. Evidence that insurance policies are maintained by the firm as stated in the RFQ.
- 8. Fee structure of the consulting firm including well installation, environmental testing other fee or fees that may be charged including, but not limited to:
 - a. Vehicle Mileage and Expenses
 - b. Telephones Charges
 - c. Reproduction of Plans and Specifications
 - d. Blue Prints
 - e. Photocopies
 - f. Secretarial Services
 - g. Well installation and reporting
- 9. Please send five (5) copies of your submittal.

As part of the consultant selection process, the City of Spartanburg will consider the following: experience, qualifications and technical competence of the consultant and of the key personnel assigned to the project (25%); proposed methodology for the project development process, including any suggested innovations, past performance on similar types of projects, and quality assurance procedures (25%); ability to meet anticipated schedule and budget requirements, past performance at meeting schedules and budgets on similar projects, and availability of the key personnel assigned to the project (20%); geographic location of the key personnel assigned to the project and their familiarity with the project area (30%).

The contractor selected to perform the work described in this RFQ will be required to provide evidence of public liability and property damage insurance with limits of not less than \$1 million for injury to, or death of, one or more persons and/or property damage arising out of a single accident or occurrence insuring against all liability of the City of Spartanburg, and its authorized representatives, arising out of, or in connection with, the performance of work under the contract

with City of Spartanburg. The contractor shall also provide evidence of Worker Compensation and Automobile insurance. Said insurance shall be provided at the sole cost and expense of the firm selected, unless the requirement is modified or waived by the City of Spartanburg.

Consultants shall comply with Title VI of the Civil Rights Act of 1964. The City of Spartanburg strongly encourages the use and involvement of Disadvantaged Business Enterprises (DBE) on these projects.
