- Deadline for return.**

If you were a resident of, a property owner in, or operated a business in Franklin County Missouri as of January 1st, please fill out the assessment list and return it to the Assessor's Office **BY THE FIRST DAY OF MARCH**. Businesses should file a "Business Personal Property Assessment List. Please call us and we will send you one of these forms.

If you moved from Franklin County before January 1st you will not owe taxes in Franklin County. Please return this list stating your new address and date moved.

Failure to return your Assessment List will result in a Penalty.

Late Personal Property Lists - Sec. 137.280 of SB 62 requires the assessor to assess a penalty on any person who fails to return his personal property tax list by the first day of March.
