### PROJECT DESCRIPTION

This project involves the widening of Briskin Lane from Cainsville Road(SR-266) to Sparta Pike(SR-26). This is a State Industrial Access Project serving L & W Engineering. Briskin Lane will be widened to three lanes with a continuous left turn lane. Cainsville Road and Sparta Pike will have turn lanes added at the intersections with Briskin Lane. The project length is 0.452 mile.
