The Undersigned hereby certifies that they have carefully examined the specifications, investigated the location, character, and extent of the work to be done in connection with the transportation department fuel bid 21-22 at 2901 N Rouse, Pittsburg Kansas 66762, and that they are familiar with the type of work involved within the scope of service and supply on specifications.
- **2.** The Undersigned hereby proposes to ensure the fuel storage tanks are filled at all times to the Transportation Directors preference year round. This will require that the tanks be checked throughout the year and more frequently during the school year August to May each year.
- 3. Vendor will provide a copy of the signed supplier's invoice with the transportation director each time the tanks are filled. The district reserves the right to randomly verify that these invoices are true and accurate. Any acts of non-compliance with these specifications can result in the withdrawal of this bid for the remainder of the school year and a reduction of the last billing for excess cost of fuel purchased elsewhere.
