STATEMENT OF WORK

Pittsburg State University is accepting bids to establish a Price Agreement for Unleaded Gasoline and Diesel (Winter Mix).

Description: Off-Road Winter Mix Low Sulfur Diesel

<u>Specification:</u> B2 Bio-Diesel Blend shall be 69% Number 2 Low Sulfur Diesel, 29% Number 1 Low Sulfur Diesel, and 2% Bio-Diesel

<u>Alternate Specification:</u> Low Sulfur Diesel Blend shall be 69% Number 2 Low Sulfur Diesel and 29% Number 1 Low Sulfur Diesel . (Purchased only when B2 Low Sulfur Diesel is not available or the cost exceeds 10 Cents per gallon over the cost of the B2 Bid-Diesel).

<u>NOTE</u>: Successful bidder to provide price verification information for the fuel pulled for Pittsburg State University. The price verification shall be the 8:00am average rack price for the day fuel is pulled and will be included with the invoices for Pittsburg State University.

Terms and Conditions:

1. Vendor will be required to deliver unleaded gasoline in quantities of 2,000 gallons or less. Diesel will be delivered in quantities of 500 gallons or less. The University does strive to consolidate fuel purchases so smaller delivers are not required on a regular basis but there is no minimum order. Delivery of gasoline and diesel must be made within 48 hours of order.

2. Vendor will be required to fill generators located on campus. There are currently four that require diesel. They are located at Axe Library, the Kansas Technology Center, Kelce and Heckert Wells. Generators are generally filled once or twice per year with winter mix diesel.

3. Vendor will be required to provide a 500 gallon diesel tank to be located on campus at a place designated by the University.

4. This Price Agreement is established to cover purchases of the listed fuels and oils by Pittsburg State University during the Agreement Period of October 1, 2013 through September 30, 2014, with option to extend Price Agreement by mutual consent for four (4) additional one (1) year periods at the same terms and conditions but not beyond September 30, 2018.

5. This Price Agreement may be terminated under the following conditions:

A. By either party upon forty-five (45) days written notice prior to the expiration of the one (1) year term.

B. By the Procurement Officer at any time, upon thirty (30) days written notice.

6. Discounts shall be guaranteed for the Price Agreement Period. All Special Conditions or Exceptions must be clearly noted.

7. Purchase Orders will be issued throughout the Agreement Period for quantities and supplies as required. Payment will be made routinely upon receipt of two (2) copies of the vendors invoice to:

8. Pittsburg State University is Tax Exempt by State of Kansas Statute #K.S.A. 79-3606C, Exemption Number KS6GJNF4N6, Federal Exempt #003-9999.

9. Any Price Agreement entered into shall be of the open-end type; the Vendor will deliver only such quantities as may be order by him.

10. Deliveries shall be F.O.B. Destination (PSU), Freight Prepaid and Allowed!

11. Deliveries shall be made within the time frame of one (1) day unless notified and acceptable by using department at time of order.

EMERGENCY SPECIAL SERVICES NOTIFICATION:

During a Natural Gas curtailment or power outage the University may require emergency delivery of offroad diesel on a daily basis (maybe twice daily). The University has capacity to hold 29,500 gallons of diesel for heating purposes. Deliveries may be required on weekends and holidays as long as the natural gas curtailment or power outage continues. Delivery of emergency fuel will be a priority and must be made within 12 hours of order.

12. The Provisions found in Contractual Provisions Attachment (DA146a) which are incorporated by reference is attached and will be made a part of this contract.
