

## INVITATION TO BID (ITB) – PROJECT SPECIFIC CONSTRUCTION SERVICES

The City of Daytona Beach will receive bids for the “**CYPRESS AQUATIC CENTER POOL RESURFACING**”, Invitation to Bid No. 20053, at the City of Daytona Beach Purchasing Division, City Hall Room 146, 301 S. Ridgewood Ave., Daytona Beach, Florida 32114, until **2:00 p.m., on October 22, 2019**, at which time bids will be opened publicly and read aloud. Bids received after said time will be returned unopened.

with “Sealed Bid for CYPRESS AQUATIC CENTER POOL RESURFACING , ITB No. 20053” plainly written on the outside of the envelope.

**The work** generally consists of completely resurfacing the entire swimming pool and replacing drains and tile as needed. The project includes removing and reinstalling all accessory items such as ropes, floats and ladders per Florida Administrative Code 64E-9 thru to 64E-9.005(2)(a) through (g), FAC. and the most recent edition of the “Florida Pool Code”.

The Bid Documents and all other Contract Documents, including Drawings and Technical Specifications if applicable, are also on file at the Daytona Beach Purchasing Division, 301 S. Checks must be made payable to the City of Daytona Beach, Florida. **Each bid** must be accompanied by **Bid Security** in an amount not less than **10%** of the total bid.

**A NON-MANDATORY PRE-PROPOSAL CONFERENCE** will be held at the Daytona Beach Midtown Cultural & Educational Center, 925 George W. Engram Blvd., Daytona Beach, Florida 32114, on **October 16, 2019 at 2:30 PM**. Interested contractors are *urged* to attend.

**The successful contractor** will be required to furnish separate 100% Performance and Payment Bonds unless the Contract price is less than \$100,000.

**The City** reserves the right to reject any and all bids, or any portion of any bid, or to waive any informalities in the bidding.

**Bids may be held** by the City for a period not to exceed 60 days from the date of opening of bids for the purpose of reviewing the bid and investigating the qualifications of bidders prior to awarding the contract.
