Effective this date, this amendment forms part of the contract documents and modifies the original solicitation.

Item #1: (page 22), VII. Terms and Conditions – B. Special, shall now include, Pricing: Fixed price contract with economic adjustment. The base milk price submitted shall remain firm and continue in force during the entire contract period. Price escalation/de-escalation will be based on the March 2018 Federal Milk Order announcements for the applicable geographical zone. (include copy with the bid): a. Price Escalations: All prices shall be firm for 30 days, after which prices for milk can escalate or de-escalate according to changes in Class 1 raw milk prices based on monthly Federal Milk Order announcements for the applicable geographical zone. Prices for milk delivered can be escalated or de-escalated at the rate of \$.001 per half pint for each full \$.15 increase in raw milk per hundred weights. Any changes in price must be accompanied by a copy of the Federal Milk Order. Suppliers are also requested to submit conversion calculations showing the manner of arriving at the amount change. Whereas, the escalation formula contained herein should apply to 95% of the petitions for price escalation, allowances will be made for occasional add-on escalation of raw milk prices by local dairy farmers which are over and above the 3 price escalation permitted by Federal Milk Orders.

Item #2: (page 22), VII. Terms and Conditions – B. Special, Price Adjustment – Limited – After Initial Term Only shall now be removed.
