- On Page Adv-3, 2<sup>nd</sup> Para.: Phase II Construction Services are removed so that an "off ramp" option may be taken by the Owner if terms are not reached with the Design-Builder for Phase II Construction Services. An Amendment will be presented to the Board of Commissioners for the addition of Phase II Construction Services at the successful conclusion of Phase I Pre-Construction Services.
- On Page Adv-4, Bonds: The solicited services (Phase I Pre-Construction Services) are professional engineering and management services fees only, and not public works construction. A Bid Bond is not required.
