Bid Pricing: This bid will remain in effect for one (1) year, consisting of one initial large purchase for estimated annual usage contained in the bid documents, followed by orders for smaller quantities on an as needed basis throughout the school year, with guaranteed pricing at the winning bid amount.

Delivery: Vendors must offer centralized pricing/billing and must be able to handle delivery to the individual School locations.
