Contract Mowing for the Community Development (Codes) Department:

Bidder shall provide pricing for mowing various lots in the city. The mowing shall be done at the request of the Community Development Department within one week (7 days) from the time of notification from the Community Development Department. The lots will be in violation of the City's high grass and weed ordinance.

The ordinance requires that lots in the City not exceed one foot (12 inches) in height. The owners of lots in violations are given 10 days to mow. If the lots are not mowed within that time, the Community Development Department will contact the successful bidder to mow the property.

Bids should be submitted on a price per the first one-half (1/2) acre increment and a price per any additional one-half $\frac{1}{2}$ acre increments of the lot or property to be mowed. Some lots may have to be mowed with a Bush Hog or similar device.

The mowed lots will need to be free of all litter **before and after** mowing and the lots need to be trimmed as necessary.


