Sealed proposals will be accepted in the Public Service Department, City of Tallmadge, 46 North Avenue, Tallmadge, Ohio, 44278 until 10:00 a.m. Wednesday, April 5, 2023, with bids being opened immediately thereafter in the Council Chambers of the Municipal Building for:

**POUR IN PLACE PLAYGROUND SAFETY SURFACING** consisting of the installation of the playground surfacing system shall be poured in place, resilient, rubber surface designed for impact attenuation when installed over a specified sub surface, and all appurtenances complete and ready for operation. Manufacturer's labor and material 5-year warranty.

### SECTION I: INSTRUCTIONS TO BIDDERS

All pages of the Bid Proposal, Specifications and Contract Documents must be intact and included in the bid submittal. Bidders must use the forms provided on the City of Tallmadge website as none other will be accepted.

The City of Tallmadge does encourage bidders to submit all bid forms with their bids.

Submit all bids to the City of Tallmadge Public Service Department, 46 North Avenue, Public Service Department, Tallmadge, Ohio 44278 according to the instructions in the Invitation to Bid posted on the City of Tallmadge's website at <a href="https://www.tallmadge-ohio.org/bids">https://www.tallmadge-ohio.org/bids</a>

Bids should be in a sealed envelope marked with project title and the name and address of bidder and reach the Public Service Department, no later than 10:00 a.m. on Wednesday, April 5, 2023. The Public Service date/time stamp is the official date/time used for the deadline of the submission of bids. The City will disqualify any bid not received on or before 10:00 AM local time on Wednesday, April 5, 2023. (City Hall is open for public access Monday thru Friday from 9:00 a.m. to 3:00 p.m.)

The City reserves the right to waive any informality in any proposal, and to reject any or all bids. The City also reserves the right not to enter into any contract as a result of this invitation for bid.

All addendums will be posted on the City website through Vendor Registry. It is the bidder's responsibility to check this site on a regular basis. The City will not be responsible for any information not viewed by bidders. All bidders should register with <a href="https://www.vendorregistry.com">www.vendorregistry.com</a> so that the City has all the necessary vendor information.

In reviewing bids to determine who is the lowest and best, the City will take into consideration the extent to which the bid conforms to the bid specifications and the qualifications of the bidder to satisfactorily implement the requirements of the Contract. The City specifically reserves the right to reject any bids for which the bidder fails to demonstrate the ability to provide the service required in a responsible manner.

Any bidder may withdraw his bid, by written request, at any time prior to the deadline set for the bid opening. Please be advised, the City of Tallmadge may impose a \$500.00 penalty to any bidder that withdraws his bid after the bid opening and prior to a contract award(s).

Bid will be awarded to the lowest and best bidder. The City will be the judge of the factors and will make the award accordingly. Should the successful bidder not be able to provide the required services, the City reserves the right to request service from other sources.

Prospective bidders will take notice that the City of Tallmadge, in determining the lowest and best bidder in the award of this contract, may award a local bidder preference to any qualified bidder pursuant to Section 143.06 of the Codified Ordinances of the City of Tallmadge. The determination of whether a bidder qualifies for the local preference shall be made by Board of Control. The Board's decision shall be final.

After award of the bid, by the City of Tallmadge, the successful bidder will receive an official award notification from the City. The signed contract will represent agreement between the City and the successful bidder (all terms of the bid specifications and any applicable addenda will apply).

The Contractor shall be required to furnish to the City of Tallmadge, evidence showing insurance coverage to be in force throughout the term of the contract. The Contractor shall carry Comprehensive General Liability and Auto Liability Insurance to cover damages for which the contractor may be legally responsible due to bodily injury or property damage. The contractor shall provide to the City of Tallmadge a certificate of insurance showing \$1,000,000.00 Combined Single Limit and \$2,000,000.00 Aggregate Coverage and Workers Compensation Insurance. The City of Tallmadge must be included as an additional insured.

The Contractor covenants to save, defend, hold harmless, and indemnify the City, and all of its officers, departments, agencies, agents, and employees (collectively the "City") from and against any and all claims, losses, damages, injuries, fines, penalties, costs (including court costs and attorney's fees), charges, liability, or exposure, however caused, resulting from, arising out of, or in any way connected with the Contractor's intentional, negligent, or grossly negligent acts or omissions in performance or nonperformance of its work called for by the Contract Documents.

After satisfactory completion of services, the Contractor shall forward invoice(s) to the following address: The City of Tallmadge, Public Service Department, 46 North Ave., Tallmadge, Ohio 44278. **This is a prevailing wage contract.**

## SECTION III: BID SPECIFICATIONS

#### A. SCOPE OF WORK

- 1. The following work shall consist of furnishing all materials, equipment and labor necessary to complete the playground surfacing system which shall be poured in place, resilient, rubber surface designed for impact attenuation when installed over a specified sub surface. Materials and depth of surfacing shall be provided that meets or exceeds safety surfacing criteria for play structure heights shown on the drawings. Material shall be mixed on site in rotating tumbler.
- 2. The rubber surface must meet ASTM F1292 fall height protection with GMAZ of less than 200 and HIC of less than 1000.
- 3. All work performed by the contractor will be subject to inspection by the City of Tallmadge Street and or Service Department and payment will be withheld for any work not complying with the above referenced specs until the deficiencies are corrected.

  Deficiencies shall be corrected at the sole expense of the contractor.
- Contractor shall be responsible for clean-up, all parts of the work area and the removal of all material, packing, waste, debris and surplus material, to leave the area in as good a condition as when the work commenced.

#### B. EQUIPMENT AND PERSONNEL SPECIFICATION

  - 6. The Contractor and all subcontractors shall make all of its payroll records available for inspection, copying or transcription by any authorized representative of the contracting agency. Additionally, the Contractor and all subcontractors shall permit such representatives to interview any employees during working hours while the employee is on the job. Department, and payment will be withheld for any work not complying with the above referenced specs until the deficiencies are corrected. Deficiencies shall be corrected at the sole expense of the contractor.

### H. Time of Completion and Liquidated Damages

1. The bidder shall commence work on the project and various elements thereof on or before <u>June 18, 2023</u> or as modified in a written "Notice to Proceed" from the owner and to fully complete the surface wearing course, including joint sealing and pavement marking portions of the project within <u>45</u> consecutive calendar days thereafter. Refer to **SPECIAL NOTES** portion of the bid documents for all items that have specific contract time constraints. The bidder shall also pay as liquidated damages the sum of \$500 for each consecutive calendar day thereafter as hereinafter provided. The contractor shall continue to pay liquidated damages in the amount indicated until such time that all work is substantially complete.

#### I. POUR IN PLACE PLAYGROUND SURFACE

#### 1. DESCRIPTION:

Pour in Place Playground Surface shall cover an area = 6,800 sq. ft (entire playground is 8,770 sq. ft). The remainder of the play area (1,970 sq. ft) will be concrete surface poured at the same elevation (this work is not part of this bid and will be completed by others: see drawing).

**Site Preparation** - Existing pea gravel to be removed by Tallmadge City personnel and excavated to a depth of +/-7" when measured from the concrete curb surrounding the play area.

**Weather Conditions** - Installation may not proceed if there is a precipitation forecasted during the following 24 hours. The air temperature must be a minimum of 40 degrees or higher.

**Subbase Preparation** - Subbase is to be 4" of #57 and #8 crushed limestone. The crushed stone base must be dry at installation. Compact with either a power tamper or power roller to less than 3/8" difference over a 10'-0" length in any direction. Compaction is to be at 90% - 95%.

**Pour in Place Rubber Base** - Poured in place rubber base layer is to be recycled styrene butadiene rubber (SBR) and polyurethane binder. Mix proportions shall be 14% binder and 86% SBR. Screed and hand trowel a consistent density to the required thickness. Thickness will vary from 2" for a 4'-0" fall height to 3" for a 6'-0" fall height to 4" for an 8'-0" fall height. This measure includes the top layer thickness. Independent laboratory testing results for compliance with ASTM- F1292 for equipment fall heights. Change in base layer thickness to meet differing fall height protection shall be a gradual as possible, with a slope of 2% or less.

**Pour in Place Top Layer** – Poured in place top layer is a to be ethylene propylene diene monomer (EPDM) pigmented rubber granules and polyurethane or aliphatic urethane binder. Mix proportions shall be 18% binder and 82% EPDM. Minimum thickness to be ½". Edges of the rubber are to be flush with the surfaces of the adjacent concrete curbing and ramps. Color mix to be 50% black and 50% of a tan brown color. Contractor to supply a 9"X9" or larger rubber sample and color.

The playground must remain closed during installation and 48 hours after installation. Security to be supplied by owner to prevent use

**Pour in Place Playground Surface Warranty** - Manufacturer's labor and material 5-year warranty.

#### 2. PAYMENT:

Basis of payment shall include all materials and labor necessary to complete the work described in this contract including any incidental items such as maintenance of traffic and mobilization.

#### J. TWO BAY SWING SET

#### DESCRIPTION:

This item consists of providing all materials, labor and equipment to install a two bay PrimeTime Swing Model #12583 or comparable. This is to include two Belt Swing Seat Model # 1481 or comparable, one Zero-G Swing Chair Model #8560 (for ages 2-5) or comparable and one Expression Swing Model # 5128 or comparable.

#### PAYMENT:

Basis of payment shall include all materials and labor necessary to complete the work described in this contract including any incidental items such as maintenance of traffic and mobilization.



AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ADVERTISE FOR BIDS AND THE MAYOR TO ENTER INTO A CONTRACT FOR PLAYGROUND SAFETY SURFACING AND A NEW SWING SET AT THE MEMORIAL PARK PLAYGROUND AND PROVIDING FOR IMMEDIATE ENACTMENT

WHEREAS, it is necessary to provide safe playground surfacing and a new swing set in the City of Tallmadge; and

WHEREAS, the 2023 annual appropriation provides funds to be expended for the playground safety surfacing and a new swing set at the Memorial Park Playground.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TALLMADGE, COUNTIES OF SUMMIT AND PORTAGE, STATE OF OHIO:

SECTION 1. That the Mayor, acting through the Director of Public Service, is hereby authorized and directed to advertise according to law for bids and to contract with the lowest and best bidder upon proper approval by the Board of Control for playground safety surfacing and a new swing set at the Memorial Park Playground in the City in accordance with specifications now on file in the office of the Director of Public Service, which specifications are hereby specifically approved.

SECTION 2. That such written contract shall be awarded under the provisions of Tallmadge Codified Ordinance Chapter 143, and shall be approved as to form and correctness by the Director of Law and proper certification of funds by the Director of Finance.

SECTION 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after November 28, 1975 that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is necessary to provide for and to accomplish the purposes herein set forth, which are conducive to the health, safety, and welfare of the citizens of Tallmadge. For that reason, provided this ordinance shall receive the affirmative vote of three-fourths of the members of Council and approval by the Mayor, it shall be enacted immediately and shall be of immediate effect.
