Bids must be submitted in accordance with the attached specifications. Bids must include an itemized schedule (including quantity, unit price and total) for each work element. Bids can be submitted by mail, email, fax or hand delivered. Cover sheets, envelopes, etc. should be clearly marked with the words:

Bids will be accepted until **3:00 p.m. (EST) on Friday, August 18, 2017** at which time they will be reviewed in the office of the City Finance Director. Quotes are not subject to public inspection until the contract is awarded. The bids are good for 75 days after opening.

**Bidders are cautioned not to submit bids until the proposed requirements and specifications have been carefully examined. It will be considered that bidders will have satisfied themselves as to the accuracy of the specifications. No proposal will be considered unless prices are submitted for all items requested in any section. The City reserves the right to change the amount of quantities.**

The names of certain brands or makes denote quality standard in the article desired, but do not restrict bidders to the specific brand, make or manufacturer named. They are meant to convey to prospective bidders the general style, type, character and quality of the article desired.

The successful bidder on all construction contracts will be required to conduct the operation in accordance with all Federal, State, and Municipal health and safety rules, regulations and laws applicable to the operation. The successful bidder may be asked to provide the City with a copy of the company's safety plan prior to commencing work. For all projects over \$30,000, a general contractor's license must be furnished to the City if applicable.

**N.C.G.S. (North Carolina General Statutes), specifically §160A-20.1(b), prohibit the City from entering into contracts with contractors and subcontractors who have not complied with the requirement of Article 2 of Chapter 64. The Contractor shall submit the E-Verify Affidavit, located in the Bid Proposal section, with their bid. Bids that do not include this Affidavit will be considered non-responsive.**

N.C.G.S 147-86.55-69 requires certification for bids with a North Carolina Local Government. The certification is required at the time when a bid is submitted. N.C.G.S 147-86.55-69 requires that contractors with a North Carolina Local Government must not utilize any subcontractor found on the State Treasurer's Final Divestment List. The State Treasurer's Final Divestment List can be found on the State Treasurer's website at the address [www.nctreasurers.com/Iran](http://www.nctreasurers.com/Iran) and will be updated every 180 days.

The City of Havelock reserves the right to reject any or all proposals and to purchase items from the state contract in the efforts to award the contract to the bidder it deems to be for the best interest of the City.

**Project Scope:**

Project scope involves concrete repairs including roll curb gutter, driveway repair, and sidewalks as outlined below.

Remove and replace approximately 297 linear feet of concrete roll curb gutter at five (5) locations on three (3) different streets as outlined below, replace approximately 5 linear feet of 10-foot wide driveway at Forest View Drive, and replace approximately 102 linear feet of approximately 5-foot wide sidewalk.

**General Provisions:**

1. Contractor shall comply with all requirements of OSHA 1926.
2. Period of Performance is sixty days (60) days from date of award. **NOTE:** Gutter repairs are in support of a separate paving maintenance contract and need to be placed and completed by Monday, September 4, 2017. Remaining concrete repairs can be completed by the end of the 60-day contract period.
3. Contractor will obtain all necessary permits. Permits required by City of Havelock are provided free of charge.
4. All necessary efforts shall be made to control erosion and sediment release while this project is under construction.
5. Any excavations will be backfilled with select fill and seeded.

## **Project Specifications:**

### **Concrete Roll Curb Gutter**

1. Remove existing concrete roll curb gutter at identified locations.
2. Install new concrete roll curb gutter as shown in the attached detail. (*Roll Curb detail, COH – Replace Various Concrete Roll Curb Gutter, Std No 3.15*)
3. Place 6-inches of ABC stone under new gutter compacted to NCDOT Standards.
4. Contraction joints shall be spaced at intervals of no less than 10-feet in length.
5. New curb shall match existing curb that joins existing drop inlets at a minimum of 10-inches on back side and 6-inches on the front.

### **Driveway**


6. All new concrete driveway portions shall be a minimum of 4-inches thick, reinforced with welded wire fabric.

### **Sidewalk**

7. All commercial sidewalks at driveways will be 6-inches thick, reinforced with welded wire fabric, and widths will match existing sidewalk widths, approximately 5-feet wide.
8. All residential sidewalks will be 4-inches thick, reinforced with welded wire fabric, and widths will match existing sidewalk widths, approximately 5-feet wide.

### **Concrete**

9. Concrete for gutters, driveway, and sidewalks shall match concrete specification in Roll Curb Detail, 3,000 psi compressive strength.



NOTES:

CONTRACTION JOINTS SHALL BE SPACED AT 10' INTERVALS, EXCEPT THAT A 15' SPACING MAY BE USED WHEN A MACHINE IS USED OR WHEN SATISFACTORY SUPPORT FOR THE FACE FORM CAN BE OBTAINED WITHOUT THE USE OF TEMPLATES AT 10' INTERVALS. JOINT SPACING MAY BE ALTERED BY THE TOWN ENGINEER TO PREVENT UNCONTROLLED CRACKING.

CONTRACTION JOINTS MAY BE INSTALLED BY THE USE OF TEMPLATES OR FORMED BY OTHER APPROVED METHODS. WHERE SUCH JOINTS ARE NOT FORMED BY TEMPLATES, A MINIMUM DEPTH OF 1.5" SHALL BE OBTAINED.

ALL CONTRACTION JOINTS SHALL BE FILLED WITH JOINT SEALER. EXPANSION JOINTS SHALL BE SPACED AT 90' INTERVALS AND ADJACENT TO ALL RIGID OBJECTS.

TRANSITION FROM 24" WIDTH ROLL CURB TO 30" STANDARD CURB AT CATCH BASINS A MINIMUM OF 5' EITHER SIDE OF CATCH BASIN. PROVIDE EXPANSION JOINT AT TRANSITION POINT. THE TRANSITION SHALL MAINTAIN THE EDGE OF THE ASPHALT WITH THE CURB AND GUTTER, WITH THE 6" SHIFT MOVING AWAY FROM THE PAVEMENT TOWARDS THE BACK OF CURB.

MINIMUM CONCRETE STRENGTH SHALL BE 3000 PSI.
