Response to Question No. 17: We have 6-digit barcodes on our existing items and we have asset tags for new equipment.

Question No. 18: Are items currently barcoded or will they need to be barcoded post implementation?

Response to Question No. 18: We have 6-digit barcodes on our existing items and we have asset tags for new equipment.

Question No. 19: Could RRPS describe current Educational Technology Inventory operations process flow?

Response to Question No. 19: It depends on what was ordered. All of our new equipment is shipped to the district warehouse. Our facilities department typically distributes from there. Our technicians at the site, image or enroll the equipment by adding the licenses, etc., and adding an RRPS asset tag. Our Ed Techs at each site add the product to the inventory system. If it is a "bulk" order like 8000 Chromebooks, our Ed Tech support specialists import all Chromebooks with purchase price, PO#, Warranties, expiration date, cost of replacement, and site assignment. Our Ed Techs and front office staff check in/check out Chromebooks to students using the 6-digit barcode. We add fines and fees for students for intentional damage.
