

The Beaufort County School District (BCSD) is in need of life cycle replacement of its two **Kemp Load Balancers and Services** which have been in service for approximately seven years. The load balancers must support the entire enterprise and be setup in an HA configuration.

The BCSD intends to enter into a one-year contract with awarded vendor (or vendors) for the specified devices, implementation, and support services in the pricing grid below. Support services include three year Premium Plus with device purchase and one year Premium for years four and five. BCSD intends to negotiate with vendor for support cost for these devices on a year to year basis for period after fifth year support has ended.
