Asphalt Spray Patcher

1. Invitation to Service Providers:

The City of Brunswick, Georgia (the City) will receive proposals for an Asphalt Spray Patcher until Tuesday, March 5, 2019 at 10:00 a.m. EST for the above referenced equipment which is described in the attached specifications. The City invites vendors to submit proposals responsive to the specific requirements set forth in this request for proposals (RFP). The envelopes containing the proposal **must be sealed**, and addressed to:

All proposals must be marked **“Asphalt Spray Patcher” RFP**. The envelope must bear on the outside the name and address of the vendor. No proposal may be withdrawn or modified in any way after the deadline for proposal openings, and no faxed proposals will be accepted.

Questions regarding this request for proposals should be submitted in writing to Rick Charnock, Assistant Director of Public Works, at rcharnock@cityofbrunswick-ga.gov prior to 12:00 noon on Friday, February 22, 2019. Responses to any questions will be posted to the City of Brunswick’s website by Tuesday, February 26, 2019.

Proposals may also be submitted electronically through the online vendor service “Vendor Registry” where they will remain sealed until the deadline has passed. Service providers can sign up with Vendor Registry by visiting the City of Brunswick’s website at www.brunswickga.org and click the provided link found under the “News and Announcements” section and follow the instructions provided.

Proposals will be reviewed and evaluated by an evaluation committee from the City of Brunswick. The committee will select a preferred vendor from the proposals submitted within 14 days of the proposal due date. Proposals must be valid for ninety (90) days following the opening date.

2. Background:

The City of Brunswick, Georgia is located in the southeastern portion of Georgia in Glynn County, nestled along the Georgia coast. The city’s roadway system is old and in need of repair. City crews spend significant time repairing potholes, utility patches, and other roadway defects. The City has need of asphalt patching equipment which is reliable, cost effective, and easy to operate.

3. Project Description:

The City is interested in purchasing an asphalt spray patching system. This system will consist of trailer-mounted equipment to be towed behind an existing dump bed truck. The equipment shall be capable of cleaning the repair area with compressed air, application of emulsion tack coat, application of coated aggregate, and application of dry aggregate. The project will include

a new tailgate box for the dump bed truck sized appropriately for transfer of aggregate to the spray patcher.

4. Minimum Specifications:

The following, at a minimum, will be included in the bid price:

- Production Rate - 135 lbs./minute, 1/4-1/2-inch wet or dry aggregate
- Tandem Axle Trailer – 10,400 GVWR
- Blower-450 cfm with 7 psi @ 1500 rpm, Direct driven from engine flywheel, 10 psi relief valve
- Engine-74 HP Interim Tier 4 John Deere or Equivalent
- Compressor-15 cfm direct driven, Governed 70-95 psi
- Emulsion Tank-250 gallons, 200 psi working pressure R-15 insulation, Two 1500 watt heat blankets with thermostats
- Clean-Out - 15 gallon, 200 psi working pressure
- Engine Fuel - 18 gallons
- Swing Hose Carrier-Tri-Fold No Fatigue Design
- Operator Controls-Emulsion and rock flow, engine rpm, horn
- Crack seal attachment
- L.E.D. Light Bar
- Tailgate Box for Truck
- Water Flush System
- Factory Warranty – One Year
- On-Site Training
- Shipping

Alternate Items

Vendor may also choose to bid and price separately any add-ons for maintenance agreements or maintenance equipment that will be beneficial.

5. Addenda:

If the City determines that an amendment is required to this RFP, the City Representative will post a written addendum on the City Website at <http://www.brunswickga.org> (the “City Website”) and upon posting will be deemed to form part of this RFP. No amendment of any kind to the RFP is effective unless it is posted in a formal written addendum on the City Website. Upon submitting a Proposal, Proponents will be deemed to have received notice of all addenda that are posted on the City Website.

6. Proposal Requirements

All proposals shall include vendor’s full specifications and total costs including shipping and any applicable fees.

All proposals shall include at least three (3) references where the vendor's asphalt spray patching equipment has been in use.

Proposals shall include the cost of the proposed equipment and any accessories or add-ons deemed important by the vendor. These shall all be itemized and listed separately. Proposals shall also include a tentative date of product delivery for the proposed equipment if selected.

Proposals will be evaluated on:

- Conformance to minimum requirements listed in this RFP;
- References from previous customers;
- Cost of the equipment;
- Value added accessories, warranties, or other items in addition to the base equipment;
- Date of delivery.

7. Conflict of Interest:

Vendors shall disclose any potential conflicts of interest and existing business relationships they may have with the City. If requested by the City, vendors should provide all pertinent information regarding ownership of their company at the City's request.

8. Negotiations and Contract award:

The City is under no obligation to accept any Proposal submitted. The City reserves the right in its sole discretion to waive informalities in, or reject any or all Proposals, or to accept any Proposal deemed most favorable in the interest of the City, or cancel the competition at any time without award. Thereafter, the City may issue a new Invitation / Request, sole source or do nothing.
