## **License and Permits**

The vendor shall obtain all applicable licenses, and promptly pay all taxes required by the State of South Carolina, and/or Darlington County.

## **Local Preferences**

A vendor shall be a resident of this county. If the vendor is an individual, partnership, or corporation that is authorized to do business within the state, an office must be maintained in Darlington County and all taxes assessed must be paid. During the bid evaluation process, any vendor who meets the criteria for local preference and the evaluation team feels that the county will gain value; will have their bid price reduced by 5 percent. *The local vendor will be required to match the lowest bid submitted by the non-local responsive bid.* If all bids received are local vendors; then the 5 percent preferences will not be calculated.
