The following are amendments to the IFB #325-18 VETERANS MEMORIAL PARK GYMNASIUM EXTERIOR RENOVATION:

1. Dawson County is adding an alternate bid to the scope of work and Vendor's Price Proposal Form for the aforementioned bid. The scope of work is being amended to add alternate cost for the installing of new metal panels on the front side of the building. It cannot be determined, at this time, if the metal panels beneath the current awning have been cut to allow for a flush installation. The alternate scope, if necessary, is to replace all metal panels on the front side of the structure to match as close as possible, regarding panel profile, thickness and painted finish, to the panels on the remaining three sides of the building. The need for the alternate work will be decided by the Dawson County project manager. The contract will be awarded as a not to exceed amount. If this alternate work is not needed, the contract payment amount will be that of the lump sum not to include the alternate bid price.

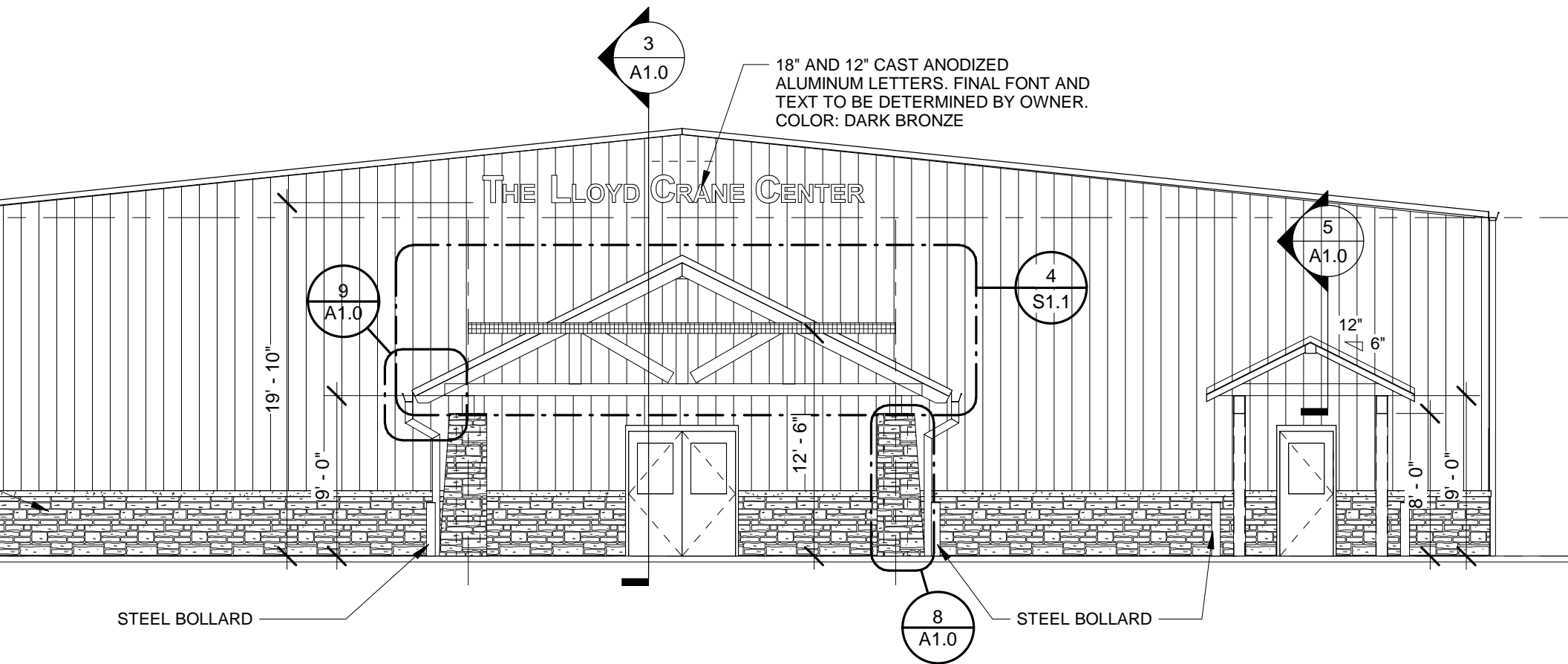
