If the Bidder discovers a conflict between any of the above, the problem shall be referred to the Owner as soon as possible for resolution by the Owner. Should a conflict occur which is not resolved before bid time, it shall be the Bidder’s responsibility to price and bid the more expensive method to comply with mandatory requirements (i.e., codes, ordinances, etc.).
