Fireworks Show for the July 4th Red, White, and Boom Celebration

The City of Spartanburg is seeking proposals for a fireworks show for the Red, White and Boom event on July 4th.

Requirements: This bid should be for a three year contract with Red, White and Boom.

Proposal should include:

General Bid Information

- 1. Vendor shall include the applicable information in their bid submittal as outlined below.
- 2. Vendor shall provide at least three reference (name, phone, address, email if available) from previous outdoor public fireworks displays from the last three years.
- 3. Bid response shall provide a total cost for the event.

General Show Parameters

- 1. The show will not be set to music.
- 2. The display will consist of an opening barrage, the main body of the show, and a grand finale, or similar.
- 3. Vendor shall prepare a show that is not less than 15 minutes in duration and shall not exceed 25 minutes. The anticipated duration of the proposed show must be clearly specified in the bid response.
- 4. Fireworks may be hand-fired or electronically fired.
- 5. Vendor shall be prepared to honor a mutually agreed upon rain date.
- 6. Vendor shall meet all South Carolina licensing requirements for the fireworks show.
- 7. Vendors shall be responsible for completing the needed documentation and submitting for a Fireworks Display Permit not less than 30 days prior to the event. The permit package shall include the Permit Application, shot list, certificate of insurance, site diagram, copy of the permit card for the lead shooter and experience level/certificates of assistants, and any other information required for permit submittal. The application will be forward to the City of Spartanburg Fire Marshal for review and approval before submitting to the State Fire Marshal.
- 8. Vendor shall be responsible for site cleanup on the night of the event.

Shells and Shell Size

- 1. The maximum permissible shell size for this event, per the City of Spartanburg Fire Marshal, shall be 5" in diameter.
- 2. No overnight storage of materials will be allowed. Materials must be brought to the site, no sooner than 2 PM, on the day of the event.
- 3. The show shall include not less than: 3" shells 500, 4" shells 150, 5" shells 100. Vendors may include more of any size as needed, but these are considered the minimum. Vendor shall include a specific list of the shells proposed in the bid and must explain any variations from the minimum.
- 4. Due to the elevation difference on the site, most shell cakes are not permissible. Should the vendor choose to include shell cakes, they shall be 2.5" diameter or larger and shall be clearly called out in the bid specification.
- 5. Pre-loaded displays only no reloading of mortar will be allowed.

Certificate of Liability Insurance
