As a result of questions during the mandatory pre-bid meeting on Monday, November 27, 2023, the following clarifications/changes are provided for your information. Please make all appropriate changes to your quote documents.

What type of material (Corian, Stone, etc.) will be used for the new solid surface 9' by 2' 01: countertops?

A1: Corian will be used for both of the new countertops.

O2: Will the new tile need to be the same size as the existing tile?

Yes, the new tile to be installed shall be the same size as the existing tile.

Q3: At the point where the tile transitions into the restrooms from the lobby entrance, is it acceptable to install a threshold/transition strip at the doors?

Yes, the contractor shall supply a flooring transition strip between the bathroom doors A3: and the lobby.

Will there be an attic stock of tile? O4:

Yes, there will be 10% of each style of tile for attic stock.

What are the work hours, and will there be 24/7 access to the building? Q5:

> A5: The District Project Manager is available Monday through Friday, 7:00 am to 5:00 pm.

Yes, the contractor will be granted 24/7 access to the building.
