City of Decatur Grave Opening and Closing Specifications and Conditions

Contractor shall own excavation equipment (backhoe and dump truck) capable of opening graves and small enough to maneuver around markers, trees, and shrubs. Bid shall include description of excavation equipment owned, including make and model.

Bids received without an equipment list shall be rejected as non-responsive.

Contractor shall be experienced in grave digging, averaging 100 graves per year for the past three years. A minimum of 3 work references are required. References may be confidentially verified.

Bids received without 3 references shall be rejected as non-responsive.

Submitted bids shall include evidence of general liability insurance currently in force with a limit of \$1,000,000.00 and any other insurance normally required for the type of service to be provided. Upon award, the bidder shall name the city of Decatur as additional insured and shall agree to keep said insurance in force during the contract period. Such certificates shall provide the City be given at least 30 days prior written notice of any cancellation of, intent to not renew, or material change in such coverage. The providing of any insurance required herein does not relieve the bidder of any of the responsibilities or obligations assumed by the bidder in the contract awarded or for which the bidder may be liable by law or otherwise. Failure to provide and continue in force such insurance as required above shall be deemed a material breach of the contract and shall operate as an immediate termination thereof.

Bids received without evidence of insurance in force shall be rejected as non-responsive.

If awarded a contract, bidder shall obtain a Decatur Business License prior to starting work. Failure to do so shall be deemed a material breach and cause for immediate termination. **A Decatur Business License is not required to submit a bid**.

- Contractor shall be responsible for any damage done to grounds, markers, shrubs, or trees. If contractor does not have damages repaired after one notice, the City will do repairs and deduct the cost from the contractor's fees.
- If conditions are wet, contractor shall furnish runners, boards, plywood, etc. necessary to protect grounds when leaving the road with equipment and shall repair any damages to the grounds in a timely fashion.
- Contractor shall put all leftover dirt in a City designated location after closing grave.
- Contractor shall position equipment away from funeral site during funeral service.
- Graves must be dug within two hours of notification.
- The contractor must be at the gravesite to close the grave no later than 15 minutes after the time of the funeral for graveside funerals and no later than 45 minutes after the time of the funeral for a chapel or church funeral.
- Contract will be awarded for a one-year period, renewable for two consecutive years.
- Contract is subject to a 30-day notice of cancellation for unsatisfactory performance.
