## **QUESTIONS AND CLARIFICATIONS:**

**Question**: We are interested in the RFP: Chromebook Purchase, and we will be able to provide the following items specified in the bid invitation. Our products are refurbished, they have been cleaned, and tested to be fully functional and ready for resale. Will refurbished products work for this bid? We also offer warranties on these products as well.

**Clarification:** The District is only interested in new Chromebooks. We will not consider refurbished Chromebooks.

**Question**: I just wanted to clarify that there has only been one addendum so far. Addendum 1 and Addendum 2 are both referenced in this email.

**Clarification:** This is the third Addendum. There has been a total of three Addenda for this RFP.

**Question**: Will the District accept a digital signature on all documents, due to social distancing recommendations?

Clarification: No.

**Question**: Can the District accept delivery of the 3,000 devices prior to June 30, 2021? Particularly in regard to Option 1 Dual-Core Processor 11 inch model.?

**Clarification:** The District would like to receive the Chromebooks as quickly as possible, but no later than June 30, 2021.

**Question**: What are the current Chromebook vendors/manufactures that the District is currently using?

Clarification: Lenovo.

Question: How long does the pricing for the items need to be guaranteed for?

Clarification: Sixty (60) Days

Question: Given the severe supply chain constraints of Chromebook devices, does the

District have a project timeline of when devices should arrive?

Clarification: Per the RFP, the District requires delivery by June 30, 2021.

Question: We understand the 3,000 units is an estimated amount. Does the District have

a tentative amount and timeline of purchase?

**Clarification:** Up to 3,000 units, delivered by June 30, 2021.

Question: Will the District consider including a Cyber Liability to their insurance

requirements? Many CA entities have made this a requirement.

Clarification: No.

**Question**: I have a request, we are participating in the Chromebook bid process and HP the manufacture has responded to my associate stating we need an email approval from the end user (district) stating we can be added to HP's "Big Deal" pricing. Can you help

me with that?

Clarification: No.

Question: Would the district accept a partial bid? Meaning that you have 4 device

configurations listed. If we bid on 1 of 4 or 2 of 4 would that be accepted?

Clarification: Yes.

**Question**: Would the district accept multiple manufacturers per device? For example Option 1-Samsung, Option 2-Acer, etc. or would you only like 1 manufacturer for the entire bid?

**Clarification:** The District will accept only one manufacturer per Option, but all four Options are not required to be the same manufacturer.
